1. You recently left a note here saying that the Spuration Commission had not been getting any statistical material from the Ministry of Foreign Affairs, and asked us whether any reports were coming out.

2. I had a word with Del Balzo of the Ministry of Foreign Affairs about this, and he tells me that they hope to be able to produce complete data within two or three weeks. The reason for the delay is that, owing to the absence of many members of the Italian Diplomatic Service abroad, it has not been possible to deal with them in exactly the same way as the Government Departments at home. As you know, they were the first department to set up a commission of their own for investigating the collaboration of their members with the Republican Fascists and Germans. This has been proceeding, and the following action has been taken.

a. Under Article 2 of Decree No. 257 of October 11, 1944, fifteen Ministers and Consuls General have been placed on the retired list.

b. Under the present Spuration Decrees, persons in the junior grades who are liable to be placed upon the retired list, have the right to be heard in their own defence. This is not possible in the case of those serving abroad, and the Ministry of Foreign Affairs have, therefore, adopted the procedure of applying a law of the 11 April 1926. As a result of which, 55 persons from the 5th to the 11th grades have been put on the retired list.

c. The High Commissioner of Spuration has denounced 24 persons of whom 23 are Ministers or Consuls General. Sixteen of these are under judgement and the case will be settled in November, or at the latest, December. The other 7 are still abroad or in Northern Italy.

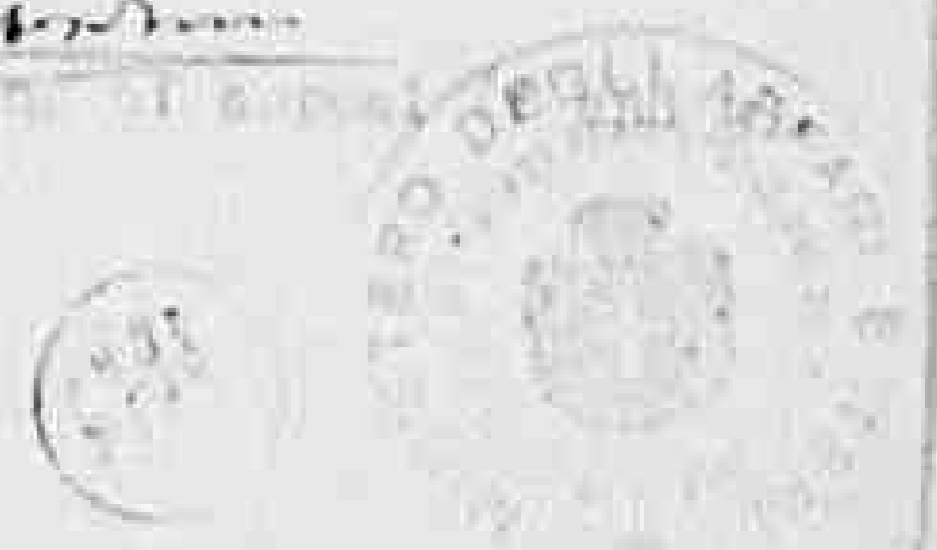
