2. Casual attendance by Allied Forces personnel at political meetings, and even private conversations with Italians on political subjects, may lead to misunderstandings and will be avoided on all occasions.
3. All commanders will issue orders to all concerned to refrain at all times from any form of participation in Italian political affairs."

Arrangement: Is made of the establishment of the Supply and Resources Division within the Economic Section.
