Test of Sequence

Abstract: The purpose of this study was to determine the effect of a 12-week training program on the heart rate (HR) and heart rate reserve (HRR) of middle-aged men. The study was conducted in a laboratory setting. The subjects were 15 middle-aged men (mean age 45.5 ± 5.2 years, range 35-55 years) who were sedentary and had no cardiovascular disease. They were divided into two groups: a control group (n = 7) and a training group (n = 8). The control group remained sedentary throughout the study. The training group followed a 12-week training program consisting of three sessions per week, each lasting 30 minutes. The training program was designed to increase the HR and HRR of the subjects. The HR and HRR were measured at rest and during maximal exercise at the beginning and at the end of the 12-week training program. The results showed that the training group had a significant increase in both HR and HRR compared to the control group. The HR at rest increased from 68 ± 5 to 72 ± 5 beats per minute (p < 0.05). The HRR at rest increased from 12 ± 2 to 15 ± 2 beats per minute (p < 0.05). The HR during maximal exercise increased from 175 ± 10 to 185 ± 10 beats per minute (p < 0.05). The HRR during maximal exercise increased from 105 ± 10 to 115 ± 10 beats per minute (p < 0.05). The results of this study suggest that a 12-week training program can effectively increase the HR and HRR of middle-aged men.

1. Ref. your 214.32/003 dtd 18 November 1944.
2. To date there have arrived 19 FIA stenographers from the United States. Prior to the arrival of these civilians, there had been an acute shortage of office equipment in the Economic Section. This can be substantiated by the numerous requests directed by this Section to the HQ Commandant for office equipment, particularly typewriters.
3. The arrival of FIA stenographers did not lessen, but on the contrary, greatly augmented the need for typewriters and other office equipment. In the beginning, the new civilian stenographers as well as the military in the section had to work under a most unsatisfactory arrangement of alternately using the few available typewriters. Let us point out that although there were 26 typewriters received from the United States, two of these were damaged beyond repair in transit, are utterly useless and must be discounted. Three are now in the typewriter repair shop awaiting complete overhaul which will entail a long delay. This leaves a working total of 17 machines distributed throughout the section and in use by FIA stenographers (14), for whom there would otherwise be no machines available.
4. For the most part, the other FIA supplies received are of an expendable nature such as paper, envelopes, ink, pads, notebooks, etc., with the exception of some desk pen sets, dictionaries, index finders and other small office-desk items of like nature which have been distributed to FIA personnel throughout the section.
5. We have been receiving urgent and persistent requests for typewriters from the Food, Public Works, Labor, Transportation and Industry Sub-commissions. In view of the above stated conditions, we cannot possibly comply with these requisitions. It is impossible, therefore, for this Section to contemplate the release of typewriters or any other office equipment at this time.

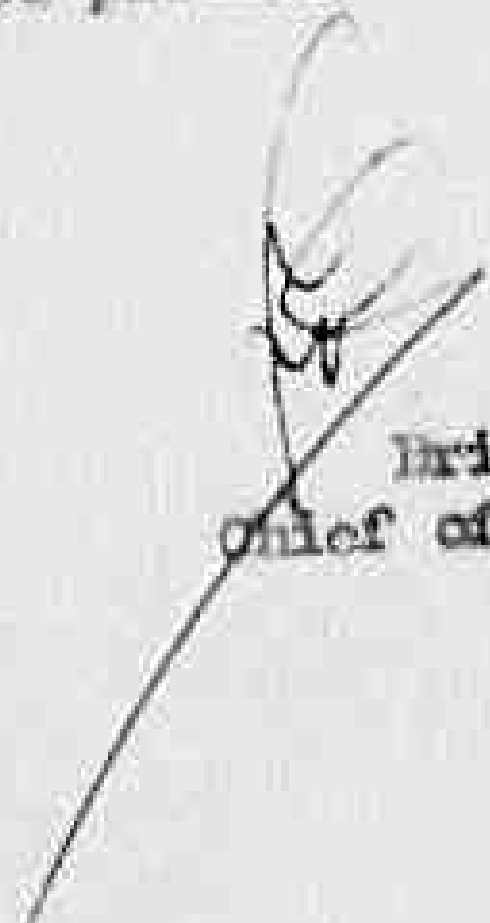

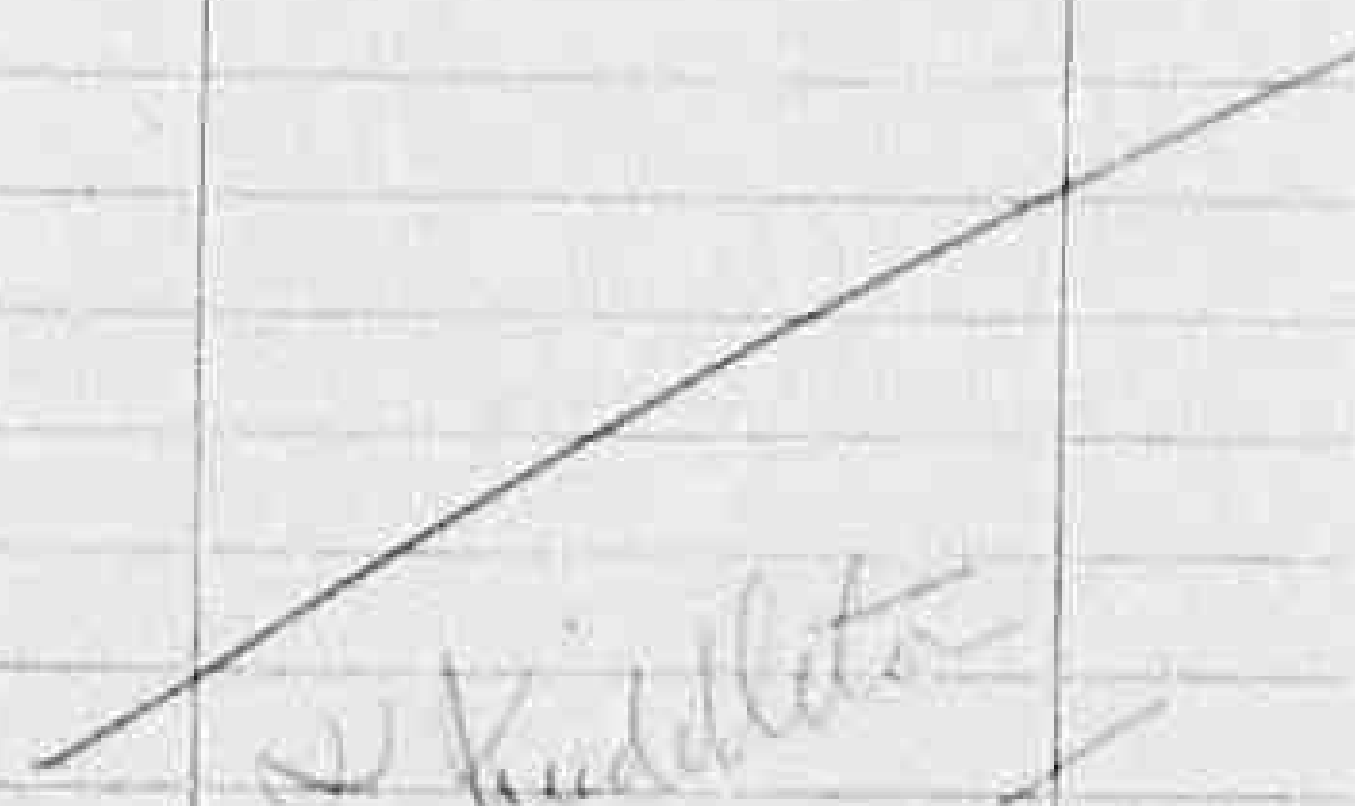
