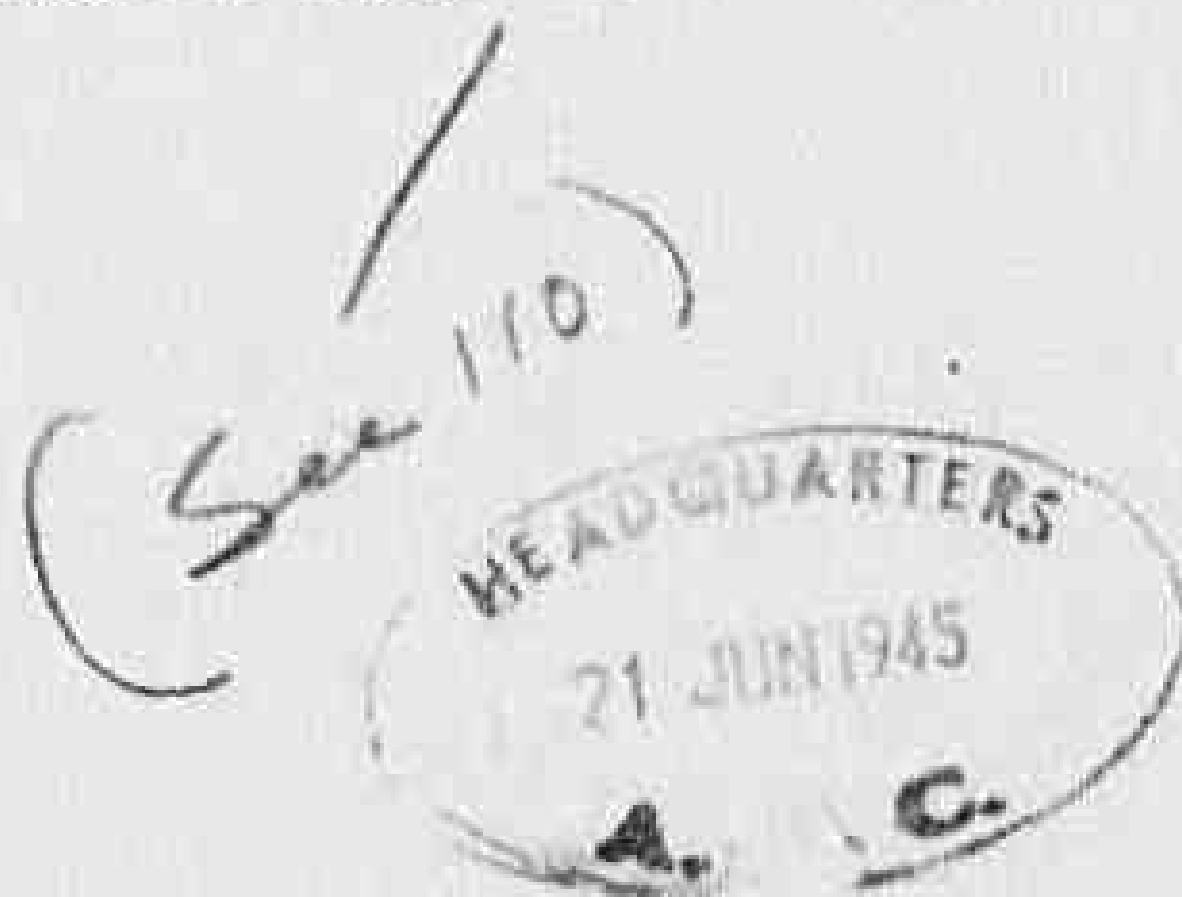

It is considered that the time has come for a meeting between Regional Commissioners of the North and Vice Presidents and Directors of Sub-Commissions at Headquarters, and that, in addition, the opportunity should be taken of bringing together those Italian officials who are working in close touch with AMG with their opposite numbers in the Italian Government in Rome.
2. Such a meeting will therefore take place on the 27th and 28th June in Rome. On the 27th the meeting will be for the purpose of discussing matters which are applicable to the whole of the North, and are of general interest, and upon which the policy has not yet been decided. On 28th June the meeting will be split up into a number of sub-committees for the purpose of clarifying matters upon which the policy has been decided but about which there is some need for explanation.
