I have not approved this request. So long as Mr. Sullivan is Director of a Sub-Commission or part of the Allied Commission, there is no objection to his planning for the future whilst sitting in the Commission. Once, however, he is part of the Embassy staff I think it would be most undesirable to give permission for US personnel to remain here, for it is the thin end of the wedge not only of the British personnel coming over here but of the Embassy taking over the building. Such an eventuality has not yet arisen.

SUBJECT: Provision of Space and Services for
Industry and Utilities Advisory Staff

TO : HQ. COMMANDANT

1. The American Embassy has indicated to me a desire to have Allied Commission provide suitable office space and related services for the Industry and Utilities Advisory Staff, which is being organized under Mr. A. H. Sullivan, Director of Industry and Public Utilities Sub-Commission, from personnel presently assigned to Allied Commission. This staff will consist of about twelve to fifteen persons, including military and civilian.

2. The function of this Industry and Utilities Advisory Staff is to advise and assist the Italian Government in the formulation and preparation of plans and projects for the rehabilitation of Italy. It constitutes essentially a continuation of certain responsibilities which have been carried on by the Economic Section of the Allied Commission. The nature of this responsibility is such as to require very close liaison with Allied Commission and UNRRA, which would be greatly facilitated by the requested arrangement.

3. It is recommended that this request be approved.

4. This letter carries the approval of the Acting Chief Commissioner.
