VERBAL NOTE.

We present our compliments to the Embassy of the French Republic and have the honour of informing you of the following:-

It has been brought to our attention that at Innsbruck Italian buses are seen circulating, still bearing the countersigns of Rome and Milan. These have obviously been taken into Austria by the Germans, and this Ministry would be grateful if -- analogously to what has recently been granted by the U.S. Government-- the French military authorities will be informed and given instructions for the individualization and restitution of the 'buses in question.
