1. Adverting to our letter of even number 22nd February, 1946, (para 2) and also our letter of even number dated 27th February, 1946, (para 3).
2. During the period I was on duty in ROME, I saw an Officer in the French Liaison Division of HQ. A.C. on March 12th, who stated he had no knowledge that Lt. Kalck (French L.O. at TENDA) was no longer attached to LYONS for rations and pay - but was now attached to ROME.
3. As the French L.O. states he is under the Command of ROME for rations and pay and frequently requests travel orders to proceed to MILAN for such purposes, may I please be informed whether he is actually attached to ROME or whether he is still under the Command at LYONS.
