From Military Attache. Following is paraphrase of signal received from Vice Consul Split.

Quote. 1. Two reliable sources have supplied following information on two persons who may be OSNA agents operating in Italy.

2. Personal description.

a. Miss Dirc Bozic. About 24 years of age. Height approximately 5'4". Attractive and plump. Dark colouring. Family civilians in Split.

b. Mrs. Boanka Pasinovic nee Ivssic. About 26 years of age. Height approximately 5'6". Attractive, good figure, hair brown, nose aquiline. Family domiciled Split area. Husband works for ZEMALJSKA Banka shortly to move to Zagreb. Has three year old daughter with husband's family.

3. These women had friendly relations USA Military Mission Split. Left Split in March for Zagreb and since then they made at least three trips to Italy. On two occasions were reputed to be staying best hotel Trieste. Dress well and send home money of which they do not lack. Both Italian speaking and believed to travel between Trieste Milan and Rome., using Zagreb as base. Reported at currently in Milan reporting and making investigations on Yugoslavs in Italy and said to be shortly sent to Rome.

4. All factors in which above information received renders authenticity extremely likely. Additional information may later be available. Unquote. Grateful if you have any information on the above.

1. Party of Princess of PIEDMONT will not leave SWITZERLAND until approximately 1 March. Exact date and final composition of party will follow as soon as possible.
2. In view of delay in return of the party it is necessary for General DI PRALERMO to return to ITALY now to report on his mission and to resume his normal duties.
3. It would be appreciated if on being notified of the time and date when PRALERMO will arrive at the Swiss frontier you will have him met, transported to an aerodrome and put on a plane for ROME with such priority as will ensure his return is not delayed. It is suggested he be met at the same point on the frontier as that to which you took him when he entered SWITZERLAND.
4. Confirmation of the above is requested. For your information PRALERMO holds adequate travel orders for the return journey.

Notification as to when Princess of PIEDMONT and her party will leave SWITZERLAND not yet to hand but felt that you would like following details not to enable you to plan road transport and accommodation.

Para 1. VIP plane (from VIP flight this HQ) to bring the party back from FRANCE would land at BRUN LYON airfield on day before party would emplane. VIP plane besides normal crew would have on board Major PEARSON of Allied Commission who would desire to proceed to the border, meet the party and act as conducting officer on flight back to ITALY.

Para 2. Party of Princess would proceed from SWITZERLAND to Hotel National at ANNEMASSE arriving day before emplaning. Party would require accommodation and transportation from border to accommodation and thence to airfield. Major PEARSON would require transport to take him to the border in order to meet and return with the party.

Para 3. Understood that when party of Italian Political Personages moved back to ITALY on 7/8 December last accommodation was provided at CHATEAU PEYREU and that assistance in handling party was given by Major PAYETTE and Lieut LOMBARDI of Civil Affairs LYONS. Considered here that same arrangements for party of Princess would be adequate.

Para 4. Final composition of party of Princess of PIEDMONT still dependent on whether she brings her 4 children with her but following will serve as guide to you pending final details being known.
