REPATRIATION OF ITALIANS FROM DODECANESE  
OCT. 1944 - JULY 1945

*Explain*

TO: CSO

Your attention is drawn to correspondence on this file with reference to the repatriation of Italians from the DODECANESE .

Folio 6: AFHQ request AC to obtain immediate acceptance of Italian Government to principle of repatriation of a total of 665 persons owing to risk of outbreaks of violence due to anti-Italian feeling.

Folio 8: Is copy of letter from MFA which says that in principle it cannot favour the repatriation of Italians who have been settled abroad for many years and that its policy is to favour emigration rather than repatriating emigrated Italians. It has no objection however to the repatriation of Italian officials not employed by EAA.

Folio 12: Signal from C.A. Section to AFHQ agreeing with the Italian view pointing out that the proposal amounts to a mass evacuation of all resident Italian population, which is a matter which should await determination at the Peace Conference.

Folio 13: Is personal for General Robertson pressing for authority for the repatriation and increases the number of persons to 2,170, which figure however includes some refugees held in camps which it is desired to close. Details of the latter have not yet been submitted to the Italian Government.

Personal for Gen ROBERTSON from DOWLER.

1. Question of repatriating to ITALY Italian nationals who cannot for security and other reasons remain in DODECANESE has been under reference to you Hq since Oct last. No progress seems to have been made in spite of your support.

2. Small number involved VIZ 2170 including refugees should not I imagine cause any great embarrassment in ITALY but we cannot keep them much longer in DODECANESE without risk of serious trouble. Hope however that once these have left opposition will die down and no further repatriation will be necessary while DODECANESE remain under BEA.

3. Grateful earliest authority for repatriation to proceed. Nominal rolls will be sent if required.

- 1 On 9 June 1945 AMED on the instigation of ISOP, requested the Commission to ask the Italian Government if they would accept into this country 665 persons now in the Dobroanese. At a later date this number was increased to 1157.
- 2 On 26 June the Italian Government answered to the effect that they have no objection to the repatriation of officials, but that they could not favour the repatriation of Italians who settled abroad many years ago.
- 3 This Section is of the opinion that the Italian view is a correct one, despite the alleged danger to these persons. It would be appreciated if you would consider this view and say whether you are in agreement.
- 4 Copies of the relevant documents are attached.

MEMORANDUM FOR THE ALLIED COMMISSION

SUBJECT : Italians in the Dodecanese.

1. Reference is made to Mem-INT/24/G-II(IT) of June 18th 1945.
2. The Italian Government have no objection to that the Italian officials in the Dodecanese, not employed by the A.M.G., be repatriated to Italy.
3. As regards the other Italians, it is pointed out that most of them have settled in these islands, and particularly in Rhodes, since 1922 and many of them have set up an economic activity which is useful to the life of the local populations and to the general economy of the country. Their return to Italy where they have no possibility of finding work, would bring about their ruin and lay into the Italian Government a very heavy burden just at a time in which the latter must face the return of the ex-prisoners of war who surely need assistance and relief.
4. The Italian Government cannot favour, on principle, the repatriation of Italians who many years since settled out of the country, both abroad and in the Italian Colonies and Possessions: Italy is compelled, for obvious reasons, to follow a policy which aims at favouring emigration rather than at repatriating emigrated Italians. The Italian Government expect the Allies to share and further this policy.
5. As regards the Italians in the Dodecanese, the Ministry for Foreign Affairs fail to see for what reason they should find themselves in some danger, all the more so as the local populations have drawn nothing but benefits from the exploitation of those islands by the Italians. Should there, however, be some threats of sporadic disturbances, the Italian Government trust that the Forces of occupation will be able to forestall them without having to resort to the forcible mass-transfer of persons from their place of residence.

1. Anti-Italian feeling in DODECANESE Island so strong MIDEAST consider serious risks outbreaks violence unless certain classes removed at early date. Appreciated by MIDEAST difficult for Italian Government to agree any large scale repatriation but considered essential following to be repatriated at once:

(1) 50 men, 38 women being Metropolitan Italians ex-rhodes whose presence likely to cause trouble with Greek population. 56 children would accompany.

(2) 82 Metropolitan Italians ex-rhodes who are discharged officials. 6 women and 7 children would accompany.

(3) 169 men, 440 women and 119 children being whole Metropolitan Italian population of Island of COS. Local Greek feeling in COS against these is stated dangerously hostile.

2. Total of all above 665 persons.

All of classes 2 and 3 above and some of Class 1 desire return Italy.

Request you secure immediate acceptance of Italian Government to principle of repatriation all above and signal reply. Nominal rolls will then be forwarded of MIDEAST and details repatriation worked out.

1. Your letter 6-5 AMHQ 35-62 dated 5 November '44, has been carefully considered by this Commission.
2. I am directed to state that it is the considered opinion of this Commission that the repatriation of the categories mentioned in sub paras. A, C, & D of para 2 of the letter dated 22 October '44 from GCHQ IPT, would at the present time be undesirable.
3. It cannot be doubted that a large proportion of such persons will have to be treated as refugees and will cause an already extremely difficult problem to be even more so.
4. Furthermore it would be most undesirable to receive these subjects in view of their politically undesirable background and outlook. It is therefore requested that such persons be not repatriated to this country while hostilities continue.

1. It is our policy that Italians are to be given no part in our administration of the DODECANESE when we occupy these Islands. While the future of the DODECANESE is not yet decided, it can safely be assumed that they will not be returned to Italian sovereignty.

2. There will be certain categories of Italians whom it will be most desirable to repatriate to ITALY as soon after the occupation of the islands as possible. An estimate of these is given below, but the accuracy of the figures can only be verified after occupation.

(a) Discharged Civil Servants who would be a focus for political intrigue	-	200
(b) Discharged Carabinieri etc., who have military status and are subject to treatment as PW	-	400
(c) Italians on Security Black Lists not sufficiently dangerous to justify internment	-	450

3. In the early stages of the occupation there will be a number of PW in the islands who will be concentrated and imprisoned in a central cage at RHODES. These PW will be evacuated to the mainland in the MIDDLE EAST as shipping is available, but this may take some time. It is desired to avoid a further commitment of keeping the Italians in para 2 above under restraint, and as they will ultimately have to be repatriated to ITALY, it is suggested that they should be moved by direct shipment from RHODES to ITALY as soon after occupation of the islands as possible.
