Subject: RUK Files

To: Allied Force Headquarters.
Attn: G-5 Section

1. I am seriously concerned with regard to the RUK files now in my custody. These files are documents of the greatest importance, not only to the Italian Government, but to the Allies themselves. Owing to shortage and constant changes in staff I have been unable to complete even the registration of the files which is one of the most important steps to ensure their security. Moreover, unless these files are micro-filmed we run the risk of the loss of the extremely valuable information which they contain through accident or design.

2. Owing to the difficulties of staff mentioned above, the files at the moment are practically completely in the hands of German staff. I have no evidence to doubt their integrity but suspicions have arisen during the last two weeks which bring me to the conclusion that if we are to be certain that no information leaks out about these files to unauthorized sources, these Germans should be decently re-interned pending decisions by U.S. and U.K. Governments on proposal in para 5 below. The temptation is far too strong.

3. It has been suggested that these files are the property of Allied Commission in Germany and I would urge that a rapid decision be made as to their future disposal.

4. In the meantime I am compelled to treat them merely as archives and to limit my work on them to the registration of the documents and to restrict access to them, as approved in your letter, to the absolute minimum.

5. I would recommend that so long as they are kept in Rome these files should for purposes of investigation be passed over to the custody of the Joint Diplomatic Research Section which is under the aegis of the US and UK Embassies working on Italian secret archives in Rome. Such disposal would release the Allied Commission from a responsibility which I feel they can no longer accept without an increase in staff of several specially qualified officers whom it would be almost impossible to obtain. US and UK Embassies agree in principle and, if you concur, they will submit detailed proposals to their respective Governments regarding personnel, pay, etc. Meanwhile, Germans mentioned in para 2 should not be allowed to disperse, in case it is decided that their specialized knowledge is indispensable.

6. If it is decided not to microfilm the documents, then they can be transferred to the Joint Diplomatic Research Section as soon as accommodation can be found. If it is decided to microfilm them, then the transfer should take place in instalments after the photographic process.

7. In the meantime I am allowing access to these files under the conditions laid down by you to a member of the Italian Government who wishes to examine them in connection with Italian taxation.

At a Meeting with Dr. Bombassei and Col. Domenico Fumarola
Chief of Italian Finance Office - on 5 Aug. 1946.

1. Dr. Bombassei said it was understood that RUK files were in Rome and it was requested that access should be permitted for them to be examined by Italian Government.

2. Major Harrison said that the conditions under which the Italian Government could examine the RUK files were in preparation but that the investigation of files might interfere with present instructions to commence Microfilming and until the policy to Microfilm was altered, he could not promise that access to the files would begin immediately.

3. Col. Fumarola asked whether the files were in Rome and how long it would be before access could be arranged.

4. Major Harrison said that without the instructions of the Executive Commissioner he could say nothing further but that immediately any information was available he would get in touch with Dr. Bombassei upon the matter.

I have the honour to draw your attention to the facts given
below :

1. - We have just received instructions according to which

- a) an appreciable part of the considerable French industrial material taken away by the Germans is at present in the Upper Adige ;
- b) we are being asked to supply every information concerning its nature and location.

2. - I have contacted in this matter the CEM Sub-Division and it appears that :

- a) in fact a very considerable quantity of industrial material of the United Nations is in the Upper Adige ;
- b) CEM are unable to give for the moment but the most general information on its nature and location ;
- c) Only access to the RUK archives which on the other hand have been exactly located in the Upper Adige, would permit to trace the whole quantity and to proceed to the restoration of this industrial material.

3. - As a result of and following our visits to Major HARRISON (Ref. Par. 2 of your letter 4063/EC) who told us that he was at our disposal for any "precise question" regarding the RUK files, I have the honour to ask you kindly to give or arrange for instructions to be given which may permit to CEM and to my Staff to work in conjunction with the RUK files staff, in order to clarify and settle this particular matter.

A Conference held at Archives Division - 19th Dec. 46.

Present: Col. Dom Fumarola - Director of Italian Finance,
Major N.M. Harrison - Archives Director,
Capt. McCracken (A) - Archives Officer.

1. Major Harrison stated that the Meeting had been called to carry out arrangements whereby accessibility to the RUX files could be made for Italian officials in accordance with AFHQ (G-5) instructions.

2. Major Harrison read out the conditions (translated) and Col. Fumarola agreed to all the points.

3. Col. Fumarola asked whether any further "taxable" information was now available either upon removed plants, and machinery, or clothing and materials such as boots etc?

4. Major Harrison stated that ROSES might be available later but that the files were still being listed and catalogued and were still incomplete. In view of the variety of items continually coming to light there were three categories which Italian Finance officials might care to examine:-

9. Major Harrison in conclusion asked Col. Fumarola (a) if he would contact Col. 1. The present state of RUK files now permits accessibility by the Italian Government in accordance with your instructions.
2. Up to the present owing to a Security black-out imposed at the request of SIB and FBS only certain abstracts from the files were able to be seen by Italian Officials of the Ministry of Finance.
3. This black-out has now been lifted. After screening it was decided to dispense with the services of the German staff and they have now been paid off. One employee of Czech nationality has been retained.
4. Numbering of all RUK documents is continuing. A total of over one million has been completed out of an approximate 3 million. Approval for RUK files to be microfilmed will allow increased staff to complete this work but may somewhat interfere with examination of certain files whilst filming and documenting is in operation.
5. In accordance therefore with your instructions a table of conditions has been prepared under which Archives may be entered and RUK records examined by officials of Italian Government. (Enclosure A).
6. If these conditions are approved, steps will be taken to procure an Allied Official under (d) and the Italian Government advised that access to the RUK files is now permitted, subject to these conditions.

Subject: Conditions of access to Archives and examination of R.U.K. records by Italian Government Officials.

- (a) Access to RUK files will be allowed only to approved officials of the Italian Government.
- (b) The names of these Italian Officials will be agreed with the Director of the Archives Division, and the number of officials will not be in excess of a number which can be supervised by one Allied Official. If a change is desired in the Italian officials, prior-approval must be given by the Director of Archives Division.
- (c) Examination of records will be carried out in a special room set apart for the purpose in that part of Alcom Hq. allotted for the storage of RUK files.
- (d) Investigation of documents will be carried out under continuous and close supervision of an Allied official who will be:-
- (i) A British or American subject.
 - (ii) Of officer status.
 - (iii) If possible, German speaking.

The above Allied official will be permanently in the room with the Italian officials.

- (e) No documents will be removed either from its file or taken from the examination room.
- (f) All documents handed over to the Italian officials for examination will be signed for and will be checked and accounted for at the end of each day's work.
- (g) No information obtained from the documents will be communicated to any private individual or to the representatives of firms.
- (h) Officials who are nominated under (b) will sign a certificate to the effect that they undertake to observe conditions (e) and (g).

(a) The statement that the FSS report will in no case be later than Sept. 14 cannot be confirmed. In order that the numbering of all RUK documents shall continue as soon as possible, FSS have promised to release certain rooms and the files within them by the end of this week. The numbering of over three million papers will however take some time to do, depending upon the staff employed.

(b) That military personnel are not available to process the documents is incorrect. My Archives Branch are ready to commence processing the files for filming immediately approval is received from OCS that the documents shall be microfilmed here. This is expected daily.

(c) The reply to your four questions can be answered in the negative.

(1) Instructions in writing to the Italian Government of the conditions of access have not been issued. Decision is awaited as to how the RUK files shall be administered and by what staff.

(2) The only application by the Italian Government is enclosed. This is for copies of filmed matter when microfilming has been completed.

(3) The Italians have NOT been informed in writing of the present blackout of the files.

(4) No plan has been proposed by the Italians as to how they intend to use their privilege. It is believed that they have a German speaking Italian interpreter whom they propose to use.

I am able to assure you, however, that certain access is being permitted in accordance with my letter to AFHQ (4063/EO. para 7) of Aug. 9th.

SUBJECT : Access to RUK files by the Italian Government

I should be grateful for your comments on the following notes, which constitute my understanding of the present position with regard to RUK records and access thereto by the Italian Government. I should also be grateful to have the answers to the questions raised at the end of this memorandum.

Custody and administration of the RUK records is presently vested in the Office of the Executive Commissioner, Archives Branch.

No Allied Military personnel are presently assigned specifically to guard, handle, or process the records.

German personnel who had been processing the records were taken off this work on or about August 8, owing to suspicion of security leakage. Since that time no work has been done on the documents, and no access to them has been allowed.

FSS are presently investigating possible security leaks. Their report is due as soon as possible, and in no case later than September 14, 1946.

ALCOM is empowered to grant access to the records to the Italian Government, under the terms of instructions from G-5, AFHQ, dated July 13, 1946, (File No. G-5: 963.20P). This instruction was issued after consultation with the State Department and Foreign Office, and specified that only officials of the Italian Government might examine the files, provided such investigation be done under continuous and close supervision of an Allied Official and that certain other mechanical precautions for preservation of the documents be observed.

Even after completion of the FSS report, and lifting of the present security blackout on the files, there is no indication that military personnel will be available to process the documents or to provide the machinery for fulfilling the conditions under which Italian Government access to the files may be granted.

After consulting with the British and American Embassies, the Allied Commission informed G-5 on August 9 (Ref. 4063/EC) of the possible security leaks and recommended turning custody of the documents over to the Joint Diplomatic Research Section. The two embassies had indicated that they were submitting to their respective Governments recommendations for personnel to enable them to fulfill the obligations thus contemplated. Thus it has been assumed that not only processing but also access to the files would depend upon transfer of custody and administration from ALCOM, which in turn depended on the two Embassies indicating their willingness and ability to provide the requisite personnel.

The US Embassy has now been informed by its Government that, owing to shortage of funds, additional personnel to work on the RUK files cannot be supplied. The US Government does, however, appreciate the importance of the problem, and will continue to attempt to find a way to assign adequate personnel.

The British Embassy is presently awaiting further instructions and possible assignment of personnel, following personal enquiries in Rome by Lt. Col. Thompson.

Irrespective of other aspects of the problem I should be grateful for answers to the following questions:

1. Has the Italian Government ever been informed in writing of the conditions under which its officials may have access to the RUK files? If so, may I please have a copy of the letter so informing them?
2. Has the Italian Government since February 1946 asked in writing to have access to the documents, especially those pertaining to removals from Italy of industrial plants? If so, may I please have a copy of their request?
3. If the answer to question 1 is in the affirmative, have the Italians ever been informed in writing of the present blackout on the files? If so, may I please have a copy of the letter?
4. Have the Italians ever indicated how they propose to exercise the privilege of access to the RUK files, indicating whether they have qualified personnel, a detailed plan of procedure, and any specific objective? If so, may I please have a copy of the letter.

If it is not, then it will be more difficult as time passes to arrive at the truth and I recommend steps should be taken now to reconcile their reports with the facts contained in the RuK files.

2. Has any action been taken by Major Rowarth to acknowledge receipt of the 12 letters enclosed with your letter?
3. The final disposition and the policy as to any further investigation of these matters is at present under discussion with CGS Washington through AFHQ (G-5).
4. In the meantime will you please forward any future correspondence on these matters immediately to my office for action.

1. Para 10 of MAT 1021 contemplated that RUK files be placed temporarily under ALCOM. Latter now states owing to run down and lack of suitable personnel it can no longer handle these files, but that Joint Diplomatic Research Section under AMHS British and US Embassies is prepared to accept them and that the Embassies are making recommendations as to staff to their respective Governments.
2. In view of foregoing and impending demise of ALCOM your approval to the transfer is requested.
3. When considering para 12 of MAT 1021 you should be aware that recent check shows that collection consists of over 4,000,000 documents and would require 9 months to photograph with equipment at present available and produce 2 copies only.
4. If photographing is desired will you please state number of copies required and when photographing to take place before or after transfer to Joint Diplomatic Research Section in latter event as the military period will probably terminate before photography could be completed would the Military Film Unit be available.


