Dear Admiral,

Among the various forms of propaganda which we thought of using to facilitate the subscription, to the five years Buoni del Tesoro 5% 1945, which is now taking place in Northern Italy, there is also the throwing of leaflets by a plane.

To this end, the Ministry of Treasury and the Bank of Italy asked the Finance Sub-Commission (Lt. Col. E.P. Waters) the necessary authorization which depended on the approval of the Air-Force Sub-Commission and the five Regional Commissioners of Northern Italy.

On July 18th, Lt. Col. N.T. Beard, of the Finance Sub-Commission, informed the delegate of the Bank of Italy that the leaflets could be printed at once, for the 5 Regional Commissioners had given their agreement, and the Air Force Sub-Commission gave its authorization on general principles, and said that the leaflets prepared in packs of 5000 were to be transported to the Grottole Airport, before 8 a.m. on Monday July 23rd.

According to these precise statements, the Bank of Italy took the necessary action to have 2 million leaflets printed at once, thus spending about one million lire.

But, on July 21st, when the leaflets were already printed, the Finance Sub-Commission informed the Bank of Italy that it was not possible to have the leaflets thrown, for A.F.H.Q. had not allowed the necessary fuel to be allotted, for the Command considered the flight of the planes wasn't one of the cases of urgent necessity for which an allotment could be made.

I hope that considering the circumstances which I have explained to you, you will kindly intervene to obtain the allotment of the fuel required for the flight. I take the liberty of asking you to have this allotment made without delay, for a further postponement, even of a few days only, would destroy all the propaganda effect which the throwing of the leaflets might have, and have a negative influence on the results of the loan which is so important for the economy of our country.

Dear Admiral,

I refer to your communication of July 2nd, in which you drew my attention on the fact that the men who belong to the Allied Army Forces, though entitled - because of the pledge assumed by the Italian Government - to full tax exemption, have nevertheless to bear the burden of some taxes, such as taxes on public shows, sale tax, and tax for the fund of national solidarity.

You certainly noticed that this depends entirely on the system for the collection of indirect taxes, which weigh on the product objectively, independently of the person of the consumer.

In any case, I am quite willing to confirm the pledge taken by the Italian Government to exempt the members of the Allied Army Forces from every form of taxation, while I acknowledge the reservation of the Allied Governments to ask for the payment of all sums paid by the above mentioned soldiers to the Italian State and to the organizations which depend from it.

I have contacted the Minister of Finance who will order the depending organizations to observe the exemption.

My dear Mr. Prime Minister:

I understand from the Joint Directors of the Finance Sub-Commission of this Commission that there is a growing tendency at the Ministry of Finance to lose sight of the fact that the Italian Government has undertaken to grant exemption from Italian taxes not only to Allied organizations but also to individual members of the Allied Forces.

It is appreciated how difficult, if not administratively impossible, it is to devise methods of granting relief from indirect taxation to individual Allied personnel without leading to uncontrolled tax evasion by Italian nationals. In consequence, the Italian State revenue is benefiting to the extent of many millions of Lira from taxes paid by individual members of the Allied Forces. The more important of the taxes being paid by Allied troops are the turnover tax (sull'entrata), entertainments tax, Fund of National Solidarity, and Imposta di Consumo. Of these the first mentioned is without doubt the greatest source of revenue, when it is borne in mind that most goods change ownership at least three times before reaching the final purchaser and that the price to him is thereby enhanced by a minimum of 1%.

However, while it is not intended at this date to request any change in the existing arrangements, I do wish it to be clearly understood that individual members of the Allied Forces are not liable to any form of Italian taxation and that the Allied Governments reserve the right to be reimbursed for any taxes which have been or may be paid by the Allied Forces in Italy to the Italian Government or any sub-division thereof.

The savings-bank of Imola, (Bologna), founded in 1859, is managed, according to the statute in force, by a board composed of a President, a Vice-President and five councillors.

However, the President, in charge, Vincenzo dal Negro, left the town a year ago, and never came back, and the vice president, Dr. Carlo Gambetti, resigned some time ago, though he is still temporarily supervising the current business of the Bank.

According to the statute, the President and the Vice President are appointed by a decree of the Prime Minister, who would therefore have to provide to the posts rendered vacant by the absence of the first and the resignation of the second.

As this concern has its seat in a locality which is under the administration of the Allied Military Government, I think you must be informed about this situation, and I ask you to draw the attention of the regional Commissioner on the advisability of completing the administrative organs of the Bank. Adv. Giacomo Del Monte Jasoni has been suggested for the post of President and Dr. Gino Nardozzi for that of Vice-President; they have the necessary requisites and enjoy the confidence of the population.

The Italian Government has no objections to make on this subject.

I shall therefore be most grateful, my dear Admiral, if you kindly take the necessary action to normalize the situation of this old and deserving savings-bank.

It is likely that you have received detailed reports from your representatives in the north. However, I am forwarding a few extracts of general interest from a report, dated yesterday, from my Joint Director, Colonel Menapace, written in Milan:

1. "Establishment of an AC office in Milan for Northern Italy. The CLNAI has repeatedly pressed for this, doubtless because this would be a pretty solid recognition of their authority to determine policies for the North. I have advised Mr. Antolini that this would be unwise from Finance point of view. We have told the CLNAI that they should present their suggestions and requests to the RFO's, and that these will pass them on to AC Finance Sub-Commission. By this means, we shall be able to orient policy toward accords with the Ministries, Banca d'Italia, etc., in Rome on all the problems regarding currency, operations of Banca d'Italia, and other matters which must be treated on a national basis. Otherwise we should have conflicts on many points."
2. "Another example of the committee's autonomous attitude is this: when I told Longhi that Mattioli and Orsi had been designated as Commissari of BCI and Credito, temporarily and for the express purpose of convoking the Boards, he unhesitatingly declared that the committee will not accept these appointments. He said they have no objections to these men personally, but they will not accept appointments themselves since they concern the North. He went further and said that they will not recognize the head office of Banco di Roma as having jurisdiction over its branches in the North because they consider that the Commissario of that bank in Rome is not qualified for the post."
3. "Parallel problems, of course, run all through SIC/AC up here, and our whole group has had many discussions of this aspect of the situation. A firmer attitude in

our organization is developing. Mr. Antolini has requested Col. Walker (IV Corps SCAO) to instruct the CLNAI to postpone any further payments, by industrial commercial and banking firms to their employees of the bonus which I described in my letter of 12 May to you via Col. Penick. Walker is endeavoring to persuade the committee to hold this matter in abeyance until it can be considered by the Italian Government because of its national importance. However, if persuasion does not succeed it is intended to tell the committee that it is the desire of AMG that this be considered as an order."

4. "The whole matter will doubtless be solved when an understanding is reached between the Rome cabinet and the CLNAI, and this step is urgently necessary if constant conflicts are to be avoided."
5. "Longi's position in regard to the Commissari of BCI and Credito, incidentally, was uncompromising, even though I insisted on their temporary nature, because he saw this matter as a point of authority in the North. Naturally, this question involves the whole area of government and is something for the Rome government and local CLNAI to work out. At the time, however as you will appreciate, this does impose on AMG perhaps some deviation from the line of handling the situation up here with a "light rein", since the avoidance of unrest and keeping of law and order require AMG to assure the smooth functioning of governmental machinery and the economic life of the area."
6. "The matter of channels of AC/AMG operation also needs clarification. I have told the RFOs' to communicate ~~immedi~~ ~~ately~~ directly with Finance Sub-Commission, but to send copies to the FO IV Corps who will send them on to SFO 5th Army. I suggest that directives be sent to RFOs directly, with copies to SFO 5th Army for himself and FO IV Corps, and to 8th Army RFO for the rest of the North."

I received your letter 34281/34015/9.6 of 6 May 1945.

I can assure you that the Allied Commission has also had under constant study the possibility that currencies, including Italian lire, might be imported into Italy, particularly across the northern frontiers.

Proclamation # 2 of the Allied Military Government forbids the importation or exportation of currencies of all countries including Italian lire. The northern frontiers have been closed by order of AFHQ and instructions have been issued to enforce the terms of Proclamation # 2.

My financial advisors are satisfied that practicable steps have been taken to control the importation and exportation of currencies; and they will keep H.E. Soleri informed of the effects of the control measures and of any other important developments.

the Minister of Treasury told me that he very much feared that in the present circumstances, Italian currency might be introduced in the kingdom through the land and sea frontiers, as well as by air.

This would be a violation of definite regulations formerly issued by the Italian Government, and have serious repercussions on the monetary circulation; it seems therefore necessary and urgent to prevent its taking place.

I share His Ex. Celery's preoccupation, and I send you a copy of the main regulations on the subject, asking you to take the necessary action.

The Italian Government thinks it would be necessary to establish a strict control at the land and sea frontiers, and in the airports, and that the censorship organs should get orders to prevent Italian currency from being introduced by means of correspondence coming from abroad; that the sums which should be found ought to be sequestered, kept as deposits, and information sent to the nearest branch of the Banca d'Italia.

I trust you will examine this question which is so important and urgent, and I would very much appreciate some information about the orders which will be issued for control.

3. In the discharge of its duties the JMFC will work in close co-operation with the Allied Commission. To assist to this end and to assure direct liaison, the Allied Commission will be invited by the JMFC to have a representative present at each scheduled meeting of the committee.



4. The JMFC may at its option add such members as may be desirable, and co-opt such other persons as may be necessary for the conduct of its duties.

5. In those forces in which instructions are signed and issued by or on behalf of a chief of a staff or service section, the responsibility for reference to the JMFC of proposals having a financial bearing which may affect some other force, will lie with the officer who will eventually sign and issue the instructions. In those forces in which instructions are signed and issued by an agency which is not responsible for the content of the instructions, responsibility for reference to the JMFC will rest with the general or special staff section having primary interest.

Currency problem in BOLSANO and TRENTINO is subject.

1. Indications are that Germans have treated BOLSANO and TRENTINO in Northern ITALY as part of GERMANY (AUSTRIA) and have introduced Reichsmarks. Not known what composition of currency circulation is at present.

2. Until Reichsmarks can be withdrawn should we declare exchange rate between lire and marks and if so should rate be ten lire per reichsmark. It is planned to call in all reichsmarks in exchange for lire at earliest opportunity, but metropolitan lire may not be adequate in volume unless new supplies are uncovered in North. In such circumstances call in of reichsmarks would have to await arrival of new currency, unless A.M. lire are to be used. Your views requested soonest.

My dear Mr. Prime Minister,

It has been brought to my attention that certain highly-placed officials of insurance companies in Rome are corresponding with insurance offices and companies in foreign countries that are on the proscribed lists of the Allied Governments. Such correspondence has been conducted through the medium of the ordinary postal services, which are liable to Allied censorship, and excerpts made by the censorship authorities disclose use by these same companies of telegraphic and other facilities at the exclusive disposal of the Ministry of Foreign Affairs.

The conditions under which my advisers have agreed to the active functioning of the Italian insurance companies, which have been confirmed by a communication from the Allied Governments made known to the Ministry of Industry, Labor and Commerce, have precluded the resumption of such contacts. The only foreign correspondence now permissible is limited commercial correspondence to certain Allied countries under conditions already known to you.

It is a matter for some concern that certain interests are endeavouring to evade restrictions well known to them by facilities of this nature, and I shall be grateful if you will ensure that all the companies are warned that such evasions are regarded most unfavourably by the Allied authorities.

Dear Admiral Stone,

I thank you for your letter of 23rd March about the new Italian Internal Loan, and confirm that PWB will do anything in its power to assist this loan.

I have already included a paragraph agreed with your Finance Sub-Commission in our weekly directive, which has been issued today, and will include similar paragraphs as long as required. I have also cabled to London and New York asking that the BBC and the American radio shall afford suitable publicity to this initiative of the Italian Government.

I have also written to Florence instructing our Headquarters in that city to give all possible transport facilities for posters and other material which the Italian ministry may desire to distribute within the military zone. I have also enquired whether we can assist with printing facilities in that city. Mr. Minifie, the Deputy Head of our organization in Florence, was in Rome yesterday and I fully explained the matter to him and he will do what is possible to assist the Italian officials.

I am going to Bari myself tomorrow and will take similar action there.

The Italian Government Bill advertising this issue is being distributed by PWB on as wide a basis as possible. I would add in this connection that PWB will always be pleased to assist the Italian Government or individual Italian Ministries in the distribution of films prepared by the Government until such time as the normal machinery for the distribution of films has been re-established. I would however, suggest that requests for the distribution of Italian Government Films should be addressed to PWB through the Allied Commission as we do not wish to undertake such duties in Liberated Italy unless it is the Commission's desire that we should do so.

On 26 June, 1944, Finance Sub-Commission was advised by Regional Finance Officer, Region IV, that in auditing the account of AEC 5 Army sub-accountant, an item of Lire 30,150 was found representing a payment for press clippings furnished by Burrelles and Romilse Press Clippings Bureau in the U.S. The actual dollar payment in the U.S., it was found, was effected by one Captain C. A. Harwell out of his personal bank account, it being understood that he would be repaid in lire through AEC 5 Army. The total cost of the two services for three months was indicated to be \$301.50. The sub-accountant referred the payment voucher for Lire 30,150 to Major John Asee, Executive Officer, AEC 5 Army, who obtained General Huse's own signature on the payment voucher.

3. On 3 July, 1944, Colonel E. H. Foley, Jr., Joint Director, Finance Sub-Commission, wrote an official letter to General Huse, the relevant parts of which read as follows:

4. On 20 July, 1944, General Huse replied as follows:

The clippings were ordered in furtherance of the wishes of the Army Commander in order that Allied Military Government might, so to speak, watch the pulse and temperature of the American people with regard to their reaction towards what is being done by Allied Military Government with the Fifth Army. The services purchased are such as a Public Relations Officer would normally subscribe to in the pursuit of his functions. There being no such officer now at this headquarters, it is necessary for me to discuss matters with the press constantly, in accordance with the Army Commander's policy. So follow that, I must be fully informed of how the press is reacting. The clippings were not desired for historical purposes and therefore are

valuable only if received with reasonable promptness such as is the case with those ordered from legitimate newspaper clipping bureaus. Subscriptions to newspaper clippings is a common and well recognized administrative procedure in the U.S. War Department and similar establishments when a knowledge of the public's reactions is important.

It is noted that certain microfilmed press clippings from the War Department have been given distribution among higher ranking military Government officers in Italy and North Africa. While this is doubtless the case, such material has reached Allied Military Government, Fifth Army, only on three occasions and in all three of them the copies were so old that they were of historical interest only. The last such material received at this headquarters was several months ago. The file at AGC headquarters that is available for perusal is hardly of much practical use to a military headquarters in the combat zone nearly six hours distant.

In my opinion it would be difficult to justify the reversal of the policy authorized by Col. Foley. The change of Commander at 5 Army may make it possible to withhold subsequent authority. But I would expect that Brig.-General Hume has already convinced the new Army Commander that the maintenance of an interesting and detailed news clipping service is to be desired. This is a subject which would be better discussed in conversation between General Truscott and yourself rather than by correspondence restricted to the financial field.

1. I have been informed by DD Claims and Hirings that the Acting Provincial Supply Officer, Perugia Province has agreed to an increase in hotel tariff rates in that province. Copies of the Claims and Hirings letter and that of the Acting Provincial Supply Officer are attached.

2. As you will note from paragraph 5 of the Claims and Hirings letter, the agreement made in Perugia will cause serious trouble for the Italian Requisitioning Authorities, upon whom the responsibility rests for financial settlement with hotels occupied by the Allied forces, both in Italian Government and Military Government territory.

3. I therefore <sup>direct</sup> request that you instruct the Acting Provincial Supply Officer to withdraw his letter of agreement and to inform accordingly all persons to whom a copy had been sent.

1. I refer to telephone conversation (Major Hall - AD Hirings) and to letter from Acting Provincial Supply Officer AMG, Perugia Province, to Prefettura Perugia copy to Commissario dell'Ente del Turismo.
2. It is noted from this letter that the Acting Provincial Supply Officer has agreed an increase in tariff rates for hotels in that province of 500% over the latest published Italian prices in respect of 1st, 2nd and 3rd category hotels and 600% in respect of 4th category hotels.
3. As you are aware, the question of fixing a tariff rate for hotels has proved completely incapable of solution to date. The payment on account system agreed between the Allied Military Authority and the Italian Government has been evolved largely for this reason and at the direct request of Finance Sub - Commission, Allied Commission.
4. As you are also aware, the Ministry of Industry and Commerce, Italian Government, are at the present time endeavouring to draw up a tariff rate for the various six-monthly periods from the Allied occupation of Italy to date.
5. The agreements made in the above letter are out of all proportion and will cause serious trouble for the Italian Requisitioning Authorities unless some action is taken immediately by your Sub - Commission to have the agreement cancelled. This is particularly necessary as a copy of the letter has been sent to the Central Tourist Organisation, responsible in normal times for the fixing of tariff rates for hotels.

PAYMENT FOR AIR TRAVEL WITH MATS AND AFO OF NATIONALS

1. Instructions have been received that in future (a) the transport by MATS or AFO of nationals of countries receiving lend-lease facilities will be charged against lend-lease account, and (b) the transport of nationals/countries not receiving lend-lease will be paid for in cash.
2. AC is not concerned with the accounting for the transport referred to in 1 (a) above, which will be handled by the U.S. transport agencies concerned.
3. With regard to 1 (b), the individuals to be transported fall under two categories, (a) individuals whose travel orders are not obtained by AC, and (b) individuals whose travel is sponsored and travel orders issued by AC, (e. S. Italians travelling on AC business, or nationals of countries not receiving lend-lease transported by Displaced Persons and Repatriation Sub-Commission).

4. AC is not concerned with the procedure for the transport referred to in 3 (a), as payment of the transport charges will be made by the agency sponsoring the travel.

5. With regard to 3 (b), namely nationals of countries not receiving lend-lease whose travel is sponsored and whose travel orders are made out by AC, the payment of the transport charges will be made by AC. The procedure will be as follows:-

Financing of Italian diplomatic missions is subject.

1. Italian Ministry of Foreign Affairs and Ministry of Treasury have now presented a tentative plan for financing Italian diplomatic missions for January and February, 1945.

2. Instructions have been given, with the approval of AG, for utilization of following local currency amounts, if available, by the respective Italian missions in January and February, 1945: SWEDEN - Krona 98,000 PORTUGAL - Escudos 540,000 SPAIN - Pesetas 1,599,160 TANGIERS - Pesetas 252,000 ARGENTINA - Pesos 240,000. Italian Ministry of Foreign Affairs has indicated that these are the minimum amounts required at the present time, and that it is hoped that reductions can be made by closing offices and institutes and repatriating personnel. It should be noted, however, that because of lack of up-to-date information Italian Government cannot be certain that the above-mentioned local currency amounts will actually be available.

3. With regard to SWITZERLAND, TURKEY and EIRE, Italian Government requests permission to finance its diplomatic missions in these countries by drawing on its post-liberation dollar and sterling accounts. In the case of SWITZERLAND, Italian

Plans being laid to send a competent Italian representative to SWITZERLAND to examine the whole situation; until this is done it is recommended that Italian Governments suggestion be followed. Sums requested for these 3 countries and approved by AC: SWITZERLAND - Swiss Franc 327,408 EIRE - Pounds 980 TURKEY - Turkish Pounds 113,843 Plasters 12 TAM 398 provides that dollars and sterling will be drawn on equally. Neither Italian Government nor AC is aware of exact channels that would be used to effect the dollar exchange transfers and therefore Minister of Treasury has requested that entire amounts needed in SWITZERLAND, EIRE, and TURKEY be made available by local currency advances from the American and British Missions, immediate repayment being effected in WASHINGTON and LONDON by debits to Italian post-liberation dollar and sterling accounts. It is recommended that this be adopted as interim procedure, and that if it is desired that the exact procedure specified in TAM 398 be followed you forward information as to what banking channels the Italian Government could use in making dollar remittances to all neutral countries. Unless there are strong reasons to the contrary, it is suggested that the local currency advance procedure be continued, for it would eliminate delays in transfer of American share which might result in double requests to British Missions and other complications.

4. Italian Government has also raised question of financing the Italian Missions in RUMANIA and BULGARIA. Minister of Treasury states that he believes the mission in RUMANIA has sufficient funds at its disposal for the time being. <sup>352</sup> It is expected that an Italian official from RUMANIA will shortly visit ROME and that he will be able to clarify the situation. For BULGARIA the Minister has requested 3,000,000 Leva for January and February. Since BULGARIA is an ex-enemy country and does not

My dear Mr. Prime Minister:

The Directors of the Finance Sub-Commission have recently discussed with H.E. Marcello Soleri, Minister of Treasury, the implications of the news from the north that the manufacture of currency has broken down completely and that Buoni del Tesoro Ordinari are being used as supplementary currency. We feel that it would be eminently desirable, at this time, to take what action we can to relieve the Italian state of the burden of redeeming bonds used as supplementary currency in the north and to increase the difficulty of the Germans and of the Fascist government in financing their operations. We do not propose any attempt to repudiate currency, since it is indistinguishable, except on very close examination, from currency used in liberated Italy.

In order to achieve this purpose, any actual repudiation would have to be effected by AMI officers, but the statement of repudiation must come from your government. We would suggest that the Italian Government give wide publicity, by every means within its power, to an announcement containing, in substance, the following:

"After today the following types of Buoni del Tesoro Ordinari, issued in enemy occupied territory will not be honored:

- (a) All bonds having the face value of 10,000 lire or over, issued since 1 September 1944.
- (b) All bonds on which date of issue and date of maturity are identical.
- (c) All bonds issued in enemy occupied territory after today."

I would appreciate hearing your views on this matter.

SUBJECT: Participation of Italians in International and Economic Organizations

1. I would appreciate it if you could have a memorandum prepared on the possibility and desirability of Italians participating in the International Monetary Fund and the Bank for International Reconstruction.
2. Such a memorandum would be the basis for a request for further information and indications of present thinking in Washington and London on this subject.
3. I assume that a certain amount of thinking has already been done on this subject, both here and in the United States and United Kingdom. It seems to me that Italy is going to need more financial help than is now in sight; therefore, that every avenue of additional funds should be explored. When the Bank for International Reconstruction really "gets off the ground", it may be possible for it to participate in the financing of Category "B" imports into Italy.

Landed cost imported coal. Following is summary of cables CIVVED 13 from TROOPERS and VX 72142 from AQWAN on subject.

In arriving at an approximate landed cost of imported coal which Allied Commission can pass to Italian Govt as a basis on which they can fix internal selling price, the following information is furnished.

(a). A figure of 30 dollars per tons should be used as the estimated US average landed cost of coal furnished by the US Government to ITALY including SICILY for civilian use.

(b). A figure of 115 shillings per tons should be used as the estimated UK average landed cost of coal furnished by the UK to ITALY including SICILY for civilian use.

(c). It is understood that AC/AMG will weigh estimated UK and US landed costs by quantities furnished by US and UK(?) respectively and thus determine an approximate UK/US combined weighted average landed cost for coal to give to Italian Govt for internal pricing purposes only. If this is done AC/AMG should inform the Italian Govt that quoted cost is the best estimate available now and is without prejudice to the price to be charged the Italian Govt when more accurate costs are known.

Of Italian Communists, a man of great ability and intelligence, and believes that Italian leaders of this movement have strong personalities and would remain, therefore, reasonably independent from Moscow. At the same time he believes there is no need to exaggerate the "danger" of Communism in Italy, and particularly the subjection of that party to Moscow. Mattioli affirms that through close economic cooperation between Italy and America, favorable conditions may be created for employment of Italian manpower, thus avoiding the dangers of leftist political movements. Togliatti's participation in the government makes such a danger less likely, he states. He points to the Demo-Christian party as a factor in Italian political life. He believes in political unity, and that the Italian government should be supported by all political parties in its work of reconstruction, and be given an opportunity to reach political-economical-financial agreements with the United States.

4. Mattioli's view on Italian intervention in the war with Japan is that the majority of Italian political parties are in favor of it, but that no decision will be taken until participation in the Pacific war is considered by Italians as a political necessity. He thinks it is wrong to believe that Italy intends to bargain with the Allies, viz., that Italy's intervention in the war against Japan is contingent on her being accepted as an ally. Mattioli believes that Italy's effective participation in the war requires as a prerequisite that Italians first be convinced that intervention would bring them a new status among the United Nations.
5. While in America, Mattioli intends to contact people in authority on matters to be discussed, and others close to President Roosevelt who could advise the President on Italy's urgent needs. Italy's economic conditions make it imperative that his conversations in the United States should succeed. Failure of his mission would in probability cause a tremendous disappoint and moral collapse.

The Swiss will continue temporarily to make such loans to qualified Americans in the other liberated Italian areas north of Rome.

In order to avoid making duplicate payments it would be greatly appreciated if the Finance Officers of the Allied Commission could be requested not to make any further loans in November or in subsequent months to qualified applicants but to refer such applicants to the respective consulates or to the Swiss for this purpose.

A list showing the provinces contained in the Naples, Palermo and Rome consular districts is attached.

In case some November loans have already been made before the notification to discontinue such loans is received, it would be appreciated if a list of the persons receiving such loans showing the names and addresses and the amount of the loan in each case, could be sent to me for the information of the Naples, Palermo and Rome consular offices and of the Swiss representative.

Reference is made to your letter of 27 October 1944 concerning the payments of the Swiss Legation in Washington for the purpose of defraying the expenses of the representation of Italian interests in the United States.

As we originally requested by means of a message from O.S.S. received by us on 16 August 1944 to authorize the release of an amount not to exceed \$5,000 per month for this purpose. This was discussed with the Italian Government which verbally authorized the payment of \$3,000 per month and stated that a request would be made of the Swiss Government for information as to the reason for a need of \$5,000 per month. The payment of \$3,000 per month was authorized on 25 August 1944.

On 3 September 1944 the Political Section A.S.S. delivered to Finance Sub-Commission the paraphrase of the telegram received from the Department of State Washington stating that \$5,000 is needed asking the Department to be informed urgently why \$5,000 had not been authorized.

On 10 September 1944 Finance Sub-Commission notified Political Section that the Italian Government was waiting information from the Swiss Government before authorizing advances of \$5,000 per month.

Two other messages from the Department of State requesting the Italian Government to increase the amount available were delivered by the Political Section to the Finance Sub-Commission on 20 and 27 September. This matter was again discussed with the Italian Government who stated it was still waiting information from the Swiss Government. The Italian Government also requested that the Department of State be asked to inform the Swiss Legation that the Italian Government would appreciate receiving information supporting the need of \$5,000 per month. The Italian Government had not paid the lire counter value of the \$9,000 already remitted although frequent requests were made for repayment by the Finance Sub-Commission.

On 20 October 1944 Mr. Ortona of the Foreign Office delivered to Finance Sub-Commission a letter from the Minister of Treasury dated 13 October 1944 authorising payment of \$5,000 per month beginning from 1 July 1944. This letter, two copies of which were sent to the Ministry of Foreign Affairs, instructed that the Ministry should immediately repay the equivalent amount in lire. The Political Section was notified of this communication on 20 October 1944.

Requests have been daily of the Foreign Office for payment of the lire counter value of the dollars; as yet no payment has been received and no payment order in dollars has been sent.

My dear Mr. Prime Minister,

Reference is made to the recent budget message by Minister of Treasury Soleri. We are in agreement with his conclusions that the time is not propitious for a large loan to attempt to cope with the budget deficit and that despite the serious efforts of the Minister of Finance no substantial increase in revenues can be expected in the near future.

Although we are thus in accord generally that the income of the State cannot be substantially increased in the near future, on the basis of our study of the Italian budget and methods of expenditure control for the past year we do feel that certain adjustments, which can readily be made, should result in savings which to some extent will be effective in ameliorating the present unbalanced condition of the State budget.

On the basis of this study we would like to propose creation of a Cabinet Committee on Economy in State Expenditures and we feel that the following recommendations which are, however, very general in nature merit the serious consideration of such a committee:

- (a) Analysis of the budget discloses the presence of a great number of "enti" which are supported at public expense. It is our feeling that those functions which are properly governmental could probably be better administered by direct governmental agencies. This should enable the Government to consolidate many functions and to abolish many "entee" with the attendant saving. (c) The more or less independent status of State road administration under its old organization has recently been changed and made an integral part of the Government, reporting directly to a member of your Cabinet. We feel that there are comparable situations such as the railways, monopolies, telegraph and telephone systems which might well be studied by an Economy Committee to determine whether these bodies should be made an integral part of the Government as in the case of State roads or should be returned to private ownership. A change in either direction would affect economies in the State administration. In addition it is our feeling that if any of these enterprises were returned to private ownership the taxation yield to the State would exceed so-called profits now accruing to the State.

(d) We feel that the present list of Parastatal Agencies receiving contributions from the State should be re-examined with a view to eliminating those which are not performing governmental functions. We would also suggest such a committee should seriously consider a change in the present method of determining the amount of State contributions so that amounts would be specified by law and not left to the personal judgment by the Minister or some subordinate official.

(e) Throughout the budget we find "Fussidi" being used to make funds available to the head of a State organization in order to give financial assistance to public employees. There appears to be no justification in public administration for this practice and the potential dangers are obvious.

(f) We feel that the practice of making "pro memoria" appropriations/limit and with the understanding that the disbursements will be covered by the post facto appropriations is an open acknowledgment of the lack of adequate thought in the preparation of the budget. We cannot commend too highly the budgetary practice of the Royal Italian Navy in this respect in that they plan their work, dividing the budget request into periods of time corresponding to the periods of the performance of the work so that expenditure control can be exercised throughout the period. The universal application of this procedure throughout the Government is recommended.

(g) We have observed a practice of understating the sum needed in preparing a budget request in reliance on supplementary appropriation at a later date. This invalidates the budget and tends further to fortify the habit which is not peculiar to the Italian Government, of relying on supplementary appropriations which are created without adequate review.

In addition to these very general observations the officers of the Finance Sub-Commission have prepared, as a result of their study, detailed comments on specific "capitoli" of the budget. I should be very glad to make available to any committee you may want to appoint these comments and the services of the officers who prepared them.
