Paragraph 3, AFHQ Administrative Memorandum Number 43, 1945, is rescinded and the following substituted therefor:

" 3 AUTHORITY

(a) Authority is granted to provide food, as set forth herein, during each working period of eight (8) hours or more for Italian civilians, who are:-

1. Workers other than office workers.
2. Office workers.

for the Allied Forces. This authority is applicable to civilians employed directly by the Allied Army, Navy or Air Forces, by contractors on their behalf, or to employees of industry operating for the Allied Forces.

(b) Where employing units have so arranged their working schedules that a forty eight (48) hour week is completed in five and a half (5 1/2) days, the mid-meal or office workers meal may be issued on the half (1/2) day, with the employing unit commander's authority, to all those workers who have completed their forty eight (48) hours"

SUPPLY OF FOOD TO ITALIAN CIVILIANS FROM CIVILIAN STOCKS
(MIDSHIFT MEAL & OFFICE WORKERS' MEAL)

NOTED 9/10

AFHQ Administrative Memorandum Number 30, 1945, is rescinded and the following substituted therefor, effective as of 1 October 1945.

1. Scope - This memorandum supersedes all former directives on the subject with the exception of WFOUSA Circular Number 7, 1945.

2. Applicability - The provisions contained herein are generally applicable throughout ITALY, SICILY and SARDEGNA.

3. Authority - Authority is granted to provide food, as set forth herein, during each working period of eight (8) hours or more for Italian civilians, who are:

- a. Workers other than office workers.
- b. Office workers.

for the Allied Forces. This authority is applicable to civilians employed directly by the Allied Army, Navy or Air Forces, by contractors on their behalf, or to employees of industry operating for the Allied Forces.

4. Responsibility - Where the employee works directly for the Allied Forces, the Army, District, Base Section and Area, or equivalent commanders, will be responsible:

- a. For providing the facilities necessary to prepare and serve meals.
- b. For ensuring that Allied military personnel are not used for this purpose except in a minimum supervisory capacity where other arrangements are not possible.

5. Ration Scales - a. Workers other than office workers - Below are the details of the midshift meal for workers other than office workers:

b. Office Workers - Where considered desirable there may be served on the job a daily issue of a standard meal for office workers, consisting of:

Bread	50 gms (equals 42 gms of flour)
(This may be served in whole or in part as Bread, pasta and/or flour)	
Dried Vegetables	20 gms
Soup	20 gms
Salt	5 gms
Olive Oil (when available)	5 gms

6. Allowances for other than Office Workers - The following personnel will be entitled to food as detailed in paragraph 5 a above:

a. Workers, other than office workers, employed 100% by the Allied Forces either:

- (1) Directly
- (2) By contractors and/or industries who in turn are employed by the Allied Forces.
- (3) Railway Workers other than those employed in offices.

b. Labor employed, other than as stated in paragraph 6 a above is not entitled to any additional food.

c. Office workers are not entitled to the Midshift Meal.

7. Allowances for Office Workers a. The personnel qualifying for the standard meal for office workers, detailed in paragraph 5 b above are office workers employed by the Allied Forces either:

- (1) Directly
- (2) By contractors or industries who in turn are employed 100% by the Allied Forces.

b. All cases of workers claiming entitlement under paragraph a (2) above will be referred to HQ ALCOM Food Sub-Commission for a decision as to eligibility.

8. Issues to Contractors - Issues of food to civilians employed by contractors and industry working for the Allied Forces will be strictly controlled by the employing Service in order to insure that:

- a. Only bona-fide employees are fed.
- b. Food is furnished and distributed on the proper scale.
- c. Food leakages do not occur.

9. Deductions - The Service responsible for placing the contract or arranging for the use of the industry will insure that:

a. Contractors and firms working for the Allied Forces deduct from the wages of their employees the amounts prescribed in paragraph 11 hereof.

b. A deduction is made on invoices rendered equivalent to the deduction from employees wages in respect of food.

10. Provision of Supplies - Responsibility for the provision of supplies is placed as follows:

a. Flour, Dehydrated Soup and Dried Vegetables - The Italian Government is responsible for the provision of flour, dehydrated soup and dried vegetables in territory under its control. In AC/AMG territory this responsibility rests with the Allied Commission. When these items are not immediately available from Italian Government or Allied Commission sources, for their respective territories, they may be supplied from military stocks. In such cases S & T AFHQ, or Quartermaster, MTOUSA will present to HQ ALOC a consolidated monthly total of the amount issued at the scales authorized in paragraph 5 above and Allied Commission will arrange replacement whether the issue was in Italian Government or AC/AMG territory.

b. Items other than flour, dried vegetables and soup (i.e. Fresh vegetables yeast, salt, etc) will be supplied from military stocks. ST AFHQ and Quartermaster MTOUSA, as the case may be, will demand allocation of these items, as applicable, in the normal manner from local resources.

c. The baking of bread, the manufacturing of pasta and the providing of these items to employing units is a service responsibility.

11. Payment a. Midshift Meal (Workers other than Office Workers)

(1) There will be deducted from the daily wages an amount equivalent to the cost of the food furnished as items of the midshift meal.

This amount will be as follows:

11 ozs of Bread (or equivalent combination of bread, pasta and/or flour)	5 lire
6 ozs of fresh vegetables	3 lire
1 oz Dehydrated Soup	1 lire
0.2 ozs Salt	No charge

(2) The whole or any part of the Midshift Meal may be issued at the discretion of the Commanders mentioned in paragraph 4. In all such cases the cost of the components so issued will be as prescribed in sub-paragraph a (1) above.

(3) Every effort must be made to make the full scale ration available where local conditions make it desirable.

b. Standard Meal (Office Workers) - This meal will be furnished at a cost of 5 lire per head per issue, which cost shall be deducted from the employees' wages.

12. Entitlement to Additional Civilian Rations a. Heavy workers will be entitled under civilian economy effective 1 October 1945 to a civilian supplementary ration card authorizing them to purchase the following:

100 gms Bread
20 gms Minestra daily.

or in the case of Miners & Forestry Workers:

400 gms Bread
20 gms Minestra daily.

b. Heavy workers of the Allied Forces are entitled to similar supplementary rations in addition to the midshift meal authorized under paragraph 6 above.

c. To enable employees of the Allied Forces to obtain civilian supplementary ration cards, employing units will issue 'Certificate of Employment' as per Appendices "A" and "B" to all entitled workers on each pay day.

d. All contractors will be responsible for arranging with the local Italian authorities for the issue of civilian supplementary ration cards to their employees in accordance with the instructions issued by the Italian Ministry of Food.

(MIDSHIFT MEAL, OFFICE WORKERS' MEAL AND SUPPLEMENTARY RATION)

AFHQ Administrative Memorandum Number 56, 1944, is rescinded and the following substituted therefor:

1. Scope - This memorandum supersedes all former directives on the subject with the exception of MTOUSA Circular Number 116, 1944, (corrected copy).

2. Applicability - The provisions contained herein are applicable to SICILY, SARDINIA and all portions of the mainland of Italy south of the Army Rear Boundaries. The provisions hereof are applicable within Army Areas as far as operational conditions permit and at the discretion of Army and independent Corps commanders.

3. Authority - Authority is granted to provide food, as set forth herein, during each working period of eight (8) hours or more for Italian civilians, who are:

- a. Workers other than office workers;
- b. Office workers;

for the Allied Forces. This authority is applicable to civilians employed directly by the Allied Army, Naval or Air Forces, by contractors on their behalf, or to employers of industry operating for the Allied Forces.

4. Responsibility - Where the employee works directly for the Allied Forces, the Army, District, Base Section & Area, or equivalent Commanders, will be responsible:

- a. For providing the facilities necessary to prepare and serve meals.
- b. For insuring that Allied military personnel are not used for this purpose except in a minimum supervisory capacity where other arrangements are not possible.
- c. In conjunction with Allied Commission, for effecting proper distribution of supplementary ration cards for purchase of additional food as hereinafter provided.

7. Allowances for Office Workers

a. The personnel qualifying for the standard meal for office workers detailed in paragraph 5b above are office workers employed by the Allied Armed Forces either:

- (1) Directly;
- (2) By contractors for industries who in turn are employed 100% by the Allied Armed Forces.

b. All cases of workers claiming entitlement under paragraph a (2) above will be referred to HQ ALCON for a decision as to eligibility.

Subject: AC Civilian Mess.

1. The Chief Commissioner has directed that a careful investigation be made and report submitted with recommendations relative to making available for the noon-day meal at the AC HQ civilian mess, surplus and left-over foods from the various AC and 2675 Regiment messes in Rome. The following questions are to be considered:

a Under present regulations can such arrangements be made?

b Would it be practical to use any such foods for the augmentation of the civilian mess?

2. The Chief Commissioner requests that this matter be considered urgent.

3. In connection with the civilian mess at HQ AC, recently Economic Section passed a minute to Establishment Section together with Economic Section's file, setting forth a memorandum from Food Sub-Commission as to what supplies Food S/C felt could be bought from SEPRAL. In the minute it was suggested that HQ Commandant contact the Food S/C and complete arrangements for augmenting the mess.

7. Food for Civilian Employees. CCS stated that Col. Henn had rung up from AFHQ and said he was prosecuting the matter. Econ Sec had discussed with P. d Sub-Commission. There was considerable discussion as to whether we should accept any help from a charitable society or whether we should give a better deal from AC resources alone, bearing in mind that any increase in ration over the authorized scale would affect all civilian workers employed by the Allied Services throughout Italy. CCS would ascertain what AFHQ had achieved and would then discuss the matter with CC. Meanwhile, the present arrangement would continue, but the possibility should be examined of converting the present charitable organization into some form of cooperative society.

Conferred with Col. Densmore at length and the position seems to be:

1. The present mid-day meal for office workers is what AFHQ permits, - maximum permitted but no more.
2. This AFHQ Administrative Memo No. 56 of 9 Dec 44 was championed and promoted especially by AC for overall application to Allied civilian workers.
3. If we were to digress from this such as by supplementing one Mess arbitrarily, - and HQ AC specifically, we would be creating a precedent not entirely desirable.
4. Through SEPRAL and Vatican agencies, an arrangement could be worked out by Col. Densmore to make our HQ AC civilian mid-day mess the 390th of the 389 relief supplemental kitchens already functioning in the LAZIO Area and in this way, the meal could be augmented somewhat, up to as much as possibly 110 grams.
5. Augmenting the mid-day meal over all Italy by AFHQ would amount to tons of food to many thousands of workers, which Food S/C is not prepared to endorse or implement at this moment.

SUPPLY OF FOOD TO ITALIAN CIVILIANS FROM CIVILIAN STOCKS
(MIDSHIFT MEAL AND SUPPLEMENTARY RATIONS)

1. SCOPE - This memorandum supersedes all former directives on the subject with the exception of:

- a. HPOUSA Circular Number 116, 1944 (corrected copy).
- b. Hq. AAI Routine Order Number 252, 1944.

2. APPLICABILITY - The provisions contained herein are applicable to Sicily, Sardinia and all portions of the mainland of Italy south of the Army rear boundaries. The provisions hereof are applicable within Army Areas as far as operational conditions permit and at the discretion of Army and independent Corps Commanders.

3. AUTHORITY - Authority is granted to provide food, as set forth herein, during each working period of eight (8) hours or more for Italian Civilians, who are:

- a. Performing heavy labor;
- b. Engaged as office employees;

for the Allied Forces. This authority is applicable to civilians employed directly by the Allied Army, Naval and Air Forces, by contractors on their behalf, or to employees of industry operating for the Allied Forces.

4. RESPONSIBILITY - Where the employee works directly for the Allied Forces, the Army, District, Base Section and Area, or equivalent commanders will be responsible:

- a. For providing the facilities necessary to prepare and serve meals.
- b. For insuring that Allied military personnel are not used for this purpose except in a minimal supervisory capacity where other arrangements are not possible.

c. In conjunction with Allied Commission, for effecting proper disposition of supplementary ration cards for purchase of additional food as hereinafter provided.

5. RATION SCALES

a. Heavy Workers - Because of the two basic Ration Scales for civilians now applicable in Italy, it is necessary to have two civilian scales for the Midshift Meal and Supplemental Rations. These have been calculated so that the sum of the Basic Scale plus Supplemental Rations is the same irrespective of the part of Italy in which the worker is employed. Below are the details for Midshift Meal and Supplemental Rations for:

- (1) NORTHERN AREA+ - NORTH of the NORTHERN Boundaries of the provinces of CAMPOBASSO and NAPLES and SOUTH of the rear boundaries of ARMIES.
- (2) SOUTHERN AREA - SICILY, SARDINIA and the mainland of ITALY, SOUTH of the NORTHERN Boundaries of the provinces of CAMPOBASSO and NAPLES.

b. Office Workers - Where considered desirable, there may be served on the job a daily issue of minestrone soup consisting of:

- Dehydrated - 28 grms
- Dehydrated Vegetables - 28 grms
(interchangeable with fresh vegetables if available)

and a lesser quantity of such items as may be in excess local supplies to make up a total of approximately 70/75 grms. of ingredients per head.

6. ALLOWANCES FOR HEAVY WORKERS - The following personnel will be entitled to food and supplemental ration cards according to Scale "1" and "2" detailed in paragraph 5a above:

a. Scale "1" - For labor engaged on heavy work employed by the Allied Armed Forces either:

- (1) Directly;
- (2) By contractors and / or industries who in turn are employed 100% by the Allied Armed Forces;
- (3) Heavy railway workers.

b. Scale "2"

(1) For labor engaged on heavy work employed by contractors who are employed less than 100% by the Allied Armed Forces, e.g. Public Utilities.

(2) Labor employed on heavy work for the war effort other than that in a and b (1) above.

c. Each case of heavy workers claiming entitlement to Scale "2" rations will be presented to Hq ALCOM for a decision as to whether they will receive the entire "2" ration scale or any portion thereof. Determining this ALCOM will be guided by the following priorities:

Priority I - Public Service Workers in electric power, gas, water and communications.

Priority II - Heavy workers employed by other contractors working less than 100% for the Allied Armed Forces.

d. Labor employed, other than stated in paragraphs 6a and b above is not entitled to any other additional food or supplemental ration cards.

e. Office workers are NOT entitled to either Scale "1" or "2" rations.

7. ALLOWANCES FOR OFFICE WORKERS

a. The personnel qualifying for the daily issue of soup doled in paragraph 5b above are office workers employed by the Allied Armed Forces either:

- (1) Directly;
- (2) Or by contractors for industries who in turn are employed 100% by the Allied Armed Forces.

b. All cases of workers claiming entitlement under paragraph a (2) above will be referred to Hq ALCOM for a decision as to eligibility.

8. ISSUES TO CONTRACTORS - Issues of food and supplemental ration cards to civilians employed by contractors and industry working for the Allied Armed Forces will be strictly controlled by the employing services in order to insure that:

- a. Only bona fide employees are fed;
- b. Food is furnished and supplemental ration cards are distributed on the proper scale;
- c. Food leakages do not exist.

9. DEDUCTIONS - The service responsible for placing the control or arranging for the use of industry will also insure that:

- a. Contractors and firms working for the Allied Armed Forces deduct from the wages of their employees the amounts prescribed in paragraph 11 hereof.
- b. A deduction is made on invoices rendered equivalent to the deduction from employees wages in respect of food.

10. PROVISION OF SUPPLIES - Responsibility for provision of supplies is placed as follows:

a. Nightshift Meal for Heavy Workers and Soups for Office Employees:

(1) Allied Commission is responsible for the provision of flour, dehydrated soup and dehydrated vegetables. When these are not immediately available from Allied Commission sources, they may be supplied from military stocks. In this case, organizations involved will present to Hq AECOM a consolidated monthly total of the amount issued and Allied Commission will arrange replacement.

(2) Other ingredients will be supplied from military stocks. Organizations involved will demand allocation of these items, as applicable, from local resources in the normal manner.

(3) The baking of bread is the responsibility of the employing service.

b. Supplementary Ration - The supply to the normal civilian channel of the R.R. constituting the supplementary ration is the responsibility of Allied Commission.

11. PAYMENT

a. Nightshift Meal (Heavy Workers)

(1) There will be deducted from daily wages an amount equivalent to the cost of the food furnished as items of the nightshift meal. This amount will be as follows:

1/3 lb Bread	2 lire
6 ozs Fresh Vegetables	4 lire
0.8 ozs Dehydrated Soup	1 lire
0.2 ozs Salt	no charge

(2) The whole or any part of the nightshift meal may be issued at the discretion of the Commanders referred to in paragraph 4. In all such cases the cost of the components so issued will be as prescribed in sub-paragraph a (1) above.

(3) Every effort must be made to make the full scale ration available where local conditions make it desirable.

b. Minestrone Soup (Office Workers) - The soup will be furnished at a cost of 2 lire per head per issue, which cost shall be deducted from the employees wages.

1. Reference attached

- a) ltr 3 Jan 45, ref B.04/ES, from Col. Denmore to Food S/C, with attachments (1)
- b) memo 4 Jan 45, Ref 43-3/ / Food, to Col. Denmore from Col. Legg. (2)

2. The Chief Commissioner was very much disturbed this morning at the Vice Presidents' meeting when I reported that in order to solve the situation with respect to providing a proper meal for employees of HQ, AC, we were working with ONAMRO. He expressed his appreciation for the willingness of the Church organization to assist but felt that it was unfair to use their resources for employees of the Allied Forces.

3. Would you please indicate to me just what contribution ONAMRO will make and the part we will play in the matter?

4. The Chief Commissioner is most desirous that the food be obtained from Allied sources or from imported civilian supplies, if this is at all possible. He had directed the Chief of Staff to write a strong letter to AFHQ with respect to AFHQ Administrative Memo. #56 of 9 Dec 44 which provides that office personnel will receive only dehydrated vegetables and soup powder.

5. The Chief Commissioner has indicated that while he does not want to turn to ONAMRO in order to provide the meal for HQ AC civilian employees, yet he will not deny the employees such assistance. It appears that our inability to provide is due to the AFHQ directive and the extreme tightness of the supply situation and availability of miscellaneous supplies.

FROM : Director, Food Sub-Commission.

TO : Col. L.D. Demore, ADCOS, Economic Section.

1. Reference LDD/es, of 3 January, 1945, for immediate action.
2. Para. 3 of the above noted letter refers, namely: "Can any food supplies be made available by Food Sub-Commission from imported civilian stocks with the suggestion of HQ. A.S. Indian Civilian mess?" The extreme tightness of the supply situation and availability of miscellaneous supplies from imported stocks precludes any material contribution from this source. Resources, therefore, has to be made to the local organization which provides a measure of subsistence for civilian messes. With a view to ascertaining the degree of assistance which could be provided, a meeting with the USABMG officials was held at 0900 hours today, 4 January. Sig. Baidelli of this organization stated that it would be possible to organize an employees' mess at this headquarters and that his organization could provide certain basic commodities which, with the contribution now being made to the soup meal, and supplemented by local purchase, that he thought that a satisfactory solution could be found. Assistant Wg. Commandant and Quartermaster were present at this meeting and arrangements have been made for a further meeting to take place tomorrow, 5 January, to further pursue the project.
