Reference policy outlined in FAN 536 paras 1 to 5 following sent after consultation with BENSON. Consider it necessary provide for additional provincial officers for VENEZIA GIULIA and frontier province UDINE also called FRIULI. Present estimate 23 additional officers required bringing total regional establishment to 88 provincial officers. Up to date 40 provincial officers have reported to this Region for duty. Understand 8 ARMY spearhead officers going to AUSTRIA will probably be withdrawn for concentration in 14 days by which time operations FAN 536 will be in progress. Position is therefore urgent. Consider that proportion of extra officers could be semi-trained as could use in dilution in other provinces releasing trained officers for frontier. Majority should if possible be Americans to restore present unbalanced composition Region. Gled to welcome staff officer from your HQ for discussion. HQ opens ABBNO south of PAVIA 5 or 6 May dependent on move of MAIN 8 ARMY.

It cannot be determined at present for how long this situation will exist and it will be necessary to keep these officers temporarily attached to the truck pools until a disposition has been made. These officers have not been ordered to report to their regions as yet pending authority from the Executive Commissioner to remain at their post.

2. Meeting held with object of ascertaining the means by which additional personnel and transport for D.P.R.S.C. commitments in Northern Italy can be obtained.

G-5 Section had received letter IPA/1 dated 10 April, 1945, from Acting Executive Commissioner, A.C., stating that the requirements in transportation for the operation of the D.P.R.S.C. in Northern Italy are far beyond the powers of the present ceiling of the Allied Commission to provide and that it is necessary that an increase of A.C. W.B./I.L. for transport be authorised for allotment to the D.P.R.S.C.

Letter G-1B/11/1 stating the personnel requirements for D.P.R.S.C. was handed to Brigadier Henn.

4. Total additional requirements for D.P.R.S.C. for Northern Italy asked for in these letters was:-

5. Discussion centered around whether Allied Commission could supply additional personnel and transport. Representatives of G-1 (B) and G-4 (B) and (A) were emphatic that the additional personnel and transport were NOT available from Allied Commission. Brigadier Henn emphasised that these increased demands above present A.C. ceiling would probably result in GHQ Org. asking A.C. to justify present and future allotment of personnel within Allied Commission. The method by which transport should be held and accounted for by A.C. was discussed and how additional transport issued to A.C. for D.P.R.S.C. would count against a general over all holding of A.C. (i.e. proportion between British and American).

It was clear that no immediate action would result from new war establishments which are bound to take months to be sanctioned.

6. Brigadier Henn asked if D.P.R.S.C. would consider the adoption of the three proposed standard units for personnel and transport for Austria (BRITISH) which were to be considered by WEC on 13 April. It was considered that this might provide the quickest solution to the problem. He asked a small committee with Major Driffield-White as chairman to study the question and for D.P.R.S.C. to express an opinion whether these standard units would answer their demands for personnel and transport.

7. These standard units were carefully studied as to how they could be fitted into the D.P.R.S.C. Northern Italy Plan. It was decided that they would be suitable and that D.P.R.S.C. would make the necessary demands with modifications.

The personnel and transport would be attached to Allied Commission for work with D.P.R.S.C.

8. The following major points came out during the discussions:-

(a) The proposed standard Austrian Unit, when approved by W.E.C. will be a complete and separate unit, having its own War Establishment of personnel, transport and G 1098. The status of this staff will be that of a regimental unit under control G-1 (E), A.F.H.Q. These personnel are not interchangeable between units without competent posting orders from A.F.H.Q.

(b) The possibility that the application for these Units may result in G III Org., A.F.H.Q. calling on A.C. to justify present allotment of personnel and definite statement showing that no personnel or transport are available to fulfill D.P.R.S.C. requirements.

(c) Representatives G-1 and G-4, Allied Commission were requested to present over all requirements of A.C. for ITALY including D.P.R.S.C. requirements.

9. In conclusion, the results of these conversations indicate that for the Allied Commission to carry out those responsibilities concerning refugees, displaced persons and repatriates, a responsibility delegated to A.C. by A.F.H.Q.; it is of paramount importance that the Allied Commission presents its over all requirements for ITALY without delay.

Unless this is done there appears little possibility of personnel and transport being allotted to this Sub-Commission.

Transportation Sub-Commission Officers - Northern Italy

1. When AC/AMG take over in N.W. Italy, it is proposed to establish an Advanced Echelon of the Transportation Sub-Commission. Its duties will be as follows:

a. To coordinate, on behalf of the Director of the Transportation Sub-Commission, movements and transportation work in the regions of Piemonte, Liguria, Lombardia, and such other provinces as may be considered as "N.W. Italy" from time to time.

b. To coordinate movements and transportation work with the military authorities.

c. To control the general distribution of AC and civilian transport in N.W. Italy.

d. To see that movements programs are carried out in accordance with established priorities, particularly programs affecting more than one region.

2. a. Regional Transportation Officers will arrange all local movement within N.W. Italy as far as possible from their own local resources; they will contact each other as necessary; and they will also work closely with military movement officers.

b. Demands for local movement within the N.W. area that cannot be met as outlined in (a) above and movement to or from places outside N.W. Italy will be referred to the Advanced Echelon of the Transportation Sub-Commission, who will try to meet such demands (1) by adjustment of AC controlled capacity, (2) by further contact with military movement headquarters in N.W. Italy, and (3) by reference to Transportation Sub-Commission, Rome.

1. Attached hereto at Appx "A", "B" are suggested increases in personnel of Allied Commission for the specific purpose of employment with the Displaced Persons and Repatriation Sub Commission and War Materials Disposal and Italian Prisoners of War Sub Commission.
2. The requirements in officers for the operation of the Displaced Persons and Repatriation Sub Commission centres in Northern Italy are far beyond the powers of the existing TO/RS of the Allied Commission to supply and it is considered that additional personnel will be necessary to enable this Sub Commission to carry out its commitments which are detailed at Appx "A".
3. The Allied personnel requested by the War Materials Disposal and Italian Prisoners of War Sub Commission is required to control and coordinate the Italian Military Staff at all main centres and to have a Liaison Officer at each Group H.Q. who will be in control of all centres in each Group area; they will also be responsible for the arrangement of movement of Italian Prisoners of War to the rear area, Depots and, in many instances, their homes. It is estimated that the minimum number of personnel required for this purpose is 20 officers and 40 ORs, i.e., 1 Officer and 2 ORs for each of the main centres (14) and 1 officer and 2 ORs to each H.Q. (6).
4. It is possible that some or all of these personnel could be made available from Replacement Centres and Depots to be attached on a temporary basis to the Allied Commission to work under the Sub Commissions concerned. May this, please, be considered?
5. The alternative to the suggestion in para 4 above would be an application for an increase in the TO/RS of the Allied Commission but as the tasks to be performed might very reasonably be considered more of a military commitment than one for the Allied Commission, the urgency would be met more readily by the adoption of the first suggestion.

Extract of Minutes of Chief of Staff's Meeting held on 9 February 1945.

Personnel. COS had got out a new paper on withdrawal from the South, which would leave 42 officers in Southern Italy, Sicily and Sardinia. Of these, 34 were AMG officers in Naples Commune and 2 AMG officers in Pantelleria and Lampedusa. Some of the balance of 6 officers would only be there for a limited period. COS ruled that the 5 officers at Civitavecchia would come under Econ Sec.

He said he would discuss the whole subject of withdrawal from the South with Gen. Robertson to-day and said we must consider the repercussions on the military and must warn AMG that the Italians will have heavy additional responsibilities. COS said he would try and persuade AMG to remove the Area HQ from Sicily.

Est Sec thought that a Military directive was required dealing with direct requisitioning and declaring martial law in Italian Government territory. COS instructed Land Forces Sub-Commission to make their recommendations on this.

COS said that the posting of officers for Northern Regions was nearly complete. There was a tendency for everyone to target Toscana, Emilia and Abruzzi-Marche Regions. We must avoid that. He asked Est Sec to examine the possibility of moving Piemonte Region HQ to Siena as Regional and Area HQs should be together. Lombardia Region should collect in Rome after Lazio-Umbria Region had gone on 1 March and this would leave only Liguria Region at Chiavari. COS directed his Office to find out which Area was to be in Liguria.

As regards Austria, Est Sec said we were definitely committed to 100 American officers. Austria must be treated as one of the Northern Regions in matters of personnel.
