Subject: Allied Soldier's Assistance in Recovery of Stolen Mail.

To : Chief of Staff ✓
Executive Commissioner's Office.

1. The Minister of Posts and Telecommunications has reported that on the afternoon of 30th August 1946, on the Via Casilina, some unknown thieves broke the rear sliding-window of a Postal motor vehicle, abstracted a sack of Postal packets containing valuables, and then absconded in a motor-car which was waiting nearby.

2. The Postal Agent of the motor vehicle, intent on recovering the sack of mail asked an Allied soldier who was passing in a "Truck 1/4 ton 4x4 G & R" to help him, and with this soldier they pursued the car containing the thieves. When it was noticeable that the car would easily be overtaken, the thieves fearing capture threw the sack of mail into the roadway. The car was not pursued further.

3. The items in the bag were checked with the relative advices and nothing was missing nor had any item been opened.

4. The Minister in expressing his thanks to the Allied Commission states that he is certain, that the successful recovery of the mail must be mainly attributed to the prompt help of the unknown Allied soldier, thereby saving the Postal Administration a large amount of money which would have been due to be paid in compensation had the letters been lost.

5. No further details are available locally to assist in tracing the soldier who gave such valuable and prompt assistance.

6. In the circumstances will you please say if the matter should now be regarded as closed or whether it would be the Chief Commissioner's decision to forward the details to A.F.H.Q. requesting that the particulars be inserted in such routine orders which would circulate to all Units in the theatre.

1. Reference is made to your memorandum dated 3rd October 1945 giving paraphrase of telegram received from ANPOLAD Caserta dated 2nd October 1945.

2. The position as stated by G-5 : AFHQ was correct but the difficulties listed have been largely overcome in the last few days.

3. The following points still remain to be settled before the gift parcel service from U.S.A. can be extended, not only to Italian Government Territory, but to all Italy (except Venezia Giulia) with an increased weight limit of 5 Kilograms, (11 lb):-

(a) Agreement by U.S. Postal Administration to divide parcels into Provincial Sections and to address the relative bags to the appropriate Provincial Capital. (Mat 923 dated 3rd October refers).

(b) Proposed transfer of Foreign Censorship Section from Post Office Sorting Office Naples Railway Station, to 61 Via Medina. (P.6.203/CS dated 3rd October 1945 addressed G-5 : AFHQ refers).

(c) Additional allocation of petrol for EMBSEI vehicles for use in transporting mails from Civil Port to Railway Station and Sorting Office on days immediately following arrival of parcel mails from U.S.A. (P.23.215/CS dated 29th September 1945 addressed Minister Posts and Telecommunications para 4 refers. Request for estimate of additional postal). (P.23.223/CS dated 5th October 1945 addressed G-5 : AFHQ refers. Without awaiting receipt of estimate request whether on a matter of policy an additional allocation would be granted for this purpose).

4. It is believed that settlement of these points does not present any great problem and anything you can do to assist expediting favourable action by the agencies involved will be appreciated.

THE AMBASSADOR of the United States of America has the honor to refer to the Note of the Ministry of Foreign Affairs dated January 4, 1945, in which permission is requested for the shipment of relief parcels by Italian prisoners of war and members of the Italian Service Units held in the continental United States to their families in Italy.

The Ambassador is happy to inform the Minister of Foreign Affairs that, according to instructions recently received from the Department of State, arrangements have now been completed whereby Italian prisoners of war and members of the Italian Service Units, held in the continental United States, may request the International Committee of the Red Cross to send ordinary unregistered and uninsured gift packages by parcel post to civilians at Rome, Vatican City, Naples and Palermo. These gift packages will be limited to relief items, with a total value of not more than \$25.00. Only one package per calendar month may be transmitted at the request of the same sender.

1. The Decrees governing Postal and Telecommunication Rates in Italy were not amongst those listed in AC/4010/9/L "Economic Decrees" of 30 April 1945 and the relative Special Order published in the supplement to the Gazzetta Ufficiale No. 51 of 28th April 1945. They would, therefore, normally be due for application in Military Government territory, except Venezia Giulia, on the dates on which the Gazzette Ufficiali including the relative implementation orders reached the Prefects of each Province concerned. As the services concerned are interprovincial it would, however, be impracticable to implement the Decrees on different dates and the 1st July 1945 will, therefore, be the date on which the rates laid down in the Decrees become effective, with the exception of the Decree covering Foreign Postage which is already being applied.

3. The Post Office publications in which the above Decrees are detailed are as follows:-

4. It is important for full publicity to be given to the increases of Postal rates both in the newspapers and on the radio. Publicity should of course be given to increases in Telegraph and Telephone Rates, but need is not so great as for Postal Rates. Care will no doubt be taken to ensure that any notices prepared for exhibition to the public concerning the new rates do not contain references to any services which are suspended. The attention of the Post Office staff should be drawn to the fact that the Supplement to Bollettino No. 6 shows the authorised rates for all the normal services, but that this does not imply the resumption of any services not specifically authorised.

POSTAL SERVICES

Executive Memorandum No. 35 of 1st March, 1944 is hereby cancelled and the following is substituted therefor.

1. In order that Postal Services introduced in Allied Military Government (A.M.G.) territory shall be on a uniform basis, the following instructions will be observed.
2. All postal services are normally suspended when areas are liberated and correspondence in course of post must be held at the disposal of Censorship.
3. Post Office Provincial Directors will be instructed to "freeze" and record all postage stamps and other "carte valori" on hand at Post Offices. In particular postage stamps of the Republican Government will not be sold. A "Guide to the restoration of Postal Services", which contains instructions to Provincial Directors as to the work necessary prior to such restoration, is issued by the Communications Sub-Commission.

4. Post Office Financial Services.  
It is usually necessary to restore certain of these services on a local or provincial basis prior to the re-introduction of postal deliveries. Relative instructions are contained in Executive Memorandum No. 36 and the Guide referred to in para. 3 above.

When Post Offices have been opened for Financial Services, Provincial Commissioners may authorize mail from Italian Prisoners of War and International Red Cross Committee Messages received through A.A.C. channels to be distributed. A Post Office in the Province for delivery to "callers". A house to house delivery by postmen of such correspondence is not usually permitted for reasons of Security at this stage. Correspondence addressed to Prisoners of War and International Red Cross Committee Messages posted at Post Offices in the Province should be made up in packets or bags containing only such items and addressed to the Allied Censor Control Officer at the Provincial Capital. The bags or packets may be conveyed to the Provincial Capital by the same means as are used for the conveyance of documents relating to the Financial Services. If there is no Allied Censor Control Officer at the Provincial Capital the Communications Sub-Commission should be consulted as to the appropriate address for these P.W. despatches.

6. Local Services.  
Except in the case of the largest towns it is rarely worth while introducing a local postal delivery service, prior to the restoration of ordinary postal services. If such a service is proposed and the agreement of the Security and Censorship authorities has been obtained it should normally be confined to a collection and delivery of postcards within the Provincial

Capital and possibly other large towns in the Province. Notices should be printed and exhibited in advance of the opening date. The rate of postage for a service of this kind is the current rate for local delivery in force in Italian Government territory and should be verified at the time.

7. Exceptional Post-card service to largest cities.  
 In order to satisfy the natural desire for news of relatives and to remove excuses for the large amount of illicit travel and conveyance of communications which often follows the liberation of a large city, agreement in principle has been obtained to a 25 word postcard service with the rest of Liberated Italy (where postal services are in operation) being opened in the following places as soon as possible after their liberation:-  
 Bologna, Genoa, Milan, Turin, Verona, Venice.  
 15 Army Group will advise the Allied Commission and Army concerned when such services can commence. The Postal Officer of the Region concerned will visit the city as early as possible to make the technical arrangements relating to the service.
8. Restoration of Postal Service with other Provinces.  
 The restoration of ordinary postal communications between the Province concerned and other parts of Italy where postal services are in operation requires the approval of 15 Army Group which must be sought through Communications Sub-Commission.
9. International Posts.  
 No steps will be taken locally in connection with the introduction of foreign posts. All arrangements will be made and the relative instructions issued by AC. HQ. Normally the Foreign mail service is resumed at the same time as ordinary postal communication with the Italian system is restored.
10. Transport Contracts.  
 If, in connection with the introduction of internal mail, it is necessary to fix new contracts with private firms for the conveyance of mails, such contracts should only be placed after full discussion with the Provincial Directorate and should be on short-term basis (say three months), with Post Office option to cancel or renew.

12. Delivery Agencies.  
Prior to the war certain classes of correspondence could be delivered by authorized agencies other than the State Postal Monopoly, upon payment of appropriate fees. For censorship and security reasons steps must be taken to prevent the operation of such agencies for the collection and delivery of correspondence. They may, however, be permitted to act independently of the Post Office, as agents for publishers, and deliver daily newspapers and the like.

As from 29th April the external civil mail service from Italy will be extended to the following countries:-  
Belgium, Bulgaria, France, Greece (including Crete), Roumania.  
Private postcards and letters up to 40 grammes in weight will be admitted but -as in the case of existing services to other countries (except U.K. and U.S.A.)- commercial correspondence is not at present permitted. Any Italian civilians requiring further information on this subject should be referred to civil Post Offices where notices giving details of censorship regulations, postage rates, etc. are exhibited.

A Guide to the restoration of Postal Services, which contains instructions to Provincial Directors as to the work necessary prior to such restoration, is issued by the Communications Sub-Commission.

4. Post Office Financial Services.

It is usually necessary to restore certain of these services on a local or provincial basis prior to the reintroduction of postal deliveries. Relative instructions are contained in Executive Memorandum No. 36 and the Guide referred to in para. 2 above.

5. Prisoner of War correspondence and International Red Cross Messages.

When Post Offices have been opened for Financial Services, Provincial Commissioners may authorize mail from Italian Prisoners of War and I.R.C.C. Messages received through A.M.G. channels to be distributed to Post Offices in the Province for delivery to "callers". A house to house delivery by postmen of such correspondence is not usually permitted by Security at this stage. Correspondence addressed to Prisoners of War and I.R.C.C. Messages posted at Post Offices in the Province should be made up in packets or bags containing only such items and addressed to the Allied Censor Control Officer at the Provincial Capital. 6. Local Services.  
Except in the case of the largest towns it is rarely worth while introducing a local postal delivery service, prior to the restoration of ordinary postal services. If such a service is proposed and ~~agreed~~ <sup>agreed</sup> Censorship agreement has been obtained it should normally be confined to a collection and delivery of postcards within the Provincial Capital and possibly other large towns in the Province. Notices should be printed and exhibited in advance of the opening date. The rates of postage for a service of this kind is the current rate for local delivery in force in Italian Government territory and should be verified at the time.

6.7. Exceptional Post-card service to largest cities.  
In order to satisfy the natural desire for news of relatives and to remove excuses for the large amount of illicit travel and conveyance of communications which often follows the liberation of a large city, agreement in principle has been obtained to a 25 word postcard service with the rest of liberated Italy (where postal services are in operation) being opened in the following places as soon as possible after their liberation:-  
Bologna, Genoa, Milan, Turin, Verona, Venice.

15th Army Group will advise the Allied Commission and Army concerned when such services can commence. The Postal Officer of the Region concerned will visit the city as early as possible to make the technical arrangements relating to the service.

Resumption of postal services.

1. You are authorized to permit the resumption of external postal services in your Theater:

- a. In occupied territory after securing CCS approval through CCAC;
- b. In liberated territory after securing CCS approval through CCAC, for the transmission of communications of a commercial or financial nature;
- c. In liberated territory, for other than communications of a commercial or financial nature, after submission of the proposal to the CCS, through CCAC, for information at least 10 days prior to the resumption date.

2. In all cases mentioned in paragraph 1 details concerning the resumption shall be submitted to the CCS, through CCAC, including the following:

- a. Provinces of liberated or occupied territory to be

- b. Countries to and from which the services are to operate.
- c. Countries for which closed mails are to be made up.
- d. Services to be operated (for instance, type of correspondence, air mail, money order, parcel post etcetera).

- g. Any other security restrictions imposed by censors.
- h. Proposed routing and method of transportation of mails.
- i. Office of exchange (that is, offices selected for handling International Mail).
- j. Stamps to be used.
- k. Postage rates.
- l. Proposed resumption date.
- m. Any separate arrangements for Prisoners of War etcetera mail.

3. You are authorized to extend a particular type of service to additional territory in a country once resumption of that type of service in a portion of the same country has been authorized. Notice of the details of such intended extension shall be reported to the CCS, through CCAC, at least 10 days prior to the extension date.

4. In all cases earliest possible steps consonant with Military security will be taken to permit resumption of normal postal relationships between the postal administration of the occupied or liberated territory of EUROPE, and the postal administrations of other countries.

1. As notified yesterday by telephone:

a. The view of the Italian Postal authorities - which we support - is that conditions make it entirely impracticable to consider opening a parcel service at the outset to more than Rome, Naples, Palermo and the Vatican State.

b. Present accommodation for storage of transit parcel mails, and sorting of parcels for delivery, is practically non-existent at Naples, due to requisitioning of and damage to normally used premises.

c. Present road and rail facilities for carrying parcel mails from Naples (the disembarkation point) to Rome are inadequate.

d. Adequate road transportation from Naples docks to a transit store, sorting office, and rail loading point (for Rome), or for making deliveries of parcels in the three cities concerned, is not available.

e. The Italian postal authorities however, generally agree that if the accommodation and main transportation deficiencies can be made good, and if actual delivery of the parcels is, if necessary, made only to callers, (who would be notified postcard) a restricted service could be operated.

2. The very short time which has been available to consider this question has not of course enabled any details to be collected. It is proposed to send an Officer of this Sub-Commission to Naples to make the necessary enquiries, and then to discuss with you the special steps which will undoubtedly have to be taken to meet the accommodation and/or transportation position.

3. It is understood that in cabling Washington 329 will cover this general position, and indicate:

1. That separate despatches will be required for each of

the four destinations.

- ii. That unless quite impracticable, the PALERMO mail should be shipped there direct
- iii. That bags should be labelled direct to the civil post Office (i.e.: - Civil mail; New York to \_\_\_\_\_).
- iv. That the U.S. Post Office should impose all such safeguards as are possible to ensure that the restriction on postings which they have suggested, and which is regarded as essential, is not side-stepped.

4. The matters of Italian customs charges, which would normally arise, and postage credits, are being enquired into and will be reported upon later.

5. The attitude of the British Post Office towards the territorial restriction on postings is fully recognised, but the Italian Government are reluctantly apprehensive of any extension of the internal or external operating areas until the outcome of an initial restricted service can be seen.

6. The introduction of even a restricted internal parcel post service is not intended by the Italian Government at the present time.

You will note that this now gives full release as far as the military authorities are concerned on long-distance telephone service from Rome; the previous restriction to defined essential subscribers is therefore removed and any limitations required to be enforced by lack of adequate facilities are now at your discretion.

1. Reference is made to the attached copy of A.A.I. letter 1401/12/431.(b) of Oct. 10th, concerning in proposals for the establishment of a special advance postcard service for civilians in certain of the larger cities not yet liberated.

2. The necessary arrangements will be the responsibility of the Regional Postal Officer. This officer will need to visit the places concerned at the earliest possible moment after Allied occupation.

3. An early visit by the Regional Postal Officer to these and other Provincial capitals has also been shown to be desirable to ensure that Civil Post Office and Sorting Office accommodation is not taken over for other purposes without due regard to future civil requirements and that Postal operating supplies and equipment are not unnecessarily disturbed. This is particularly necessary as these officers are not represented in Army A.M.G., as are most A.C.C. interests.

4. Taking these circumstances into account it is therefore requested that you arrange for Regional Postal Officers to be afforded early visiting authority, in particular for the places mentioned in the A.A.I. letter.

5. Regional Commissioners and Postal Officers concerned will be advised from this headquarters of these arrangements.

In this way all concerned can be informed of the decision without delay. I
