IN CAL SHORAK 6, IT WAS REQUESTED THAT TALK OF LAVA RPT TALK OF LAVA TYPE BE CUT
INTO PRISMS. MATERIAL ARRIVED RECENTLY OF QUALITY SIMILAR TO DELIVERED BEFORE WAR.
HOWEVER, BOULDERS WHICH WERE STORED IN CASKS, WERE OF GRADE TYPE SAVED THROUGH CRACK.
SMALL UNUSABLE FRAGMENTS OCCUPIED THE SPACES WHICH REMAINED.

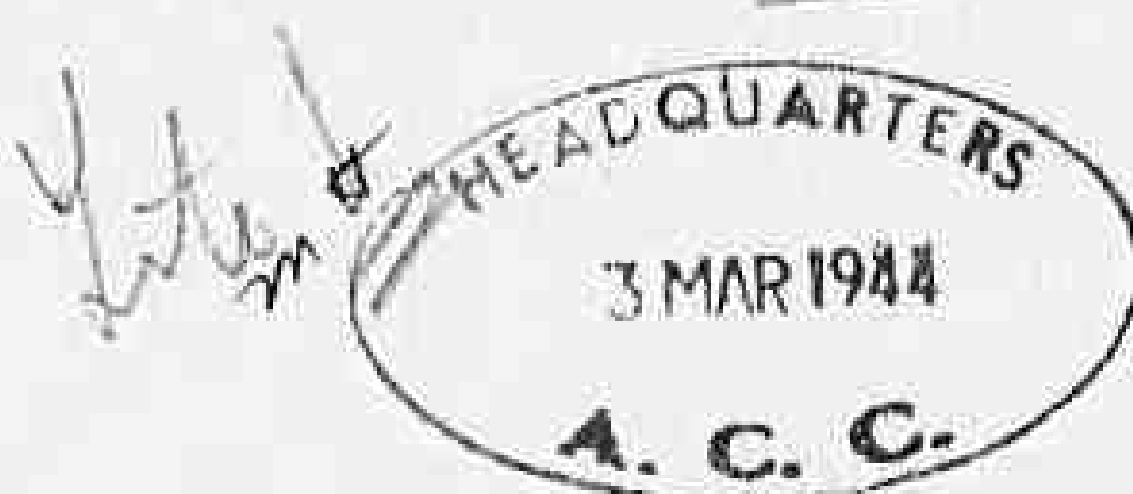
