FROM: Evacuees from THERESI

TO: HQ, Region V

1. This Sub-Commission has been advised by HQ and AG Section that you are ready for the return of the 2,000 evacuees sent to "King's Italy" in January and February.

2. The matter has been taken up with the Minister of the Interior, who states as follows;

- (a) that the evacuees are at present placed in various communes in the provinces of Bari, Brindisi, Lecce, Taranto, and Matera;
- (b) that their return to THERESI will be organized by the Ministry;
- (c) that the Ministry are in process of compiling detailed lists of the evacuees;
- (d) that the return will be effected in stages;
- (e) that arrangements have already been made with the railway authorities for carriages reserved for the evacuees to be attached to trains from BARI to THERESI;
- (f) that special permits from AGC will be required before the evacuees in Bari province can be moved;
- (g) that the movement back of the evacuees should be completed at the latest within 20 days.

3. The question of permits as at 2(f) above, will presumably be settled between you and HQ, Region II.

4. Further details will be obtained and forwarded to you as soon as available.

1. Sometime ago a portion of the town of Termoli was evacuated on operational grounds, it being understood that at a later date the need for this evacuation could cease and inhabitants return.

2. At the time of course, Termoli was in the Eighth Army area. I spoke to B.G.S. and G (Plans) regarding the question of allowing civilians to return and was informed that Eighth Army thought that it would probably be alright now, but that they having now given up the area, it would be as well to obtain permission from A.A.I.

3. I would be glad if someone could see the B.G.S. of A.A.I. and obtain the necessary clearance.
