SUBJECT: Evacuation to Italy of Yugoslav Refugees

from the Island of RAB.



1. In November 1943 the War Department informed this Headquarters that the Yugoslav Government (understood to be the Royal Yugoslav Government outside Yugoslavia) had approached the State Department with an enquiry as to whether steps could be taken to arrange for the evacuation to Italy of 4,000 refugees from the Island of RAB. These refugees were reported to have been released from internment camps by the Partisan forces.

The matter had been referred previously by Washington to the Intergovernmental Committee on Refugees in London and two possibilities were suggested, viz -

- (a) Direct evacuation under Allied arrangements for concentration at Bari.
- (b) Failing direct assistance by the Allies, provision of funds so that refugees could make their own arrangements to hire boats to carry them to the Italian Mainland.
- 2. In view of conditions then prevailing in Italy, particularly with regard to the Displaced Persons Sub-Commission, it was not considered advisable to facilitate the evacuation of these persons and the War Department were accordingly informed to that effect. At the same time enquiry was made of the Allied Control Commission (Brindisi) to discover the then latest information regarding refugees on the island. (Our cable 4726 of 23 November and your 1156 of 27 November refer).
- 3. The matter has now been reopened by the Combined Chiefs of Staffs with the suggestion that the evacuation of these refugees should be effected, and that the Partisan Headquarters should be assisted to carry this out by the



also appreciated that it would be most difficult to arrange for financial compensation to be made to those to whom it was due otherwise than at BARI.

- 6. Pending receipt of information from the Partisan Headquarters as to whether the plans suggested are acceptable to Marshal Tito the following advance directions are issued for your guidance. These directions are applicable only to refugees who may be evacuated from the Island of RAB.
- (a) AFA are authorised to advance the necessary funds to the Displaced Persons Sub-Commission in whom, it is suggested, responsibility for determining amounts due and for making payments might be vested.
- (b) AFA should notify this Headquarters of amounts expended in order that the necessary arrangements for reimbursement by the American War Refugee Board can be made.
- (c) In the event that the Partisan Headquarters should desire that compensation be made to boat owners and others assisting refugees in escaping on the arrival of the latter in Italy, Partisan Headquarters will be requested by us to indicate a fair basis and scale for such payments. The information thus obtained will be communicated to your Headquarters.
- (d) Arrangements for the administration of any refugees who may enter Italy under the terms of the foregoing procedure should be the same as for other refugees received from Yugoslavia and the Dalmatian Islands.
- (e) The arrival of any refugees entering Italy under the terms of the foregoing arrangements should be reported to this Headquarters in order that we may inform both the War Department and the American War Refugee Board of the progress and success of these plans.
- 7. You will be informed of the outcome of negotiations with the Yugoslav Partisan Headquarters so soon as details are available in AFHQ. Information should be received in sufficient time to permit the completion of arrangements by your Headquarters if the plans are to be put into effect.
