SPECIAL MANDATE

In the name of the Law

On the 1st day of June of the year 1944, at Tripoli, in my notarial chambers, sis in this Galleria de Bono No. 32.

In the presence of :

Dott. Francesco Messina, of late Paolo, empowered by G.D. dated 9 January 1943 to substitute temporarily Dott. Paolo Messina, of late Francesco Royal Attorney in Tripoli, inscribed at this Tribunal with the assistance of Mr. Gabriele Gench, of late Raffaele, and Isaac Gabison, of late Abraham, both employees, born and domiciled at Tripoli, capable witnesses, known by me

PRESENT :

Mr. Meduri Domenico, of late Francesco, proprietor, born in Gallina (Reggio Calabria) domiciled at Tripoli, via Bramante No. 21, of whom I personally certify the identity.

He appears, hereby, in virtue of this act to be made in original.

He constitutes and appoints as special ^{MANDATORY} ~~attorney~~, Signora Angela Meduri, of late Bruno, residing at Gallina, in order that she acts ~~publicly~~ officially in the name, in lieu of and in the interests of her mandator, and proceed to the redemption of the undivided share belonging to Meduri Domenico, by paternal inheritance and which was sold to the said Meduri Salvatore Giovanni for the price of lire 30.500 by notary ~~act~~ act, in Reggio Calabria on the 17th of July 1939 and registered on the August 7th 1939 No. 204.

To that effect the appointed ^{MANDATORY} ~~attorney~~ is authorized :

- a) to sign the relative act of redemption
- b) to pay what is ought to Signor Meduri Salvatore Giovanni
- c) to receive the relative acquittance
- d) to re-enter in possession of the share
- e) to do what she would consider useful and necessary for the complete execution of the present mandate, therefore including the privilege of renouncing to an eventual legal mortgage, the whole being ratified and validated ~~Signature non.~~ up to the present time.

Solicited, I notary, have received this act, written by me, and ~~it~~ read by me, in the presence of the abovementioned witnesses of the man concerned who confirms it entirely.

I am directed to refer to the question of the Validation of Powers of Attorney for use in those parts of Italy under your Control.

2. I am to state that the procedure it is proposed to adopt in such cases is as follows:-

The signature of the donor should be verified by a notary public whose signature should be verified by the President of the Tribunale.

The latter's signature will be verified by the C.A., D.C.C.A.C. or Chief Secretary of the Administration concerned and forwarded to this H.Q.

3. It is then proposed to forward the document to you and it would be appreciated if you could arrange for its onward transmission to the donee after having verified the signature of the officer acting on behalf of this Branch and completed any formalities necessary for the Validation of the document for use in the part of Italy under your Control.

4. Col. R.D.H. Arundell and Lt. Col. J.E.D. Anderson will be the officers entitled to sign on behalf of this Branch and a specimen of their signatures is enclosed herewith.

5. I am to enquire whether this arrangement meets with your approval.
