1. With reference to your letter of 12 Aug 44, much more information will be required before steps for obtaining a marriage by proxy can be taken.
2. A full statement would be required giving dates commencing with the date he first met the girl, date he left Scotland etc. It is presumed he had been in correspondence with the girl concerned and any letters passing should be forwarded for information only. It is also presumed that there are no impediments to the marriage.
3. The full name address etc of the girl should be given and her religion. It is presumed that the girl in question wishes to marry him and evidence to this effect should be shown.
4. It is understood that the R.C. Church can arrange such marriages and it is considered they might be approached in the matter for advice. It is presumed that this officer has re-established communication with the girl concerned.
5. Will you please pass this information onto the officer concerned. This matter should have been handled officially through your S.C.A.O.

1. A number of ex Ps.W. at No. 2 Allied P.W. Repatriation Camp, Resina near Naples have submitted formal applications to marry Italian girls. These applications are being dealt with in accordance with G.R.O. 162, Serial 9 of 1944 and this H.Q. has no reason to believe that the consent of higher authority will be withheld.
2. Soldiers submitting these applications, many of whom have been in Naples for several weeks, are becoming concerned over the slow working of official machinery, and fear that their fiancées will judge them unfaithful. This H.Q. is, for a variety of reasons, unwilling to grant them leave of absence.
3. It would be much appreciated by all concerned if your Headquarters ~~could~~ ^P Please arrange for the women shown in the attached lists to be informed ~~through~~ ^{by} Civil Affairs Officers that the soldier concerned is in good health and is waiting at a Camp in Naples for his application to marry to be approved by the Military Authorities.
