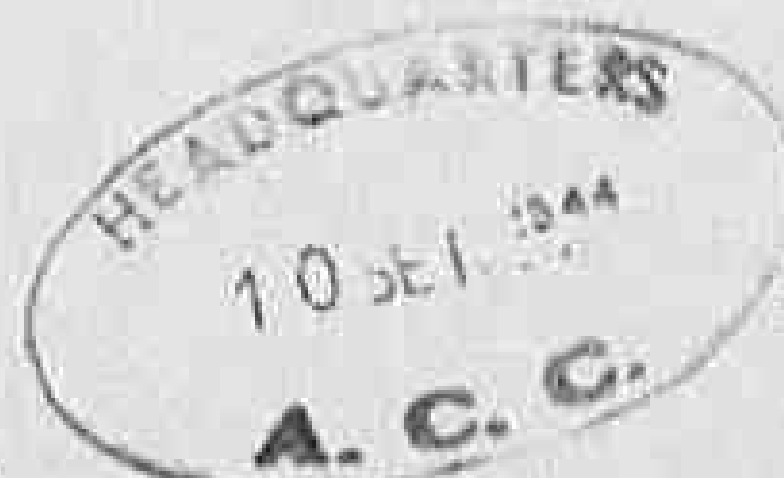

As previously stated a number of ex P.W. who have submitted formal applications to marry ITALIAN girls are becoming increasingly worried over the slow working of official machinery and the lack of communication facilities offered to them. They feel that in the absence of any direct communication from themselves their fiancées may construe their silence as either (a) unfaithfulness, or (b) ill-health. For various reasons this H.Q. is not in a position to grant these men leave.
2. Would it, therefore, be possible please, and within the Security Regulations to pass on to you open letters addressed to these girls for onward transmission to the addressees by your forward units.

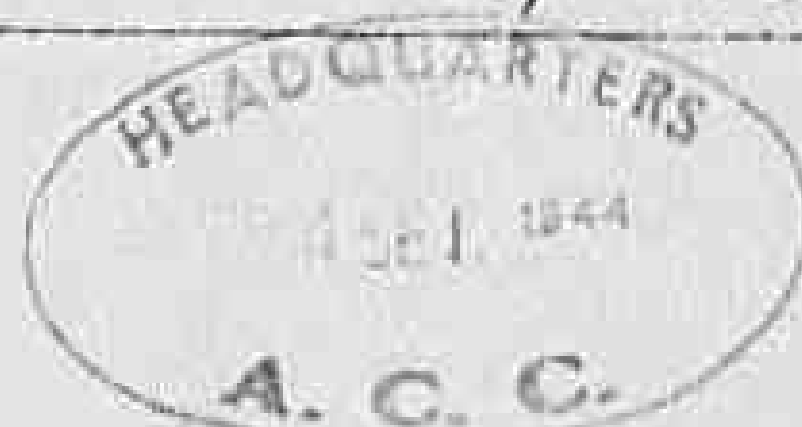

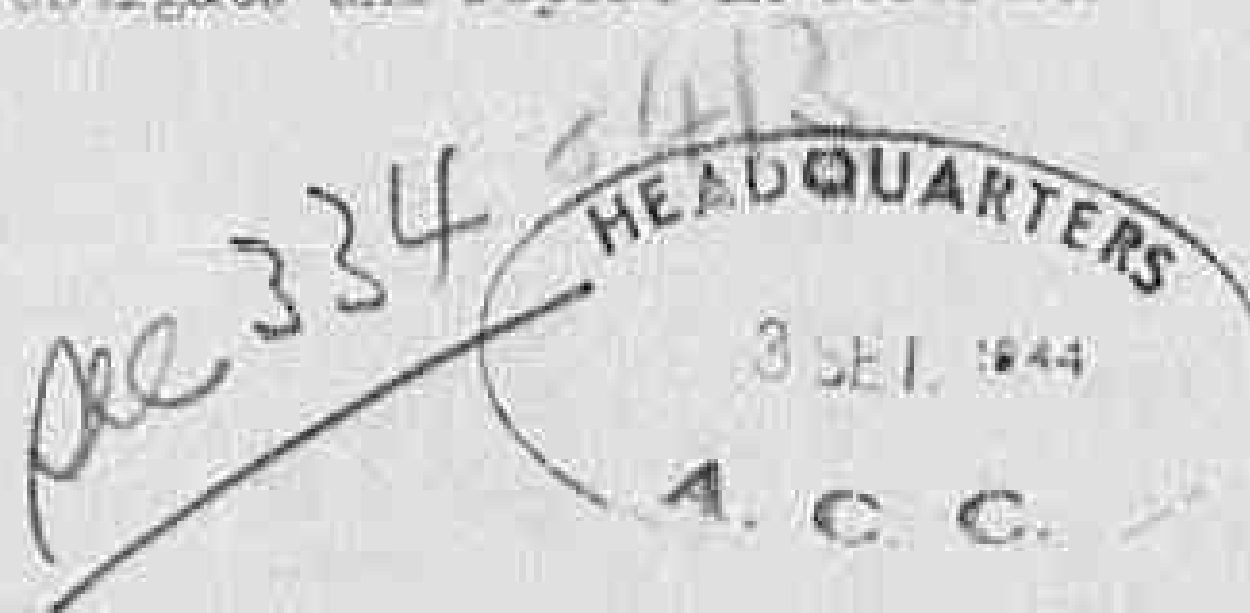

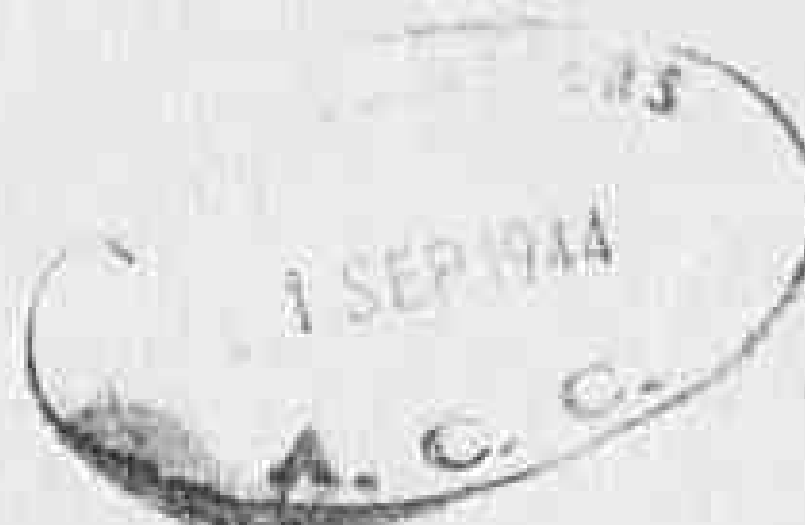
