1. The High Commissioner for SICILY has to-day given me, verbally, a confidential account of the first meeting he has held of his giunta consultiva, summoned for 1700 hrs Thursday 15 JUN 44.

2. There were present:

- AVV. ENRICO LA LOGGIA
- Francesco TAORMINA
- AVV. MONTALBANO
- Salvatore MONTEFORTE
- Prof. Andrea GUARNIERI

3. There were absent:

- AVV. ALDISIO, still in SALERNO
  - AVV. MATTARELLA, recently appointed Under-Secretary for Education.
  - Prof. Salvatore ALTOMARE of Messina and
  - AVV. Vincenzo SAITTA who were not invited in view of the intention of Italian Government to replace their services.
- (RC/014.12 of 16 MAY refers.)

4. The discussions were taken down in shorthand and the High Commissioner is drafting full minutes, a copy of which will be sent to Minister of the Interior.

5. In the High Commissioner's words, the giunta "came with their lances cocked" and the first two hours were devoted to a series of criticisms: the meeting closed at 8:00 p.m. on a more satisfactory note after Musotto's explanation of many of the difficulties. The High Commissioner's impression was that LA LOGGIA was unofficial director of the GIUNTA, which had been holding nightly unofficial meetings with the Rector of the

University, BAVIERA. Considerable "lobbying" had been indulged in.

6. Future meetings will take place twice weekly regularly at 1600 hrs, and more often if extraordinary conditions arise. The High Commissioner intends to issue future orders with the words "after consultation with my Giunta Consultiva". He has asked LA LOGGIA to draft bye-laws and rules for the conduct of meetings for submission to the Government, as no such rules exist.

7. The main criticisms of the Giunta were:

- a. that MUSOTTO had not obtained a sufficient price for grain.
- b. that the Giunta had not been summoned before; to this the High Commissioner replied that the Giunta was not in fact yet a legally constituted body as its appointment had not appeared in the Gazzetta Ufficiale and there were no rules for the conduct of its meetings.
- c. that the High Commissioner had delayed taking over the offices of the Prefettura; High Commissioner explained he had acted under direct instruction of Minister of Interior.
- d. that the High Commissioner had not found motor cars for each member of the GIUNTA, nor offices for its business.
- e. that Saitta and Altomare were not invited; the High Commissioner stated that there were reasons for this.

8. The meeting appears to have cleared the air, and while LA LOGGIA seemed to be dictating the hostile criticism, the Communist MONTALEANO was least hostile. The Giunta had felt it should have official offices, and contacts with High Commissioner's personnel and staff. The High Commissioner pointed out that it was his consultative committee and not a 'Soviet of High Commissioners'.

9. A courtesy visit paid me by MONTEFORTE to-day confirms that hostility has lessened following this first meeting.

10. The two main resultant points of interest are:

- a. that no Gazzetta Ufficiale has yet appeared appointing the Giunta.
- b. there are no definitions or bye-laws concerning its powers or functions.

Reference letters on CIVIL authorities under reference  
RC:014/12 of 28 MAR and 7 APR and subsequent conversa-  
tions - Regional Commissioner with Colonel SPICER.

1. GALTANISSETTA & SYRACUSE are still without Prefects. In addition Provincial Commissioner SYRACUSE reports that the conduct of the Prefecture is in a precarious state due to general shortage of personnel.
2. GALTANISSETTA, as one of the three largest wheat-growing provinces of SICILY urgently needs a strong Prefect. A good vice Prefect is also required as the present holder is due for epuration.
3. In AGRIGENTO, another grain-growing province with difficult conditions, the present A.M.G. appointed Prefect PANCAMO, has telegraphed placing his post at the disposition of the new Government. Meanwhile he is continuing with necessary administration.
4. TRAPANI and RAGUSA have "Prefetti Reggenti". 1542
5. The High Commissioner has again notified his government of these circumstances.
6. In view of the important work required from Prefects in SICILY to-day to enforce the grain collection, it is urged that representations be made to the new Government for early appointments.

SUBJECT: PUGLIATTI Salvatore, Messina University

TO: Head, Education Sub-Commission, ACC

1. With reference to your letter of 27 May 1944, 135/56/CA concerning the above named subject:

2. The first investigation was instigated by Major Peffa in December, 1943, then Head of the Political Intelligence Section, Region I, after having received an undated, unsigned accusation against PUGLIATTI. This accusation was almost identical to the one which was forwarded to us with Captain Hare's report in your letter referred to in "1" above. Captain Hare made an investigation in Messina and submitted a favorable report, 8/3/44, together with explanations by PUGLIATTI himself of the newspaper articles. PUGLIATTI said he could not find all of the newspaper articles and could not remember what they were about.

3. Inasmuch as some of the accusations were unanswered and further accusations were received, this office on 15 March and again on 9 May requested that PSS of Messina continue the investigation. A report was sent to this office 27 May, 1944 together with a report by the quarters and a copy of one of the speeches which PUGLIATTI could not find. Copies of these documents are attached.

4. Further investigation of speeches and publications by PUGLIATTI are continuing.

5. PUGLIATTI is no longer director of the Provincial Labor Office of Messina.

6. Major Koopman has discussed the case with Lt. Velle. A copy of this letter is being forwarded to Col Piski.

He started his career as an elementary school-teacher and later became Director of Schools. He was pensioned in 1935.

He was a Mason before the Fascist Regime but does not enjoy a very good reputation from that as he switched from one Lodge to another several times and when he eventually left the Periana Lodge he started a journalistic campaign against his ex-companions, revealing many secrets in spite of the Masonic oath.

*My dear Hancock,*

On receipt of the copy of your telegram about the Giunta Consultiva (brought by Major Bullock) I asked Colonel Spicer to take the matter up with the Minister of Interior. This was done. Subsequently Marshal Badoglio wrote to the Chief Commissioner freely acknowledging that his action in passing and publishing the decree without consultation with the High Commissioner was irregular but has given an explanation acceptable to the General.

The Chief Commissioner directs as follows:-

"We will not intervene in this question unless or until the Giunta as appointed proves unsatisfactory. Colonel Hancock will naturally keep in close touch with the situation and will inform us if he considers that action on our part is desirable and necessary."

Dear General:

This morning, His Excellency, Alcide, Minister of Interior informed me that the Colonel of the Central Commission has many objections to the appointments of the Council (Consulta) for Sicily, remarking that this appointment should have had previous approval of the Central Commission.

I recognize as perfectly just, the remarks of the Colonel and I openly confess of having, unintentionally, transgressed the regulations issued by you.

As I mentioned briefly to you yesterday, I can justify myself only by saying that this appointment was made by me at a time when I was busily engaged from morning to night in consultations with the representatives of the various parties and I did not have the necessary calmness to remember all the regulations.

I felt that it required a hasty decision to put a stop to all the maneuvers of Musette in Sicily and to appoint only persons of assured unitarian faith.

If the Commission requires that I annul the appointment, a matter upon which Musette is working at this moment, I would lose all prestige in the island.

The penalty would certainly be, in this case, disproportionate to the transgression committed.

I appeal directly to you so as to spare me such a measure.

Come é noto il corpo aereo tedesco (C.A.T.) dislocato in Sicilia, diede luog nell'anno 1941 e nei primi mesi del 1942 a numerosi incidenti con la popolazione civile italiana, che dovette subire assassini, furti, violenze e prepotenze e che in soli sei mesi ebbe a registrare ben 286 vittime, per soli investimenti stradali causati dalle truppe tedesche.

I comandanti dei gruppi carabinieri nei cui territori erano dislocati gli aeroporti in uso alle truppe tedesche, oltre a formulare direttamente più volte proteste verso i comandati germanici, segnalano superiormente tutti gli inconvenienti alle autorità italiane, inviando frequentemente prospetti e statistiche, per dimostrare la gravità della situazione.

Già al verificarsi dei primi gravi incidenti il sig. Generale Piéche, allora comandate la 3<sup>a</sup> Divisione, aveva richiesto al generale comandate la 6<sup>a</sup> Brigata carabinieri in Palermo un intervento energico verso i comandanti tedeschi per porre un freno all'attività delittuosa delle loro truppe. Successivamente l'Eccellenza il generale Rosi, comandante la 6<sup>a</sup> Armata Italiana, ordinò allo stesso generale comandante la 6<sup>a</sup> brigata carabinieri di richiamare anche a suo nome il comandante tedesco per il cattivo contegno delle truppe ai suoi ordini, autorizzando a minacciare anche rappresaglie ove non si fosse posto fine agli incidenti.

I tedeschi finalmente si preoccuparono della situazione e il generale di squadra Loerzer dell'aeronautica tedesca, per ordine del maggiore Kesserling, si recò a visitare il generale comandante della 6<sup>a</sup> brigata carabinieri, facendo le sue scuse, annunciando provvedimenti gravi a carico dei responsabili degli incidenti lamentati e prendendo accordi per il pronto intervento della polizia italiana e tedesca a carico dei militari germanici, comunque autori di disordini e violenze. Contemporaneamente - si era nell'anno 1942 - evidentemente allo scopo di placare i risentimenti delle autorità italiane, di cattivarsene le simpatie o di far dimenticare i torti subiti, i tedeschi fecero una larga distribuzione di onorificenze di diverso grado dell'ordine dell'Aquila tedesca - senza una particolare motivazione per nessuno - ai Prefetti ai Questori, ai Federali, ai Podestà dei capoluoghi di provincia ed ai comandati dei gruppi carabinieri (Catania, Siracusa,

Già al verificarsi dei primi gravi incidenti il sig. generale Pièche, allora comandante la 3<sup>a</sup> Divisione, aveva richiesto al generale comandante la 6<sup>a</sup> Brigata carabinieri in Palermo un intervento energico verso i comandati tedeschi per porre un freno all'attività delittuosa delle loro truppe. Successivamente l'Eccellenza il generale Rosi, comandante la 6<sup>a</sup> Armata Italiana, ordinò allo stesso generale comandante la 6<sup>a</sup> brigata carabinieri di richiamare anche a suo nome il comandante tedesco per il cattivo contegno delle truppe ai suoi ordini, autorizzandolo a minacciare anche rappresaglie ove non si fosse posto fine agli incidenti.

I tedeschi finalmente si preoccuparono della situazione e il generale di squadra Loerzer dell'aeronautica tedesca, per ordine del maresciallo Kesserling, si recò a visitare il generale comandante della 6<sup>a</sup> brigata carabinieri, facendo le sue scuse, annunciando provvedimenti gravi a carico dei responsabili degli incidenti lamentati e prendendo accordi per il pronto intervento della polizia italiana e tedesca a carico dei militari germanici, comunque autori di disordini e violenze.

Contemporaneamente - si era nell'anno 1942 - evidentemente allo scopo di placare i risentimenti delle autorità italiane, si cattivassero le simpatie o si far dimenticare i torti subiti, i tedeschi fecero una larga distribuzione di onorificenze di diverso grado dell'ordine dell'Aquila tedesca - senza una particolare motivazione per nessuno - ai Prefetti ai Questori, ai Federali, ai Podestà dei capoluoghi di provincia ed ai comandati dei gruppi carabinieri (Catania, Siracusa, Caltanissetta, Trapani) nei cui territori allora erano dislocati gli aeroporti tedeschi, nonché ai comandati dei carabinieri dell'aeronautica italiana ed ai comandati di legione e di brigata carabinieri.

Degli ufficiali suddetti sono attualmente presenti a questa brigata i tenenti colonnelli Sellitto Alberto e Paolantonio Giacinto.

Detti ufficiali che, ormai da otto mesi hanno con assoluta fedeltà e lealtà prestato servizio alle dipendenze del Governo Militare Alleato, che dovettero accettare l'onorificenza tedesca, concessa loro no per particolari benemerite acquisite verso i tedeschi, ma, in definitiva, soltanto per aver doverosamente difeso gli interessi delle popolazioni italiane, desiderano - all'atto in cui il territorio dell'isola viene restituito all'Italia - porre le decorazioni ricevute a disposizione del Governo Italiano, perché siano restituite a quello tedesco, nemico della loro Patria.

The nomination of a Civil Commissioner for Sicily with a seat in Palermo is meeting with serious difficulties.

When the transfer of power to Badoglio Government was foreseen, the candidature of Lawyer Francesco MUSOTTO, Prefetto of Palermo, was pressed and his candidature received the support of Lt. Col. Poletti.

MUSOTTO, who had already announced himself as supporting the independence of Sicily, although he had already embraced Republican ideas, obtained the adherence of all the remaining Prefetti of the Island and many representatives of the various parties, who agitate for power.

After the 10th Feb 1944 and before Lt. Col. Poletti had left Palermo, the candidature of MUSOTTO was pressed forward officially.

BADOGGIO knew the political ideas of MUSOTTO and opposed his candidature and himself put forward Gen. GAZZERA, already Minister of War in the reign of Fascism.

This candidature seems to have been fought by Col. Poletti, who insisted on MUSOTTO. Badoglio was therefore obliged to withdraw it. He continued to oppose the candidature of MUSOTTO and put forward the names of Gen. CASTELLANI and Gen. LA FERLA. But these seem to have fallen out.

With the presence of Col. Poletti in Palermo, MUSOTTO was sure of his position, but the withdrawal of the Col. caused him to lose ground.

To keep himself ~~in~~ in favour, he organised a meeting of Prefetti for the 20th Feb 1944 in which an order of the day

Despite this order, the position of MUSOTTO is uncertain, also because the candidature of two Sicilians are in sight. These are the ex Deputy LA LOGGIA, Democratic Social, and Deputy ALDISIO, Democratic Christian.

These two have, at the moment, few followers.

From what I could gather in Palermo, on 20/21/22 of this

month, the Sicilians want a Sicilian Commissioner.

The transfer of Lt.Col. Poletti has given new strenght to the several parties who agitate for power.

They trust in the absolute impartiality of Col.Hancock, the new High Commissioner, who has no preference for any particular party in contrast to Col. Poletti,who, it is rumored, had strong sympathy for Cardinal LAVITRANO,Bishop of Palermo and Monsignor FILIPPI, Bishop of Monreale.

The sign of the new situation is the frequent meetings held in the various theatres of the town,where the adherents of the parties meet, and where discussions is animated.

Altogether the position in Palermo is uncertain and chaotic as far as the nomination of the Civil Commissioner and organisation of the various parties for power are concerned.

In addition two officials of the Unione Provinciale dell Agricoltura and one official of the Official of the Unione Provinciale dell Industria were interned. ~~In Cosenza Province where the~~ Prefect and the Questura fled, 390 public officials were removed from office in Cosenza city and 1297 additional officials were removed from office in the rest of the province. 1012 were employed in the communal administration, 285 by the Associazione Nazionale Enti Economici Agricoli and the bulk of the balance ~~from~~ the Provincial administration. The abolition of the Fascist party displaced 397 public officials in this province automatically, 460 of whom were from the city of Cosenza. 


