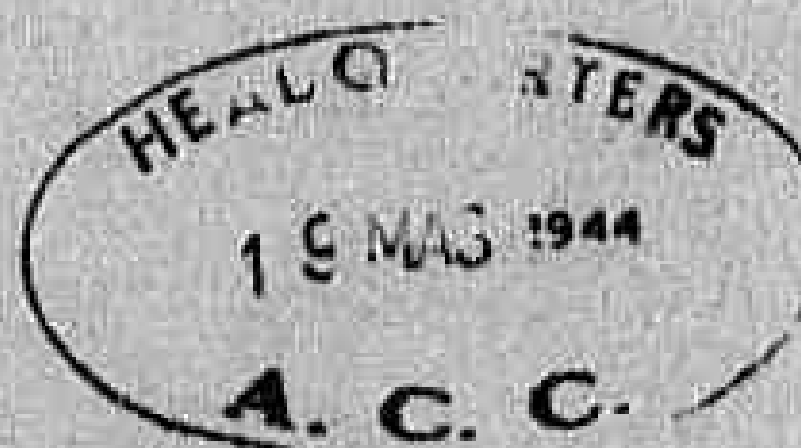
2. The new prefect's appointment takes effect the 15th May, and he has arranged with the Regional Commissioner, Region V to take up his duties on or about the 20th May.
