Italian Appointments in SARDINIA.

1. PWB wire for details of new appointments of Prefects in SARDINIA, saying that the Regional Commissioner advises early publication in order to quiet rumours.
2. I saw Admin. Section and Interior Sub-Com. who says that ACC have conveyed approval to the Italian Government of the new appointments but they do not recommend publication as these appointments have still to be confirmed by the Italian Council of Ministers.
3. Regarding General Magli, the same objection regarding publication applies. General Browning has told AAI that General Magli was removed in course of demobilization and not for political activities.
4. Interior Sub-Commission have sent today by air to Brig. Carr the names of the Prefects approved by ACC, but this is for his own private information and not for publication.
5. In my view the Italian Government should be asked to make the announcement public as soon as possible in view of the general situation in SARDINIA, which we know will not be improved over uncertainty in higher appointments.
