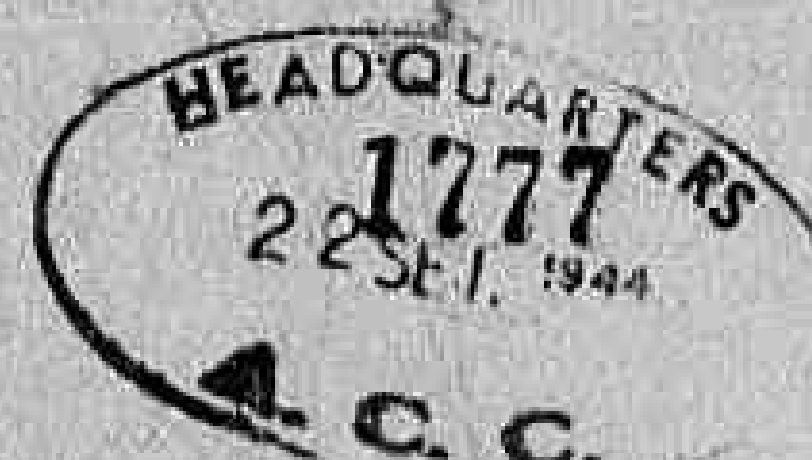

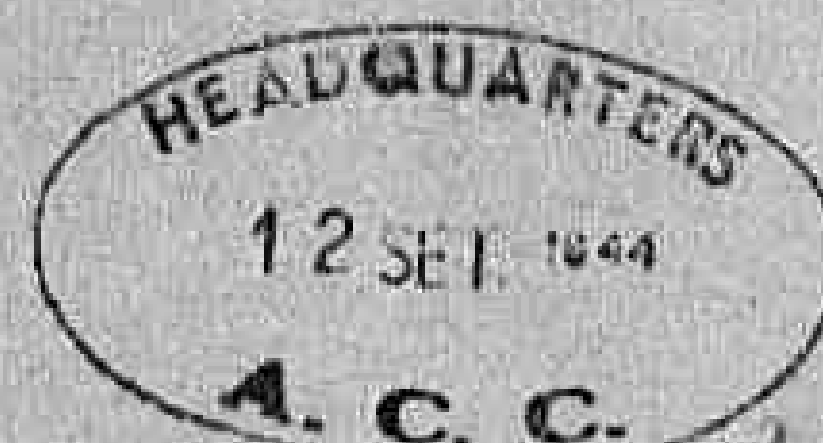

1. Pasquale Guglielmi duly reported here for duty as Questore for Livorno on 22nd August.

2. The Provincial Police Officer, who was formerly Police Officer in Benevento, at once recognised him as the man who was earlier removed from Benevento because of dishonesty.

3. On reporting to the Prefect, Guglielmi told him that he did not like Livorno and did not want to work there.

4. In these circumstances the Provincial Commissioner and the Prefect both request his immediate transfer and replacement.

1. As of today front line troops are in the suburbs of Pisa. It is not known how soon the city will be occupied but it may be very soon. As the greater part of the Province is already occupied it is essential that an Italian Administration be started at the earliest possible moment.

It is therefore requested that a skeleton team of officials be held in readiness to move forward at very short notice if required.

2. With regard to Livorno, the city has been evacuated of most of the population and it is not yet known how many of the officials can be found, though it is thought that very few are left. Fuller information should be forthcoming in another two or three days: in the meantime it is requested that for here also a skeleton team be held in readiness to move up immediately when called for.

10 AUG. 1944

TO : HQ, AGO Interior Sub-Commission.

1. The Provincial Commissioner, Siena, reports that all senior officials are present except the Prefect. The Vice-Prefect Commendatore Vincenzo BASSI is reported to be an efficient man and the Provincial Commissioner is prepared to carry on for the time being using him as acting Prefect. However the Italian Government will no doubt wish to make a new appointment to the position of Prefect in due course.

2. The Questore was absent when the city was first entered but has now returned; he is being retained for the time being and will be given a trial to see if he is satisfactory and locally acceptable.

3. The Provincial Commissioner has been instructed to furnish a nominal roll of the senior officials which will be sent on to you in due course.

4. A search is being made for a suitable man for appointment as Sindaco of Siena commune. It is felt more satisfactory to find a local man if possible and an outside man will only be asked for if an exhaustive local search is unsuccessful.

TO : HQ, AGC, Interior Sub-Commission.

1. If operations proceed at the pace which is at present anticipated the problem will very shortly arise of reorganising the Italian Provincial Administration of the thickly populated Provinces which lie ahead.

Attention is drawn to the fact that the four Provincial Capitals of Livorno, Pisa, Lucca and Pistoia, which all lie on approximately the same latitude, are likely to be occupied almost simultaneously, and that the Provincial centre of Apuania is likely to follow a few days later. The fall of Siena can be expected before the end of this month.

2. It is impossible to forecast at this stage how much of the former administration will be found in existence; in the case of Viterbo most officials were found present and to be satisfactory for temporary reappointment, whereas recent experience at Grosseto, where all Provincial Officials had fled, forces us to the conclusion that we must be prepared to face the possibility of having to organise a completely new team of Senior Provincial Officials for all these six Provinces.

3. It is therefore requested that the Italian Government be directed to nominate and have ready on call the necessary personnel, so that there may be the minimum possible in restarting the Italian Administration when the Provinces are occupied. We will keep our demands down to the minimum but it can be taken for granted that a new Prefect will be needed in every case.

SUBJECT: Italian Officials.

TO : HQ, ACC, Interior Sub-Commission.

1. It is anticipated that in a few days the Provincial Capital of Littoria will be occupied and it will then be necessary to reorganise the Italian Provincial administration.

2. It is not yet known what will be the condition of the Provincial administration or how many of the present senior officials will be available or suitable to continue in office.

3. It is therefore requested that enquiries be now made of the Italian Government to find out whether they have any officials available for appointment to the position of Prefect and other senior positions in case they are required.

4. You will be notified as soon as possible of the condition of the Provincial administration and of the exact requirements of officials who cannot be located in the area.

In the meantime it is desirable that the Italian Government should have one or two senior officials earmarked in case they are required.
