JOINT COMMUNIQUE  
AMERICAN AND BRITISH GOVERNMENTS

The President and the Prime Minister held further discussions Monday and Tuesday, September 18th and 19th at Hyde Park on subjects dealing with postwar policies in Europe. The result of these discussions cannot be disclosed at this time for strategic military reasons and pending their consideration by our other Allies. The present problems in Italy also came under discussion and on this subject the President and the Prime Minister issued the following statement: "The Italian people freed of their Fascist and Nazi overlordship have in these last twelve months demonstrated their will ~~to be free~~ to fight on the side of the democracies and to take a place among the United Nations devoted to principles of peace and justice. We believe we should give encouragement to those Italians who are standing for a political rebirth in Italy and are completing the destruction of the evil Fascist system. We wish to afford the Italians a greater opportunity to aid in the defeat of our common enemies. The American and the British people are of course horrified by the recent mob action in Rome but feel that a greater responsibility placed on the Italian people and on their own government will most readily prevent a recurrence of such acts. An increasing measure of control will be gradually handed over to the Italian administration subject of course to that administration's proving that it can maintain law and order and the regular administration of justice. To mark this change the Allied Control Commission will be renamed the Allied Commission. The British High Commissioner in Italy will assume the additional title of Ambassador. The United States Representative in Rome already holds that rank. The Italian Government will be invited to appoint direct representatives to Washington and London. First and immediate considerations in Italy are the relief of hunger and sickness and fear. To this end we instructed our representatives at the UNRRA conference to declare for the sending of medical aids and other essential supplies to Italy. We are happy to know that this view commanded itself to other members of the UNRRA Council. At the same time first steps should be taken toward the reconstruction of an Italian economy. An economy laid low under the years of the misrule of Mussolini and ravished by the German policy of vengeful destruction. These steps should be taken primarily as military aims to put the full resources of Italy and the Italian people into the struggle to defeat Germany and Japan. For military reasons we should assist the Italians in the restoration of such power systems, their railways, motor transport roads and other communications as enter into the war situation and for a short time send engineers, technicians and industrial experts into Italy to help them in their own rehabilitation. The application to Italy of the Trading With The Enemy Acts should be modified so as to enable business contacts between Italy and the outside world to be resumed for the benefit of the Italian people. We all wish to speed the day when the last vestiges of Fascism in Italy will have been wiped out and when the last German will have left Italian soil and when there will be no need of any Allied troops to remain, the day when free elections can be held throughout Italy and when Italy can earn her proper place in the great family of free nations."

Legal scale commissioners seem to take the view that third degree is quite common and that it is not their business, beyond seeing that evidence founded upon it is not considered. If however it is true that third degree methods are used, and the report of them can get as far as the press in this case, it is freely circulating before long the Italian press will smell it out and we shall get accusations. As Naples is such AMG it might perhaps be wise to make an enquiry.

SUBJECT: Discipline.

TO : Mr. No. 3 District.

1. Your letter 246/4 A of 3 July 1944 is acknowledged.
2. It is noted that there is a discrepancy between the statements by Dr. Danzona and Cpl. Huo as to the number of cigarettes found. Dr. Danzona says "about a dozen" whereas Cpl. Huo says "800".
3. Since this case was first raised a more serious case has arisen concerning another Minister namely Minister Pietro Mancini. For your perusal there is attached a copy of a letter from the Regal Ministry of Foreign Affairs dated 5 July 1944. It is stated in the letter that "the Corporal of the M.P. struck repeatedly young Mancini and Signor Meli with the butt of his pistol".
4. It is requested that an investigation be made into the matter and this Headquarters informed of the result so that a reply may be made to the letter.

5. In spite of the incident of Dr. Danzona, however, it is considered that Ministers of the Italian Government should not normally be the subjects of search, but that a special pass should be issued to them instead. This matter was discussed at a meeting at this Headquarters today at which a representative of G.S.I. (b) M.A.L. was present and it was decided to issue a special pass to Italian Ministers and certain other important Italian persons. This pass would state who they were, give them permission to travel anywhere south of the Army Control Line and ask that every facility and courtesy should be extended to them. This would not entitle them to immunity from search, but they should not normally be stopped and searched unless there is reason to suspect any irregularity. Special instructions on this subject will shortly be issued.

a. File of nine pages relative to the case of Minister of Justice Tuppino.

b. Copy of letter N. 5428 dated 5 July from Minister Prunas to the Acting Chief Commissioner relative to the searching of Minister Pietro Mancini's car and the striking of young Mancini and a Signor Mele.

2. Relative to the Tuppino case, at page 5 of the attached file, the Acting Chief Commissioner requested "that the strongest representations be made to the Military authorities". Reply of Dep Exec Comm at page 9 does not indicate whether or not this was done.

3. There appears to be a great discrepancy in the statements made by Dr. Dondona (page 1) and Cpl Hue (page 7) as to the number of cigarettes found. Dr. Dondona says "about a dozen" whereas Cpl Hue reports "800".

4. The file does not indicate that question asked by 3 District (page 8) has been answered.

5. The case of Minister Mancini is much more serious. Here it is stated, "the corporal of the M.P. struck repeatedly Young Mancini and Signor Mele with the butt of his pistol".

6. The Acting Chief Commissioner requests that an investigation be caused to be made in this matter and that the request be presented at a high military level and that information be provided upon which a reply to reference 1 b can be based.

Sir, I have to report that at about 0900 hrs. 22 June 44. I was on duty in company with Cpl. Nott, E.R.A.F. Police on the Scafati - Salerno Road, when in the course of our duty we had occasion to stop a civilian car containing three men and a lady.

Inside the car were several suitcases, and the driver seemed very reluctant over allowing them to be examined, stating that one of the passengers was a Minister of the Italian Government and that neither he nor any of his passengers were in possession of contraband or any Allied property. However on examination of the cases by Cpl Nott and myself we found that one of them contained about 800 American and British cigarettes, concealed underneath garments of clothing.

Each passenger was questioned in turn but none would accept ownership, they were accordingly confiscated.

During the examination of the vehicle the utmost respect and consideration was shown by Cpl Nott and myself towards the persons concerned. The attitude towards us however was not becoming, and they doubted our authority although we were correctly dressed in duty order and wearing arm-bands.

SUBJECT : Searching of Minister of Justice by Military Police.

TO : Acting Chief Commissioner (thru V.P. Admin Sec).

1. Attached for your information is a report from the Minister of Justice, His Excellency Tuppino, concerning the searching of his own and his secretary's person as well as his car and official documents and private papers by members of the Allied Military Police on 22 June.

2. On learning of this incident on the afternoon of the same day, I telephoned to the R.C. & M.G. Section at ACC HQ., asking them to take the matter up immediately with No. 3 District. The result of the enquiry is awaited.

3. I understand that the Minister's car bore the official markings and that both he and his Secretary were in possession of regular passes and identification papers.

4. It is suggested that as any repetition of such incidents would be likely to have most unfortunate repercussions at a high level, instructions be given with all due speed to the Military Police to use particular care when dealing with high Italian officials, and that furthermore some form of special pass be established for such persons which will entitle them to free passage and exemption from such formalities.

SUBJECT: Report on incident involving His Excellency the Minister.

On 22 June 44 at about 8 or 8.15 A.M. the car of His Excellency Tupini, Minister of Justice, was stopped at the police block in the outskirts of Pompei on the Naples autostrada. His Excellency was travelling from Salerno to Naples on official business for the purpose of attending a meeting with the other Ministers of the Cabinet of S.A.R. il Luogotenente del Regno.

In spite of the fact that the status of His Excellency appeared on the paper fixed to the wind-screen of the car and in spite of the fact that this status was declared orally and set out in his personal papers, the soldiers of the Allied Military Police having stopped the car proceeded to search everything in it, and even searched the person of H.E. Tupini, of his private Secretary Dr. Dondona and the driver. In the process of this search about a dozen "Old Gold" cigarettes were confiscated from Dr. Dondona, which he had in his pocket and also an empty petrol tin kept in the luggage "boot". The official papers and the private correspondence of the Minister and of those who were with him were examined.

Only after strong remonstrances and having stopped the car for about a quarter of an hour did the soldiers of the Allied Police allow His Excellency the Minister to proceed to Naples.

Dear Admiral,

I have been asked to report to you the following regrettable incident which took place on June 22 at the check-post of Pompei. On that day, and precisely at 12.45, Minister Pietro Mancini's car was stopped by the M.P. on duty and the Minister, his wife, his son and their friend Signor Gaetano Mele, were peremptorily ordered out of the car. Notwithstanding that the Minister produced his identification card, he was searched and then ordered to take down his travelling bags from the top of the car. Having complied, they were opened and having found in them a few packets of American cigarettes which were presented in Rome by Allied Officers to His Excellency Mancini's son and to signor Mele, the corporal of the M.P. struck repeatedly young Mancini and signor Mele with the butt of his pistol; he then emptied the contents of the bags on the road kicking them about. After which, the M.P. allowed the party to proceed on their way.

Signor Mancini was naturally very much surprised and pained at the treatment he was submitted to, all the more so as he was that very day returning from Rome where he had been to fetch his son and friend who, during these trying months, had been actively taking part in the underground activities of the patriots' movement.

I know it is needless for me to stress with you how very unfortunate similar occurrences are. I feel sure you will with your usual helpful understanding, cause the matter to be investigated and the necessary instructions to be given in order to avoid their repetition. I am also wondering whether it would not be possible to furnish Cabinet Ministers a special identification card issued by the A.C.C. I should be most grateful if you would take into consideration this suggestion, letting me know in due course your decision in the matter.



I have to report that at about 0900 hrs. 22 June 44. I was on duty in company with Cpl. Nott. E. R.A.F. Police on the Scafati - Salerno Road, when in the course of our duty we had occasion to stop a civilian car containing three men and a lady.

Inside the car were several suitcases, and the driver seemed very reluctant over allowing them to be examined, stating that one of the passengers was a Minister of the Italian Government and that neither he nor any of his passengers were in possession of contraband or any Allied property. However on examination of the cases by Cpl Nott and myself we found that one of them contained about 800 American and British cigarettes, concealed underneath garments of clothing.

Each passenger was questioned in turn but none would accept ownership, they were accordingly confiscated.

During the examination of the vehicle the utmost respect and consideration was shown by Cpl Nott and myself towards the persons concerned. The attitude towards us however was not becoming, and they doubted our authority although we were correctly dressed in duty order and wearing arm-bands.

3. I understand that the Minister's car bore the official markings and that both he and his Secretary were in possession of regular passes and identification papers.

4. It is suggested that as any repetition of such incidents would be likely to have most unfortunate repercussions at a high level, instructions be given with all due speed to the Military Police to use particular care when dealing with high Italian officials, and that furthermore some form of special pass be established for such persons which will entitle them to free passage and exemption from such formalities.

SUBJECT: Report on incident involving His Excellency the Minister.

On 22 June 44 at about 8 or 8.15 A.M. the car of His Excellency Turini, Minister of Justice, was stopped at the police block in the outskirts of Naples on the Naples autostrada. His Excellency was travelling from Salerno to Naples on official business for the purpose of attending a meeting with the other Ministers of the Cabinet of S.A.R. il Langtonente del Regno.

In spite of the fact that the status of His Excellency appeared on the paper fixed to the wind-screen of the car and in spite of the fact that this status was declared orally and set out in his personal papers, the soldiers of the Allied Military Police having stopped the car proceeded to search everything in it, and even searched the person of H.E. Turini, of his private Secretary Dr. Dondoni and the driver. In the course of this search about a dozen "Old Gold" cigarettes were confiscated from Dr. Dondoni, which he had in his pocket and also an empty petrol tin kept in the luggage "boot". The official papers and the private correspondence of the Minister and of those who were with him were examined.

Only after strong remonstrance and having stopped the car for about a quarter of an hour did the soldiers of the Allied Police allow His Excellency the Minister to proceed to Naples.

1. SABOTAGE:- On the 17 June, about 1900 hours, the Foggia power line was cut just outside of town. There is evidence that the break was caused by someone who fired shots from a .45 cal automatic weapon through the wires. The culprit was most probably a member of the Allied Armed Forces. As a result of the break, operations of many establishments were cut out for about 16 hours over a considerable area and work slowed down all over the affected area.

It is requested that anyone having knowledge of that act of sabotage so inform the Provost Marshal of this Headquarters.

It is further requested that anyone witnessing or having knowledge of indiscriminate firing in the area, especially where electricity, water, or other utilities or installations might be damaged either attempt to apprehend the parties or report the incident to the Provost Marshal.

2. RELATIONS WITH ITALIANS:- The following information was received from Allied Armies in Italy, and is brought to the attention of all units in this area.

"A considerable number of cases have occurred where troops of the Allied Forces have come into conflict with the Italian Carabinieri. In several instances the Carabinieri have used their arms, with fatal results.

Confidential*  
It should be very clearly understood by all ranks that cases of this nature will be judged strictly upon their merits. The Carabinieri have important responsibilities. If Allied soldiers molest them, or interfere with them in the course of their duties, they should not expect any different treatment from that which they would receive if they gave similar trouble to Military Police of the Allied Forces.

On the whole, the Italian Carabinieri have behaved well and constitute an important factor in the maintenance of order among the civil population. So long as they carry out their responsibilities in a correct manner, the Commander-in-Chief wishes them to be given support, and he directs that suitable punishment should be meted out to any ill-disciplined soldiers who misbehave towards them".

3. TRIP TICKETS:- All units are reminded that gasoline supply points including British operated petrol points have been instructed to require a properly issued trip-ticket or work ticket before refueling any vehicle.

4. PURCHASE OF MILITARY VEHICLES:- All military personnel are warned that all British Motorcycles in this theater, like other forms of military transport, are government property and are not legally available for sale to individuals. Purchase of such motorcycles or other motor vehicles is nearly certain to result in monetary loss upon confiscation of the vehicle and may also result in disciplinary action under Articles of War 83 and 84.

\* \* \* \* \*

5. RESTRICTED AREA:- No vehicles of units within the Allied Air Force Area are permitted on the Gargano Peninsula from AFRICENA to PRESCHICI, without a special permit issued by the British Garrison Commander. This includes all the towns and roads between AFRICENA and PRESCHICI.

\* \* \* \* \*

6. TAXI SERVICE:- Civilian carriages for hire in Foggia are not permitted to transport military personnel outside the city of Foggia without a special trip permit obtained from the military police station on Corso Vittorio Emanuelle. Carriages are limited to three passengers and the driver. A new fare schedule has been issued which the driver is required to produce for passengers on demand.

\* \* \* \* \*

7. CIVILIANS RIDING GOVERNMENT VEHICLES:- Civilian passengers in military vehicles can be authorized only by the officer controlling the transportation who will indorse on the trip ticket a specific permit showing name of driver, names of civilian passengers, and points between which they are to be carried. When work crews are transported the authorization will show the name of the foreman and number of workers under his control.

8. ICE CREAM MANUFACTURE FROM POWDERED EGGS:- A potential danger exists in the use of dehydrated eggs in an unheated condition in cold ice cream mixes.

Units using powdered eggs in the manufacture of ice cream mixes will heat the eggs to 155°F for thirty (30) minutes before adding to the mix, which should then be immediately frozen.

In order to prevent coagulation of the eggs, approximately one quart of water or milk should be added to each pound of powdered eggs and the resultant mix to be stirred constantly during the half-hour of heating.

The reason for stopping the sale of potatoes is that, although the price of this item had been set at 10 Lire per kilo, some Army units have been offering 25 to 40 Lire per kilo, thereby tempting the farmers to lift their crops before they are mature, cutting down production. If this practice were to continue a serious shortage will occur later making it impossible to secure fresh potatoes through any sources.

I have made enquiries respecting the matter shown in attached censored letter but nothing is known of any such incident as described, either by this office or the Military Police, or Naval Police.

The writer of the letter is an Italian soldier employed on guard duty near the port at Messina. He was seen and questioned when he stated that the story in his letter was untrue and that it was an exaggeration of a slight incident that occurred near his guard post one night when there was a quarrel between some English sailors (not soldiers) who had been drinking, and two or three civilians and an Italian soldier. The writer of letter was on guard duty and could hear sounds of the quarrel and later heard a shot fired when the sailors and other persons hurried away. No further particulars could be obtained as to the person involved in the quarrel and there was no evidence as to any person being wounded.

A considerable number of cases have occurred where troops of the Allied Forces have come into conflict with the Italian Carabinieri. In several instances the Carabinieri have used their arms, with fatal results.

It should be very clearly understood by all ranks that cases of this nature will be judged strictly upon their merits. The Carabinieri have important responsibilities. If Allied soldiers molest them, or interfere with them in the course of their duties, they should not expect any different treatment from that which they would receive if they gave similar trouble to Military Police of the Allied Forces.

On the whole the Italian Carabinieri have behaved well and constitute an important factor in the maintenance of order among the civil population. So long as they carry out their responsibilities in a correct manner, the Commander-in-Chief wishes them to be given support, and he directs that suitable punishment should be meted out to any ill-disciplined soldiers who misbehave towards them.

1. Anglo-Italian Cultural Association.

A group of Palermitan Anglophiles has formed an Association for the promotion and development of Anglo-Italian cultural relations. The Statute of this association is enclosed, together with a list of names of those forming the Central Committee (encl.Nol.). The group is at present sponsoring some English classes in Palermo.

2. Request for premises.

A request has been made by this association for premises, and it has been suggested that they might be allotted one or two rooms in the British Institute premises (Palazzo Costantino). It is considered, however, that no such arrangement should be made, until the policy of the British Council is known.

3. Custody of British Institute premises.

Since October 1943 the premises formerly occupied by the British Institute in Palermo (Piano Nobile of the Palazzo Costantino, 217 via Maqueda) have been held in custody for the British Council by the Educational Advisor, AMGOT, and later by the Chief, Education Division, Region I. Copies of a letter to the proprietor of the building from the Chief, Education Division and of a memorandum of the Educational Subcommission are attached (enclosures 2 and 3). The building has not been requisitioned by the Allied Forces.

4. Early advice on this matter would be appreciated.
