1. It is manifest that the present unsatisfactory state of affairs in the administration of Cosenza province will continue so long as there is no Prefect.
2. The Vice-Prefect is a good administrator, rather colourless and unlikely to be a success as Prefect here; although he might do well in such a post elsewhere. He has been in Cosenza for so long that he knows everybody, and lets himself be swayed by the various parties, though he himself has no politics. Granted that he is in an awkward position, nevertheless it is doubtful whether he would do any better were he made Prefect, because having refrained from decisive action while Vice-Prefect, he would find it beyond his capabilities to do so now; at least that is the opinion that I have formed.
3. It is essential that an appointment be made in the very near future. I do not know the situation regarding career men; but can hold out little hope of finding a suitable candidate from the general public in Calabria. It would not be advisable to select anyone with pronounced political views. Two of the best known Cosenza men are Ministers and one, at any rate, interests himself greatly in local affairs to the embarrassment of any holder of the office of Prefect. If it would be hard to find the right man among the professionals, or if a private individual is preferred, efforts will be made to find one. In any case it is requested that steps be taken to fill this vacancy as soon as possible.

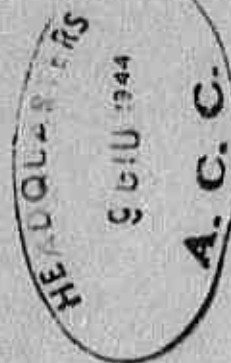

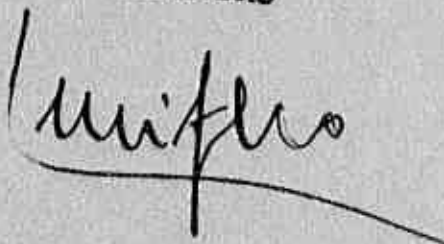
