3. If the Commander-in-Chief is not now desirous to occupy the villa, it would appear that the estate should be reserved exclusively to the Prince of Piedmont. The Chief Commissioner would be pleased to receive your views.

In the event of AFHQ moving to CASERTA, the S.A.C. will require a residence in NAPLES. General WILSON has seen the VILLA ROSEBERRY and considers this would make a most suitable residence for him.

It is, of course realized that this is the residence of the Prince of Piedmont. On the capture of ROME, however, it is thought probable that the Prince of Piedmont will take up his residence there, in which case the VILLA ROSEBERRY could be made available to the S.A.C.

If the VILLA ROSEBERRY cannot be made available, then some suitable alternative accommodation for the S.A.C. will have to be found.

My Dear General,

A few days after a short visit paid by General Wilson to "Villa Maria-Pia" at Posillipo, the attached memorandum was made with the approval of His Royal Highness, The Prince of Piedmont. It was believed, at that time, that the occupation of the capital by the Allied troops was very near, if not imminent. As a result of the development of military operations, the forecasts changed, and the memo has not been forwarded.

Today, therefore, it seems necessary to examine the whole question again, because the present situation of His Royal Highness in regard to this residence, cannot be prolonged without offending the decorum of His House and without exposing the safety of His Person, in fact, the occupation of all the buildings at the park of "Villa Maria-Pia" except for that one where His Royal Highness has His Own apartments, does not permit Him to keep His personal staff and servants with sufficient accommodation. I would like to point out that His Royal Highness cannot have with Him two of His adjutants because of the lack of room.

The presence of officers and O.R.s of Allied troops in the enclosure of the Villa could give the chance to a mal-intentioned person to get through the entrance-gate pretending to be an English or American soldier, so cancelling the measures enacted for the safety of the Prince.

Because of these considerations I beg you, my dear General, to present the delicate question of the residence of His Royal Highness, The Prince of Piedmont, to the High Command of the United Nations in order to settle it with the correct consideration.

I thank you for your authoritative intervention, and I beg you to accept my best regards.

MEMO

Contrary to the belief of the Anglo-American authorities, the official and normal residence of His Royal Highness the Prince of Piedmont, was and will be Naples and not Rome. During the greater part of the year His Royal Highness lived in the Royal Palace, but for short periods at Villa Maria-Pia, Possilliro.

It is generally known that the Royal Palace has suffered severely from aerial bombardment. The small section of the Palace which did not suffer damage from the air, has since been handled roughly by a succession of American, English, French and coloured troops; by whom the Royal Palace was regarded as being merely a barracks.

Theft and devastation of an unjustifiable nature were committed by the troops referred to.

For these reasons, with the exception of a few isolated rooms, the Royal Palace is no longer habitable.

Dealing now with the Villa Maria the position is that until quite recently the availability of the whole Villa Maria estate remained in the hands of his Royal Highness. It was nevertheless the intention of the highest American authorities to place the villa at the disposition of General Eisenhower. Unfortunately at the time of entry of the American troops into Naples, an unidentified person acting without authority, stated that the villa was available, possibly with the object of preventing it from falling into unauthorised hands.

This occupation took place despite the fact that by this time His Royal Highness was in possession of a document stating that the premises were not available for requisition. This document was issued to His Royal Highness by the Military Governor of Naples.

The largest of these cottages is still occupied by two English soldiers and from time to time by officers in transit.

Until now, though not without difficulty, it has been possible to retain intact the private apartment of His Royal Highness.

It is also necessary to take into consideration that another private residence of the Prince, situated in San Silvestro off the highest extremity of the Royal Park at Caserta, has been occupied by a high military official.

This occupation took place without either authorisation or previous notice.

In the event that General Wilson should confirm his intention, already hinted at, to establish his residence at Villa Maria-Pia, His Royal Highness would require:-

1. That the occupation would not take place before His Royal Highness was able to enter into residence of his apartment in the Royal Palace of the Quirinale at Rome. It appears that this was the intention of Gen. Wilson;
2. That arrangements be made forthwith to evacuate completely the Royal Palace at Naples and that facilities and materials be made available for the adequate repair and renovation of certain apartments by Italian Civil Engineers. Apartments would be required for His Royal Highness, his military staff and administrative staff, and for offices and services.
3. That an agreement be eventually arrived at whereby one of the cottages of the Villa Maria estate shall be at the disposition of the staff of His Royal Highness, in order that a custodian may be in residence. The custodian would be responsible for the preservation of the furniture, books, pictures and various objects which would not be required in connection with the accommodation of General Wilson and his staff.

As a result of the development of military operations, the forecasts changed, and the memo has not been forwarded.

Today, therefore, it seems necessary to examine the whole question again, because the present situation of His Royal Highness in regard to this residence, cannot be prolonged without offending the decorum of His House and without exposing the safety of His Person, in fact, the occupation of all the buildings at the park of "Villa Maria-Pia" except for that one where His Royal Highness has His Own apartments, does not permit Him to keep His Personal staff and servants with sufficient accomodation. It would like to point out that His Royal Highness cannot have with Him two of His adjutants because of the lack of room.

The presence of officers and O.R.s of Allied troops in the enclosure of the Villa could give the chance to a malintentioned person to get through the entrance-gate pretending to be an English or American soldier, so cancelling the measures enacted for the safety of the Prince.

Because of these considerations I beg you, my dear General, to present the delicate question of the residence of His Royal Highness, The Prince of Piedmont, to the High Command of the United Nations in order to settle it with the correct consideration.

I thank you for your authoritative intervention, and I beg you to accept my best regards.

Contrary to the belief of the Anglo-American authorities, the official and normal residence of His Royal Highness, the Prince of Piedmont, was and will be Naples and not Rome. During the greater part of the year His Royal Highness lived in the Royal Palace, but for short periods at Villa Maria-Pia, Possillipo.

It is generally known that the Royal Palace has suffered severely from aerial bombardment. The small section of the Palace which did not suffer damage from the air, has since been handled roughly by a succession of American, English, French and coloured troops; by whom the Royal Palace was regarded as being merely a barracks.

Theft and devastation of an unjustifiable nature were committed by the troops referred to.

For these reasons, with the exception of a few isolated rooms, the Royal Palace is no longer habitable.

Dealing now with the Villa Maria the position is that until quite recently the availability of the whole Villa Maria estate remained in the hands of His Royal Highness. It was nevertheless the intention of the highest American authorities to place the villa at the disposition of General Eisenhower.

Unfortunately at the time of entry of the American troops into Naples, an unidentified person acting without authority, stated that the villa was available, possibly with the object of preventing it from falling into unauthorised hands.

On January 1st 1944 three cottages of the villa estate were occupied by officers of varying grades, belonging to the armoured forces.

This occupation took place despite the fact that by this time His Royal Highness was in possession of a document stating that the premises were not available for requisition.

This document was issued to His Royal Highness by the Military Governor of Naples.

The largest of these cottages is still occupied by two English soldiers and from time to time by officers in transit.

Until now, though not without difficulty, it has been possible to retain intact the private apartment of His Royal Highness.

It is also necessary to take into consideration that another private residence of the Prince, situated in San Silvestro on the highest extremity of the Royal Park at Caserta, has been occupied by a high military official.

This occupation took place without either authorization or previous notice.

In the event that General Wilson should confirm his intention, already hinted at, to establish his residence at Villa Maria-Pia, His Royal Highness would require:-

1. That the occupation should not take place before His Royal Highness was able to enter into residence of His apartment in the Royal Palace of the Quirinale at Rome. It appears that this was the intention of Gen. Wilson;

3. That an agreement be eventually arrived at whereby one of the cottages of the Villa Maria estate shall be at the disposition of the staff of His Royal Highness, in order that a custodian may be in residence. The custodian would be responsible for the preservation of the furniture, books, pictures and various objects which would not be required in connection with the accommodation of General Wilson and his staff.
