SUBJECT: Accommodation and Maintenance of Refugees in French North Africa.

TO: Allied Force Headquarters, G-5 Section. 13.

1. Reference is made to your G-5: 383.7-18 of 15th June, the contents of which has been discussed with the Deputy Director, Displaced Persons Sub-Commission.

2. The following remarks refer to sections of para. 2 of your letter under reference:-

- (a) Copies of communications relative to the movement of refugees to, or the accommodation of, refugees in FNA Camp, will be addressed to or reported to HQ. North Africa District.
- (b) Accommodation for a maximum of 2000 persons in each SNF convey ex-Naples is possible and plans are being made on that basis.
- (c) Clothing for refugees in FNA. Arrangements are being made for clothing to be provided for refugees before they leave Italy, but this will necessarily be on a limited scale. It is suggested that provision should be made for repair work to clothing to be carried out in North Africa. Requirements will include needles, sewing cotton, thread, sewing machines, and cloth for patching. This arrangement has the additional advantage of providing an occupation for refugees as well as enabling them to keep respectably clad. 1892
- (d) Screening of refugees will be carried out automatically at the Transit Camp, Bari. Any further screening that may be necessary will be carried out under special arrangements to be made at averse.
- (e) It is noted that chronic cases and the seriously ill should not be evacuated to French North Africa. A ruling is, however, required regarding T. B. Cases, many of whom would probably benefit from the climate in North Africa, and also cases of "healthy amputees", by which is meant those persons minus an arm or a leg who would require no hospital treatment, and who are, to a greater or lesser degree, self supporting.

3. Nominal rolls will be prepared and refugee group leaders appointed on exactly the same lines as has hitherto been carried out for parties to Mideast.

Reference is made to the attached copies of Agenda
for, and Minutes of a Meeting held at AFHQ on 10 June
relative to the above project.

1. A copy of a paper on this subject submitted
by this Section to the Chief Administrative Officer on
5 June has already been forwarded to your Headquarters,
as has also a copy of our cable MAT 222 to the Combined
Chiefs of Staff in which plans for the accommodation
of refugees during the next 5 months are explained in
outline. The intention is that a camp for 10,000 and
hospital for 600 in the PHILIPPEVILLE area of French
North Africa (FNA) should be ready to receive refugees
by the end of July.

(a) Para 2.

It is intended that as soon as possible clothing shall be provided by UNRRA, or other civilian agencies, but until such time as this can be arranged it is requested that all necessary items should be supplied to refugees prior to evacuation from Italy.



1. Responsibility

Suggested that North Africa District should, below AFHQ level, be charged with responsibility for planning and supervision of the project.

2. Transportation

Decision is required as to whether shipping in SNE Convoys should be diverted to PHILIPPEVILLE or BONE for disembarkation of refugees.

If shipping is not to be so diverted G-5 consider it essential that refugees should be disembarked at ALGIERS. (II(a), and Appendix 'A').

3. Accommodation

(a) Should sites in the PHILIPPEVILLE area be agreed as most suitable location for refugee camps and hospital. (II(b)).

(b) If refugees are to be disembarked at ALGIERS can the camp site in the BONE area be earmarked for refugees in case of eventual need. (II(b)).

(c) Suggested that RE work should commence forthwith to prepare one camp site for 10,000, and hospital for 600 beds, in PHILIPPEVILLE area. (II(b)).

(e) Should the French authorities be asked to provide technical assistance at a later date in the maintenance of camp facilities and permanent structures. (II(b)).

4. Accommodation Stores (less Medical)

4. Accommodation Stores (less Medical)

(a) Approval is desired of the range, (less transport), and scale of provision of items listed at Appendix 'B' as a basis for planning, and that detailed lists and scales should be drawn up by FMA Refugee Control Headquarters, in conjunction with North Africa District, for approval of AFHQ.

(b) Are any items listed in Appendix 'B' in short supply.

(c) Suggestions as to the appropriate method of obtaining approval for, and supply of any other necessary items which may be required and which are not listed in Appendix 'B'.

(d) Suggested that tentage and accommodation stores (winter scale) should be obtained for 20,000. (II(b)).

5. Supplies.

(a) Recommended that one DID be permanently allotted. (II(c)).

(b) Suggested that supplies, including Ordnance, should be drawn on incident by North Africa District. (II(c)).

(c) Comments are invited as to the advisability of requesting the French authorities to supply petrol, oil, and lubricants. (II(c)).

(d) Ration Scale. Requested that G-4 will later advise as to a suitable ration scale, at the same time indicating which items should be obtained by local purchase. Recommended that North Africa District should be charged with local overall responsibility for supply of foodstuffs.

(e) Source of supply for food, probably from Army sources to begin with. Consideration to be given to provision by G-5.

6. Transport

(a) Recommended that one General Transport (GT) Platoon RASC be permanently allotted. (II(c)).

(b) Approval desired, as a basis for planning, of establishment of transport suggested in Appendix 'B'.

(c) Suggested that scale of transport, including ambulances, for hospital should be later submitted to G-4 for approval.

7. Security

(a) G-2 requested to indicate a firm date when the Security authorities will be ready to screen refugees in Italy prior to evacuation to FNA. (II(d)).

(b) If it should be necessary for camps to be wired in can military gate picquets be made available from British or U.S. military sources.

If not, should the French authorities be asked to provide personnel. (II(d)).

8. Personnel

(a) Approval is desired of the suggested establishment of military personnel as in Appendices 'C-1' and 'C-2'.

(b) Recommended that a decision should be taken as to which personnel shown as either military or civilian in Appendices 'C-1' and 'C-2' should be provided from military sources, and that military personnel

(a) Approval is desired of the suggested establishment of military personnel as in Appendices 'C-1' and 'C-2'.

(b) Recommended that a decision should be taken as to which personnel shown as either military or civilian in Appendices 'C-1' and 'C-2' should be provided from military sources, and that military personnel should be made available at a very early date.

(c) Requested that, should cookhouse staffs not be permanently available from military sources, necessary military personnel should be provided on a temporary basis and until such time as refugees have been satisfactorily trained to cook, and to operate cookhouses of first camp for 10,000 and hospital.

9. Medical

(a) In the event that UNRRA or other civilian assistance is

delayed, both in personnel and/or stores, can medical assistance be provided from military sources and, if so, on what scale.

(b) Should permanent invalids, chronic cases, and the seriously ill arriving in Italy be received in FNA or remain in Italy.

(c) Recommended that minimum essential military personnel, both on temporary and permanent basis, and on a scale to be determined later, should be provided for hospital administrative staff. (Appendix 'D').

(d) Hospital. Suggested that all tentage and accommodation stores, as opposed to medical stores, should, if necessary, be provided from military sources, British or U.S.

10. Finance

It is thought best that all financial arrangements, including allowances for refugees and methods of accounting, should be studied separately.

1. GENERAL

The ACTING CHIEF ADMINISTRATIVE OFFICER(A/CAO) directed that discussions should be on a basis of provision for 10,000 refugees, including 600 ~~of these~~ ITALY. In view of the present situation with some 3,000 YUGOSLAV refugees in ITALY, and with accommodation available for a further 10,000 in MIDEAST as soon as UNRRA assistance is provided, this was estimated as sufficient to meet probable requirements for the next 5 months. Maximum capacity in ITALY is 10/11,000 on a transit basis. At the end of 4 months the problem is to be re-viewed.

2. RESPONSIBILITY

The suggestion was put forward by G-3 that UNRRA should assume full responsibility at the outset. A/CAO and G-5 explained that it was uncertain when UNRRA assistance would be forthcoming and that to adopt this course would entail delay. NORTH AFRICA DISTRICT (NAD) expressed the wish that, if responsibility were vested in Headquarters NAD, full powers of control and command should be deputed by AFHQ.

It was agreed that Headquarters NAD should initially be responsible for the project with full powers of control and command. A/CAO directed that the question of final direction and control when UNRRA have assumed responsibility should be examined, and that NAD should later be advised on this point and on the relationship to be established with UNRRA.

M & TN (Sea) stated that refugees could be disembarked at BONE. Disembarkation at PHILIPPEVILLE could not be arranged. In the future convoy sailings may become irregular, and it should not be assumed that the present schedule of sailings would continue indefinitely.

It was agreed that refugees should be disembarked at BONE.

4. ACCOMMODATION

- (a) It was agreed that sites in the PHILIPPEVILLE area should be utilised.
- (b) NAD informed the Meeting that accommodation for 18,000 could be prepared in 3 weeks.
- (c) DMS suggested that site of 100 General Hospital should be utilised as a hospital for refugees. NAD confirmed that this was a hotted site and that no tents would be required.

It was agreed that the site of 100 General Hospital should be utilised as a hospital for refugees.

- (d) NAD confirmed that the transit camp at BONE was now ready and could accommodate 2,500 refugees.
- (e) A/CAO directed that the French authorities should not at this time be asked to provide assistance in the maintenance of camp facilities.

5. ACCOMMODATION STORES (LESS MEDICAL)

- (a) ORD.(B) handed to the A/CAO a paper covering items 4(a) and (b) of the agenda. (Copy attached hereto as APPENDIX 'A').

A/CAO agreed all points in the paper submitted with the exception of the reference made to Tents, Marquee, Hospital, Double which would not be required.

- (b) It was agreed that normal channels and procedure should be followed for obtaining supply of accommodation stores.

- (c) A/CAO directed that the question of providing tentage and accommodation stores (winter scale) for 20,000 should be considered at a future date.

6. SUPPLIES

- (a) S & T indicated that one DID could be made available. Discussion ensued as to the possibility of employing civilian, Yugoslav, or refugee personnel in order to economise in manpower.

A/CAO directed that (i) G-1(B) should endeavor to obtain the release of 250 Yugoslav military personnel now in FNA who have declared for MARSHAL TITO, and who could be employed in camp administration including detailed issue of supplies. (ii) One DID, or such lesser part as may be agreed by NAD, should be made available for 3 weeks from the date of arrival of the first group of

(d) NAD confirmed that the transit camp at BONE was now ready and could accommodate 2,500 refugees.

(e) A/CAO directed that the French authorities should not at this time be asked to provide assistance in the maintenance of camp facilities.

5. ACCOMMODATION STORES (LESS MEDICAL)

(a) ORD (B) handed to the A/CAO a paper covering items 4(a) and (b) of the agenda. (Copy attached hereto as APPENDIX 'A').

A/CAO agreed all points in the paper submitted with the exception of the reference made to Tents, Marquee, Hospital, Double which would not be required.

(b) It was agreed that normal channels and procedure should be followed for obtaining supply of accommodation stores.

(c) A/CAO directed that the question of providing tentage and accommodation stores (winter scale) for 20,000 should be considered at a future date.

6. SUPPLIES

(a) S & T indicated that one DID could be made available. Discussion ensued as to the possibility of employing civilian, Yugoslav, or refugee personnel in order to economise in manpower.

A/CAO directed that (i) G-1(B) should endeavor to obtain the release of 250 Yugoslav military personnel now in FNA who have declared for VARSHAL TITO, and who could be employed in camp administration including detailed issue of supplies. (ii) One DID, or such lesser part as may be agreed by NAD, should be made available for 3 weeks from the date of arrival of the first group of refugees; after which time detailed issue of supplies should be effected either by Yugoslav military, or by civilian personnel as NAD may arrange.

It was agreed that if possible G-1(B) should arrange for one officer and one interpreter to be included among the 250 Yugoslav military personnel, and that the question of payment of this detachment should be investigated.

(b) It was agreed that supplies, including Ordnance, should be obtained through normal channels.

(c) It was agreed that petrol, oil, and lubricants should also be obtained through normal channels, and that the French authorities should not be asked to arrange their provision.

(d) S & T stated that there was already in existence an AFHQ Ration Scale (No. 30) for refugees in Italy. This scale provided for modification for children, mothers, etc.

It was agreed that (1) refugees in FNA should receive rations in accordance with AF Ration Scale No. 3C, modified as necessary. (ii) That Yugoslav military, if assigned to refugee camps, should receive normal military rations.

(e) G-5 pointed out that to make special arrangements for the bulk feeding of a relatively small group up to a maximum of 40,000 would be uneconomical. If food was supplied from military sources some arrangement might be made whereby G-5 could make repayment in Italy. S & T stated that, if the Army was to be responsible for provision of foodstuffs, at least 3 months notice was required of any future increase in numbers over 10,000. This is necessary to permit due notice to be given to the War Office.

It was agreed that (i) supply of foodstuffs should be a military responsibility until such time as UNRRA could make alternative arrangements; (ii) the question of whether food would be required from the Army for any number of refugees over 10,000 should be decided before 1 August.

7. TRANSPORT

(a) G-4 (B) considered that the provision of a full GT Platoon RASC was unnecessary, and that in any event provision of transport by the Army should not be a permanent commitment. (See Agenda, para 6(a) and (b)).

It was agreed that (i) NAD should be responsible for the temporary provision of all necessary transport, including ambulances, and that UNRRA should be required to effect alternative arrangements as soon as possible; (ii) that 25 drivers should be included among the 250 Yugoslav military personnel whom G-1 (B) were to endeavor to obtain.

(b) DMS recommended that 3 ambulances should be provided for camp of 10,000 and 600 bed hospital.

8. SECURITY

(a) G-2 informed the Meeting that at present some 1,500 refugees per fortnight were being screened in ITALY, and that it was estimated that this total might be increased to 2,000 by the end of July. This was satisfactory provided that the French would accept the efficacy of such screening on arrival of refugees in FNA. Discussion then followed as to the advisability of exercising some measure of control over the inflow of refugees.

It was agreed that some measure of control over the inflow of refugees might be required, dependent upon accommodation and other facilities available, and that this point should receive the attention of G-5.

(b) It was made clear by several representatives present that no guards could be provided from military sources.

It was agreed that it would be inadvisable to make use of guards from French or PW sources, and that guards, if required, should be found either from the detachment of 250 Yugoslav military personnel, or from refugees themselves.

7. TRANSPORT

(a) G-4 (B) considered that the provision of a full GT Platoon RASC was unnecessary, and that in any event provision of transport by the Army should not be a permanent commitment. (See Agenda, para 6(a) and (b)).

It was agreed that (i) NAD should be responsible for the temporary provision of all necessary transport, including ambulances, and that UNRRA should be required to effect alternative arrangements as soon as possible; (ii) that 25 drivers should be included among the 250 Yugoslav military personnel whom G-1 (B) were to endeavor to obtain.

(b) DMS recommended that 3 ambulances should be provided for camp of 10,000 and 600 bed hospital.

8. SECURITY

(a) G-2 informed the Meeting that at present some 1,500 refugees per fortnight were being screened in ITALY, and that it was estimated that this total might be increased to 2,000 by the end of July. This was satisfactory provided that the French would accept the efficacy of such screening on arrival of refugees in FNA. Discussion then followed as to the advisability of exercising some measure of control over the inflow of refugees.

It was agreed that some measure of control over the inflow of refugees might be required, dependent upon accommodation and other facilities available, and that this point should receive the attention of G-5.

(b) It was made clear by several representatives present that no guards could be provided from military sources.

It was agreed that it would be inadvisable to make use of guards from French or P7 sources, and that guards, if required, should be found either from the detachment of 250 Yugoslav military personnel, or from refugees themselves.

9. PERSONNEL

(a) G-5 stated that it was the intention that all administrative and supervisory personnel should ultimately be found by UNRRA. A/CAO informed the Meeting that the Supreme Allied Commander had directed that the project should be established, and that a temporary military commitment must be accepted.

A/CAO directed that (i) suggested establishment as set out in Appendices 'C-1' and 'C-2' to the Agenda should be approved in principle; (ii) the first 3 personnel and CCS mentioned in Appendix 'C-2' should be found from British military sources; (iii) G-5 should prepare and coordinate a cable for despatch to the Combined Chiefs of Staff setting out requirements of UNRRA personnel in concrete form, and requesting that a nucleus, including an executive for organization, should be sent forward as soon as possible; (iv) NAD should examine the establishments suggested in Appendices 'C-1' and 'C-2' and

should submit final details to AFHQ for approval of the War Establishments Committee. In formulating final details of establishments NAD should ensure the maximum use of Yugoslav military personnel.

10. MEDICAL

(a) Personnel. DMS stated that military medical personnel could only be provided from existing units. In reply to a suggestion that medical personnel should be provided by the Partisan Forces, the A/CAO pointed out that there were insufficient even for Partisan wounded. The possibility of obtaining French assistance was examined but was not considered practicable. NAD recommended that use should be made of medical personnel from among Italian PW. The REPRESENTATIVES of the BRITISH RESIDENT MINISTER and the BRITISH REPRESENTATIVE with the CFLN saw no objection to this practice provided that Italians worked under British supervision. The need for female nursing staffs was also discussed.

A/CAO directed that (i) Minimum British military personnel, including 6 female nurses, should be provided on a temporary basis pending arrival of UNRRA personnel; (ii) remainder of medical staffs should be provided from Italian PW or other local resources; (iii) hospital for 600 beds should be established; (iv) General VELEBIT should be informed of the reason underlying the necessity for temporary inclusion of Italian personnel on hospital staff. (Action G-5).

(b) Stores. DMS indicated that it would be possible to provide essential equipment and stores from British military reserves, and from a pool of captured enemy stocks.

(c) Accommodation Stores. ORD(B) informed the Meeting that beds and other essential items could be provided.

It was agreed that until such time as the hospital in FWA was established, permanent invalids, chronic cases, and the seriously ill should not be evacuated to FWA.

A/CAO directed that NAD should prepare, in conjunction with the appropriate authorities, a temporary establishment of British military personnel for assignment to the hospital. This establishment is to be submitted to AFHQ for the approval of the War Establishments Committee.

A/CAO agreed that all financial arrangements should be studied separately.

11. OTHER BUSINESS

(a) NAD requested that they might be provided with necessary facilities and be permitted to effect all arrangements.

A/CAO in directing that all agencies should deal with camps and all matters pertaining thereto only through NAD referred to his previous direction regarding NAD responsibility for, and command and control of the project.

(b) NAD drew attention to the temporary nature of the military commit-

A/C/O directed that G-5 in informing the Combined Chiefs of Staff of requirements from UNRRA should indicate that the military commitment could not be contemplated after 1 October.

(c) The REPRESENTATIVE of the BRITISH RESIDENT MINISTER suggested that experienced UNRRA/MERRA personnel might be obtained on loan from MIDEAST to assist in initial organization. G-5 indicated that such a request had already been put to MIDEAST but that it had been stated that intimation would be given later when personnel would be required.

A/C/O directed that G-5 should request MIDEAST to despatch the 2 UNRRA/MERRA personnel for whom application had been made as soon as possible by air.

(d) MAD enquired as to method of administering justice to refugees.

It was agreed that this matter should be explored, and that the advice of UNRRA/NERA personnel as in (c), above, should be sought.

(e) The REPRESENTATIVE of the BRITISH RESIDENT MINISTER enquired as to when it was desired that the proposal that refugees should be accommodated in FMA should be put to the French authorities, and whether it was desired that approach should be made to the French now, or at a later time.

L/CAO requested the REPRESENTATIVE of the BRITISH RESIDENT MINISTER to ensure that the proposal was laid before the French authorities as soon as might be possible.

(f) The REPRESENTATIVE of the BRITISH RESIDENT MINISTER suggested that both the Offices of the British Resident Minister and of the American Political Adviser should follow up all cables concerning UNRRA participation addressed by AFHQ to WASHINGTON through their own channels, and should endeavor to assist in the procurement of UNRRA assistance.

L/CAO expressed his thanks for this offer of aid and requested that such steps should be taken.

The above Minutes have been approved by the Acting Chief Administrative Officer who has directed that action should be taken as therein indicated.

SUBJECT: Accommodation and maintenance of refugees in FNA

TO : HQ, A.C.C. (Attention: R.C. and M.G. Section) *7*

Reference is made to the attached copy of a paper by this Section dated 5 June 1944, subject as above.

1. The Supreme Allied Commander has directed that planning shall proceed for the accommodation and maintenance of refugees in French North Africa (FNA). A request has been made for assistance by UNRRA and it is anticipated that help, both in the form of personnel and stores, will be forthcoming.

2. Concurrently with planning at this Headquarters you will no doubt wish to make preparations in Italy. In this connection attention is drawn to Appendix 'A', para 2 (b) of the attached paper. If, as is expected, it will be necessary for refugees to be disembarked at Algiers it will be essential that their numbers shall not exceed 2,000 per convoy. Were refugees beyond this total to be disembarked it would not be possible to entrain them on the day of disembarkation, and facilities will not permit the operation of a transit camp in the Algiers area.

3. We shall, if you agree, be sending an officer in the course of a few days to obtain such information from the Displaced Persons Sub-Commission as is available, which would be of assistance in planning the administration and supervision of the project. It will be a great help if the Sub-Commission could be asked to give the officer all possible facilities, including an opportunity to visit the Camp *1873* see exactly how you have succeeded in tackling the problem at your end.

4. It should be noted that arrangements for the reception of refugees in FNA are unlikely to be completed before the end of July, and that until such time as these arrangements are made refugees arriving in Italy will have to be held in that country, less those who may be sent to Egypt so soon as UNRRA medical assistance is received in the east and the temporary restriction on evacuation from Italy to that area is lifted.

I. Problem.

- (a) To arrange accommodation and maintenance of refugees ex Yugoslavia over and above the total of 40,000 agreed for acceptance by Mideast.
- (b) To be prepared on a larger scale to accommodate and maintain refugees from other European countries received in Italy and elsewhere in the Mediterranean Theatre during the next 6 - 9 months.
- (c) To decide whether refugees as in (a) and (b) should be held in Italy, or moved to Mideast or French North Africa (FNA).

II. FNA.

Replies received to our memorandum MGS 383,7-2 of 4 May, and subsequent discussions, have provided data as follows:

(a) Transportation.

For details see Appendix 'A' (Tab 'A'). Decision required as to whether shipping in SNF Convoys should be diverted to PHILIPPEVILLE or BONE. Main camp sites will probably be located in PHILIPPEVILLE or shipping is not to be diverted as above it is considered essential that refugees should be disembarked at ALGIERS. Recommended that Allied Red Cross and other civilian welfare agencies in ALGIERS should be invited to assist in reception of refugees if disembarked in ALGIERS port.

On arrival refugees at PHILIPPEVILLE, whether by sea or rail, road transportation will be required for movement to camps.

(b) Accommodation.

PHILIPPEVILLE Area. Accommodation sites available for approximately 40,000, including some buildings suitable for hospital. Location of sites will permit organization of camps for 10,000, which is considered most economical size for administration. As certain PE work is necessary on semi-permanent structures at least six weeks' notice is required before first camp for accommodation of 10,000 could be ready.

BONE Area. Camp site with capacity 10,000. If refugees disembarked at BONE would be required as transit camp. Location is near Italian PW and Yugoslav military camps.

Maintenance of semi-permanent structures after initial installation by RE could largely be effected by refugees. Some technical assistance, i.e., plumbing etc, might be required. Suggested that the French authorities might be asked to co-operate.

(c) Accommodation Stores, Supplies, and Equipment.
Schedule of principal items required, less medical, attached at Appendix 'B' (Tab 'B').

Accommodation stores and blankets (summer scales) are available for 36,000 in FNA. Tentage for 12,000 only is immediately available.

In addition to items enumerated in Appendix 'B' the following would also be required:

- One DID (complete)
- One Platoon CT Coy, RASC

Supplies, including Ordnance, would presumably be drawn from ALGIERS on in-
dent. Arrangements might be made to obtain petrol, oil, and lubricants
locally from French.

(d) Security.

Understood from G-2 that effective arrangements cannot be com-
pleted before 1 July for screening refugees prior to evacuation from Italy
to FNA. No adequate facilities exist for security screening of large numbers
in FNA.

After arrival screened refugees in FNA G-2 would not require
camps to be guarded by military. It is probable, however, that the French
authorities would require camps to be controlled in order to prevent movement

Planning should be on basis of 1,200 bed hospital, centrally located to serve all camps. At commencement 600 bed hospital should be established. Details of suggested medical arrangements, and of establishment of medical personnel, are attached at Appendix 'D' (Tab 'D').

No medical personnel or stores are available from British or U.S. military sources. Application has been made to Combined Chiefs of Staff for UNRRA for medical personnel. It is suggested that medical equipment and stores should be added to this request.

Disposal of the infirm and permanently unfit is to be decided. It is for consideration whether these should not remain in Italy.

III. Italy.

On operational and other grounds, it is not considered desirable at this time that large numbers of refugees should be accommodated on a permanent

basis in Italy. It is considered, however, that the possibility of accommodating such persons in that country at a later time should be investigated.

IV. Mideast.

Difficulties in arranging the acceptance of further refugees in Mideast, above the total of 40,000 already agreed, are considered excessive. Considerable numbers from the Aegean and other territories being already accommodated in Egypt and elsewhere.

V. Recommendations.

- (a) That the draft plans for camps in the PHILIPPEVILLE area of FNA should be approved, and that preparations should commence forthwith for the establishment of the first camp for 10,000 and for a 600 bed hospital.
- (b) That on this basis, if approved, North Africa District be required to plan to provide accommodation and other necessary facilities, and that minimum military personnel essential for this stage in the development of the project should be made available.
- (c) That the British Resident Minister and the American Political Advisor should now be asked to invite the British and American Representatives with the CFLN to refer the FNA project to the French authorities upon whom certain responsibility may ultimately devolve.
- (d) That G-5 be charged with responsibility for co-ordination and overall supervision of the FNA project, and are authorized to set up an executive subsection to handle the matter.
- (e) That the possibility at a later date of accommodating refugees received in Italy within that country should be examined.
- (f) That the advisability of establishing near AFHQ a body whose general functions should include advice and overall supervision on all refugee problems arising within the Mediterranean Theatre should be explored by G-5, and that G-5 should be required to prepare a paper on this matter for submission to the Political Committee.

MOVEMENT OF REFUGEES

1. Sea

(a) SNF Convoys sail from NAPLES for ORAN and ALGIERS twice per month. Up to 7,000 refugees could be transported in each convoy. ACC have requested that numbers should be limited to a maximum of 5,000 on any one convoy, and estimate that the total of refugees likely to be evacuated is 4,000 per month as long as hostilities continue in Yugoslavia.

(b) Administration in FNA would be facilitated if refugees could be disembarked at PHILIPPEVILLE or BONE, in preference to ALGIERS or ORAN. From the movements side the following are among the factors involved:

i. If shipping were diverted to BONE or PHILIPPEVILLE it would be necessary to rail military personnel destined for Italy by returning ships to those ports, as time would not allow ships to be sailed to ALGIERS or ORAN after disembarking refugees.

ii. Small ships only can use PHILIPPEVILLE harbour. Understood that port facilities, particularly Naval, have been largely removed.

If refugees disembarked at ALGIERS, ACC should be directed to limit numbers to 2,000 per convoy.

SUBJECT: Accommodation and maintenance of refugees in FNA

TO : HQ, A.C.C. (Attention: R.C. and M.G. Section)

Reference is made to the attached copy of a paper by this Section dated 5 June 1944, subject as above.

1. The Supreme Allied Commander has directed that planning shall proceed for the accommodation and maintenance of refugees in French North Africa (FNA). A request has been made for assistance by UNRRA and it is anticipated that help, both in the form of personnel and stores, will be forthcoming.

2. Concurrently with planning at this Headquarters you will no doubt wish to make preparations in Italy. In this connection attention is drawn to Appendix 'A', para 2 (b) of the attached paper. If, as is expected, it will be necessary for refugees to be disembarked at Algiers it will be essential that their numbers shall not exceed 2,000 per convoy. Were refugees beyond this total to be disembarked it would not be possible to entrain them on the day of disembarkation, and facilities will not permit the operation of a transit camp in the Algiers area.

3. We shall, if you agree, be sending an officer in the course of a few days to obtain such information from the Displaced Persons Sub-Commission as is available which would be of assistance in planning the administration and supervision of the project. It will be a great help if the Sub-Commission could be asked to give the officer all possible facilities, including an opportunity to visit the Camps to see exactly how you have succeeded in tackling the problem at your end. 1862

4. It should be noted that arrangements for the reception of refugees in FNA are unlikely to be completed before the end of July, and that until such time as these arrangements are made refugees arriving in Italy will have to be held in that country, less those who may be sent to Egypt so soon as UNRRA medical assistance is received in the East and the temporary restriction on evacuation from Italy to that area is lifted.
