SUBJECT: Patents and Registered trademarks

TO : R. C. & M. G. Section
(Attn.: Capt. Morden)

1. The attached correspondence is returned to you for action.

2. It is the desire of the Italian Government that fees and taxes on patents and registered trademarks be accepted by any office of registry in AMG territory as is now the case in King's Italy. Likewise, it desires that applications for patents and trademarks received by the Uffici e Consigli Provinciali Dell'Economia should be forwarded in sealed envelopes ~~inclosed~~ in larger plain envelopes, addressed ~~as indicated~~ in the copy of the letter of the Ministry of Industry, Commerce and Labor attached. The instructions of the Italian Government, in the first instance, have been addressed to the Uffici Provinciali Dell'Economia e Camere di Agricoltura, Industria e Commercio, and, in the second instance, to the Uffici e Consigli Provinciali dell'Economia. It is therefore suggested that similar instructions be forwarded to like agencies through regional channels, if the R. C. & M. G. Section concurs that these regulations are to be made effective in AMG territory.

3. The Finance Subcommittee has been consulted and is in complete accord with the proposal that these purely administrative regulations have effect in AMG territory.
