Mr. Weber when requested about the reason of the said order declared not to be aware of.

Therefore we think it advisable to furnish the A.M.G. with the following informations regarding the Company. Further details will be given if requested:

In summer 1941, after the occupation of the Greek territory by the Italian troops, the alimentary conditions of the country and particularly of the town of Athens, appeared to be more and more difficult; starvation and illnesses were causing great losses among the civil population, whose conditions were becoming day by day more unbearable.

Consequently it was decided by the Italian authorities to relieve the Greek population through periodic shipments of wheat and other commodities.

In order to carry out this program, early in September 1941 was established the "Società Anonima Commerciale Italo-Greca" (S.A.C.I.G.) with a capital entirely advanced by the Italian State Treasury; the presidency of the Company was intrusted to H.E. Count Viola di Campalto-Royal Ambassador at disposal who at the time was in Athens as a member of the International Financial Commission of Control of the Greek Public Debt.

During the first ten months of its activity S.A.C.I.G. succeeded in exporting to Greece 65,000 tons of wheat, which was practically subtracted to the Italian civil population although the latter was already hardly pressed by lack of food. We trust that the Allied Authorities will re-examine the matter and revoke the order of seizure.
