Fin dal 21 maggio 1944 Subiaco era stata una vera oasi di pace tra l'infuriare della guerra. Nessun allarme, nessun bombardamento, nessun avvenimento militare di una certa importanza. La sofferenza di Subiaco era solo intima, per la situazione dolorosa in cui si trovava per il dominio tedesco, e più ancora, dai primi di marzo, per la presenza delle truppe repubblicane che sono state per noi fonte di tanti guai, culminati nell'uccisione tragica del giovane Valente Giulio di Antonio verso la metà di maggio, perchè tentava di sfuggire alla pattuglia di rastrellamento.
