The attention of all Company Commanders conc reed is directed to par 16, and 1d, Sect I, AR 310-10 which reads essentially as follows: "lb. The routine orders of the Nar Department -- Regiments, Battalions, and Squadrons not organized into regiments --- are designated "Goneral Orders", "General Court-Martial Orders", "Special Court-Martial Orders", and "Special Orders". These will be numbered consecutively in separate series for each calondar yoar". "Orders on routine matter issued by a commander of a battalion forming part of a regiment and serving therewith, or of companies and detachments will be designated as "Orders" and will be numbered in a single series for each calendar year". 2. In order to prevent further confusion in maintaining regimental locator cards and records for American Personnel, companies and detachments are authorized to issue "Orders" only covering the following situations: a. Pronotions (Private First Class only) b. Assignment of duties within the company or detachment, (Except COs of Cos and Dets who will be appointed by Regimental Special Orders upon recommendation of the Regional Commissioner). c. Travel of Hilitary Personnel on official business for trips involving the use of motor transportation and rail trivel only. Request for Travel Orders for Air or Sea Travel will be submitted to this Hq for approval and publication in Regimental "Special Orders". Requests for "Special Orders" involving Air, or Sea Travel will be submitted to this Hq, as far in advance as practicable. If travel must be performed immediately, letter Travel Orders based on authority this Mq, and cited therein, for Air or Sea Travel for outlying companies, i.e. Sardinia and Sicily, can be published by the Company Commander concerned, and copies of such orders forwarded to this Hq. d. Other situations specifically authorized by this headquarters. 3. Transfers from one company to another within this regiment, or to another orgenization will be approved and published in "Special Orders" this Hq. In cases where transfers must be made quickly by verbal orders, confirmatory orders will be 7084 RESTHICTED

requested. Special Orders placing military personnel on detached service with other companion will be approved and published by this headquarters.

4. It is directed that each company or detechment commander in 2675th Rogt, ACC, take the necessary action without delay to comply with the above instructions, and issue "orders" showing the appropriate company letterhead. Example: Headquarters, Co "A", 2675th Regiment, ACC, APO 394. This liq will appear on Distribution for Information.
