Subject is Immigration to Canada. Canadian immigration regulation permit admission to Canada of nationals of continental countries who are :

- A. Wife, unmarried son or daughter of fiancée of person legally resident in Canada, providing arrangements for settlement satisfactory at destination
- B. Father or mother, unmarried brother or sister, orphan (bereaved of both parents) nephew or niece under 16 years, of person legally admitted to and resident of Canada, who is in a position to receive and care for such relatives.

This scheme applies to eligible refugees and displaced persons except persons who were Citizens of and resident in Soviet Russia on 1 September 1939 and Germans both of whom are excluded.

GHQ CMP are bringing foregoing to notice of all PW/SEP in their charge. Urge parallel action by you in respect to persons in D F Camps under your control, and report of results to this Headquarters.

1. Approval has now been given to the formation and despatch of screening Commission object of which is to assist in dissolving the Sep/DP problem in Italy by (A) Isolating quislings war criminals and other wanted person liable for forcible repatriation to countries of origin. (B) Establishing those likely to be acceptable Iro or interim organisation (C) isolating those elements capable of organising opposition to policy of HMG. (D) persuading as many dissidents as possible to return to their country of origin (E) reporting and recording any other information as directed (F) making recommendations as to disposal of those screened.
2. Commission is qualified mainly to screen Yugoslavs it should be utilised to screen such other categories of DP or SEP as you in consultation with the head of commission may think of. Detailed instructions for completion task in para 1 will be issued by you direct to head of Commission.
3. Commission will be composed of 12 (15?) members each with own secretary all of officer status plus 2 additional officers for HQ Staff also 1 civilian confidential messenger of or status. Brig FHR Maclean MP for time head of British mission to Yugoslavia is head of commission he is being recalled to military service for this duty. Secretarial staff and members are mainly civilians but will include 2 or more serving officers. Head of commission will have nominal roll.
4. A party of 3 and Captain Lees estimated time of arrival by air 26 Jan 47.
5. Main body of 26 under Brig Maclean Eto Simplon express 1 (?) Feb remainder will be despatched subsequently as available.
6. Civilian member being given 6 months contracts. Question of responsibility for commission after allied evacuation of Italy is under consideration and instructions on this subject will be issued later.
7. Your FX 74537 25 Jan 47 to GHQ copy received. Grateful you oblige in due course completion all arrangements for commission.
8. Head of commission is being given copy of above instructions.

Para 6°)- New subject. Abolition of Allied Commission will materially affect functions of Advisory Council for Italy as set forth in FAN 280.

Paras 5°, and 7° of that signal will no longer be applicable in their present form and machinery of control in Italy, referred to in paragraph 4, is now greatly relaxed. In addition, on abolition of Office of Chief Commissioner, there will be no one to present to Council the reports on Italian Affairs which it has hitherto received, nor will there be the staff to compile such reports. 1. After "R" day no Allied machinery or authority will exist for the allocation of food and other disease and unrest supplies now being furnished by the OCS to Udine Province and zone A , Venezia Giulia it is therefore essential that all shipments designated for AMG territory shall arrive in time so that distribution can be completed by "R" day.
2. It is my view that after "R" day I have no responsibility for feeding or otherwise maintaining any civil territory. It is my opinion however that the territory now being maintained by OCS will suffer want unless a substantial supply of essentials remains in the various areas at the time sovereignty passes. This is particularly applicable to TFF. The free state has practically no indigenous supplies, and unless provisioning is arranged for, and actually on hand, at turnover , it will get off to a very bad start. Allied Troops will be stationed in Udine Province for a considerable period after "R" day. While I have every confidence that Italy and Unrra will do their best to fill the gap it would be a bad publicity for us to leave bare lander. AMG territory has lived a hand to mouth existence from the beginning. There is now no reserve stock of food. Coal is practically exhausted and industries are closing down for lack thereof.
