Unless they are members of the regular Army or volunteers as provided in changes to 2 RR rpt RR 1-1 as amended, enlisted men who are fathers with 3 or more dependent children under 18 years of age are eligible for discharge upon their own application, effective 1 December 1945 as announced in W X 83226 and F X 53566.

Approval by Commanders will be based upon evidence of dependency available in the field and if other sufficient documentary evidence is not rpt not available may accept in affidavit of dependency sworn to by the applicant. Enlisted men including personnel on the scarce category list who are fathers with 3 or more dependent children under 18 years of age will be afforded an opportunity to apply for discharge prior to their embarkation for overseas destination and will not rpt not be shipped overseas if they apply and qualify for discharge, effective immediately except for regular Army personnel and volunteers as provided in change page 2 of RR rpt RR 1-1 as amended of.

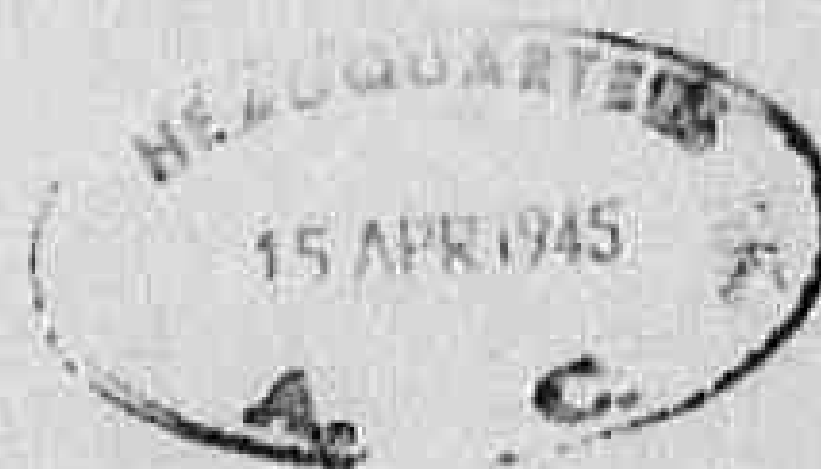

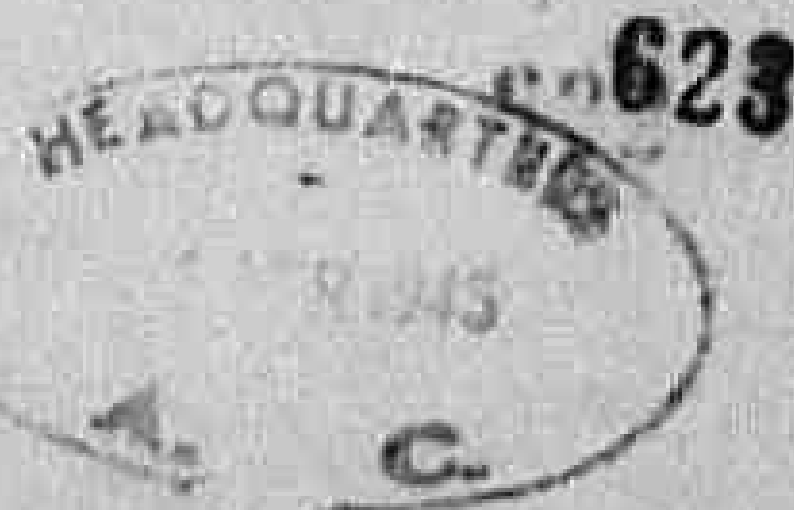

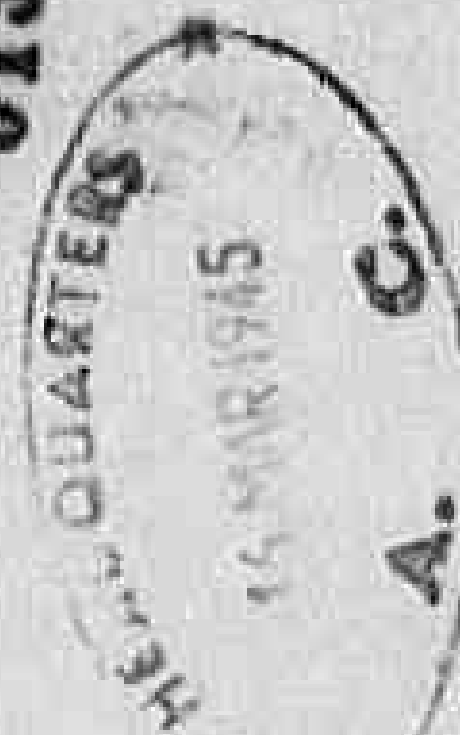

1. Reference your letter of 16 February, subject: "Rotations of American Officers", file: 13015/F, 1st Lieut. E. A. Suben will not be considered for rotation for reasons given in Colonel Uhler's note. -25

2. Some time ago, Captain Forster, together with about fifty other American officers, submitted an application for transfer in view of the War Department letter of 9 Oct. 44, subject: "Request for Approval of War Department Table of Organization for Military Personnel for Contract Settlement and Property Disposal on 'V Day'." file: AG 320.2 (28 Aug 44) OB-S-A-M. These applications were forwarded from this headquarters "not favorably considered". It is understood that G-5 had these applications indorsed to the War Department, stating that the officers were necessary for operations in this theater, but that if the War Department felt that military necessity demanded their use elsewhere it was up to them to make the decision. Consequently, the first knowledge that this headquarters had of Captain Forster's orders was when they were received at this headquarters on 2 February. These orders were transmitted through command channels to the officer concerned.

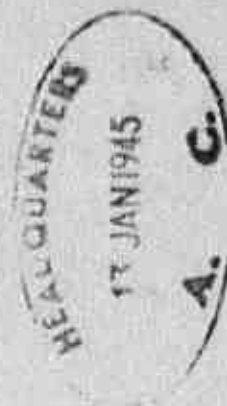

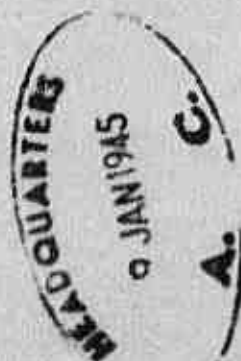

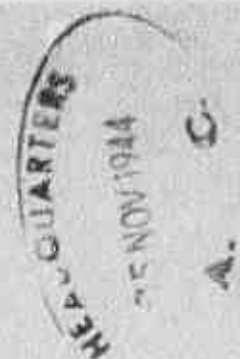
