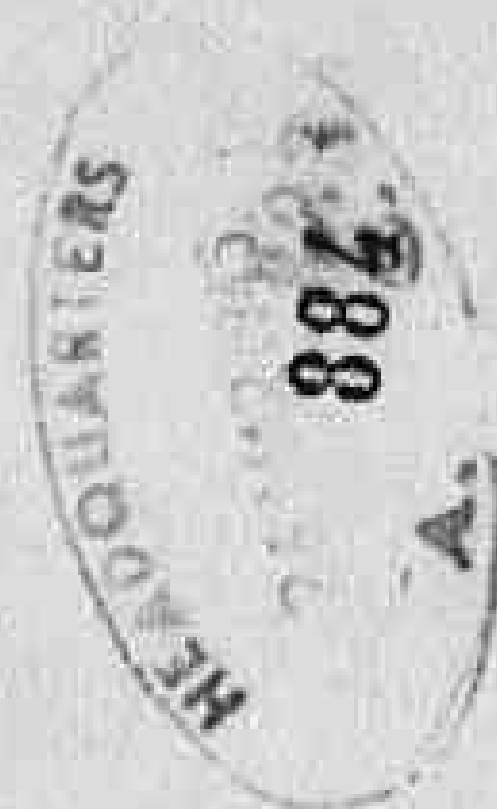

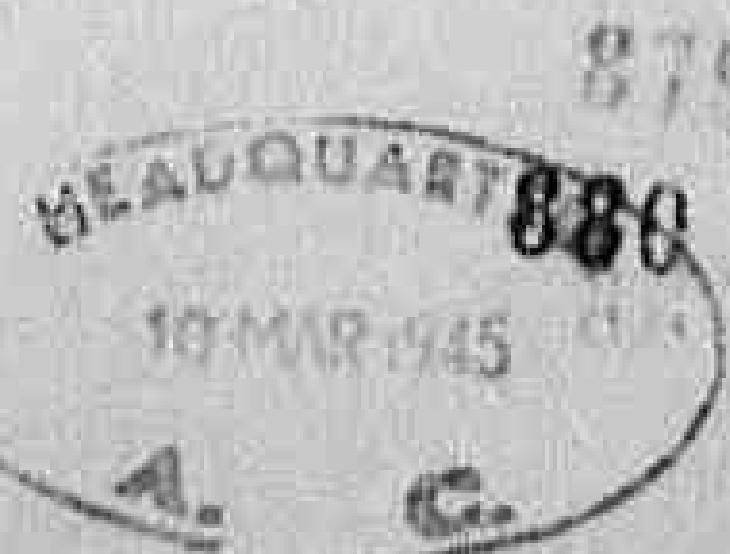

Colonel Fiske has asked me to reply to your letter to him of the 20th, about your wishing to travel to Ghent and Courtrai.

He states that there would, of course, be no objection to your making an official request. 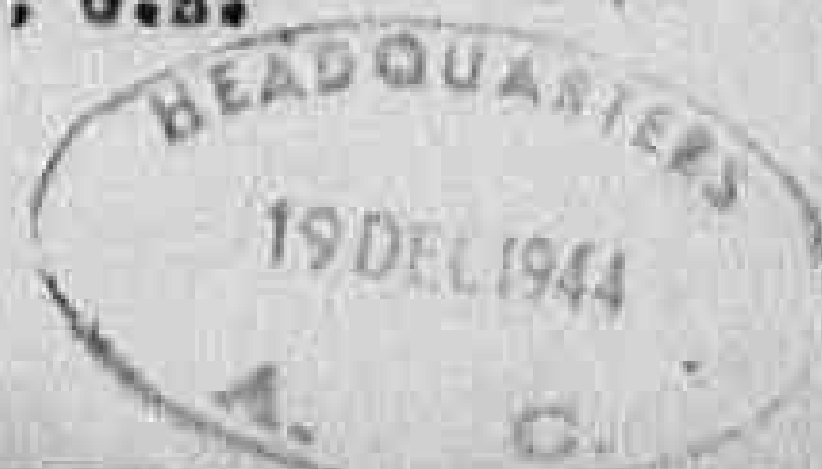

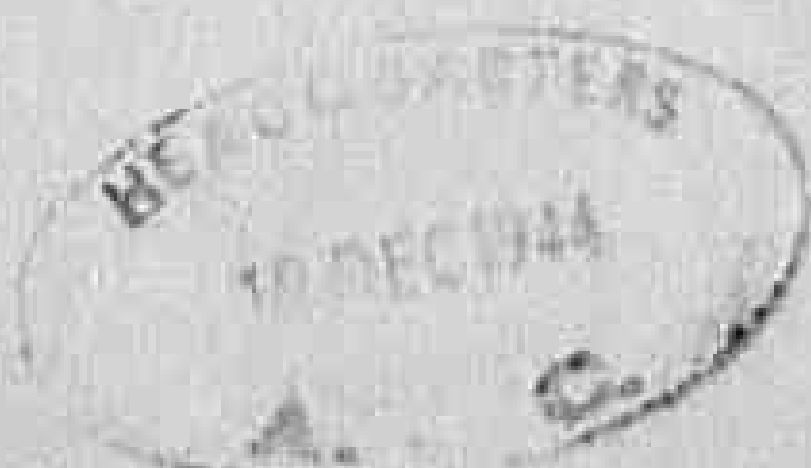
