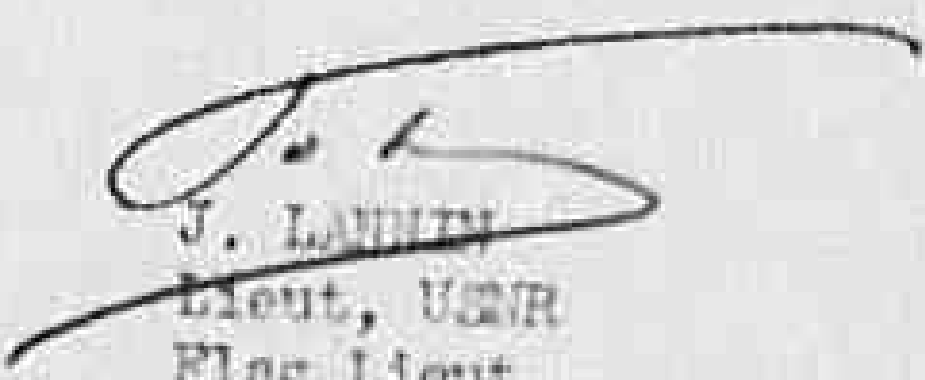

Please give following message sent immediately to Field Marshal Alexander from Macmillan.

Begin.

The Chief Commissioner informed me this morning that as a result of the decision to entrust the greater part of the American sphere of Austrian occupation to SHAF, an order has been received by General Macarney to send immediately to SHAF 124 U.S. officers originally belonging to A.C./A.M.C. for civil affairs. These fall into four groups.

(a) 39 officers attached to Fifth Army and 2 to the Eighth Army for Allied Military Government purposes as the army moves forward.

(b) 37 officers belonging to Allied Commission who will be dropped off by the army as it moves forward for A.M.C. work in forward areas.

(c) 36 officers transferred to the permanent planning staff for Austria and now in the Naples area.

(d) 10 officers similarly transferred but temporarily made available to A.C. and now employed in Italian Government territory, rear regions, and H.Q. A.C.

2. A suggestion has been made that SHAF's needs might be met for the time being by surrendering officers in (c) and (d) but retaining for Italy those in (a) and (b). The Chief Commissioner and I are very alarmed at the effect upon the carrying out of the order as received by SHAF since it would destroy the whole plan which has been made for the occupation of Northern Italy. It would be a major disaster.

3. The British and American Ambassadors who were present at this meeting are naturally not concerned with the military side but are gravely preoccupied with the political ill effects which would follow from this decision. You know how worried we all are already about the political dangers in the North of Italy upon liberation.

Would you consult with General McArthur and see whether he will agree to the proposed compromise measure and send an agreed telegram to the GCS from yourself and him setting out the position and asking urgently for reconsideration of the order. It is not within my province, but I cannot help feeling that STAFF could produce additional bodies, especially from those originally allocated for work in France.

5. I feel that you have a right to take a position since the ultimate responsibility for law and order and efficient administration in Northern Italy rests on you.
