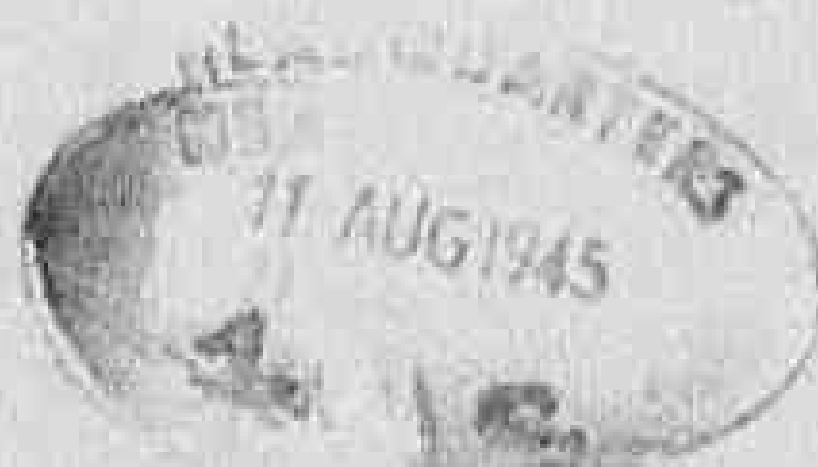

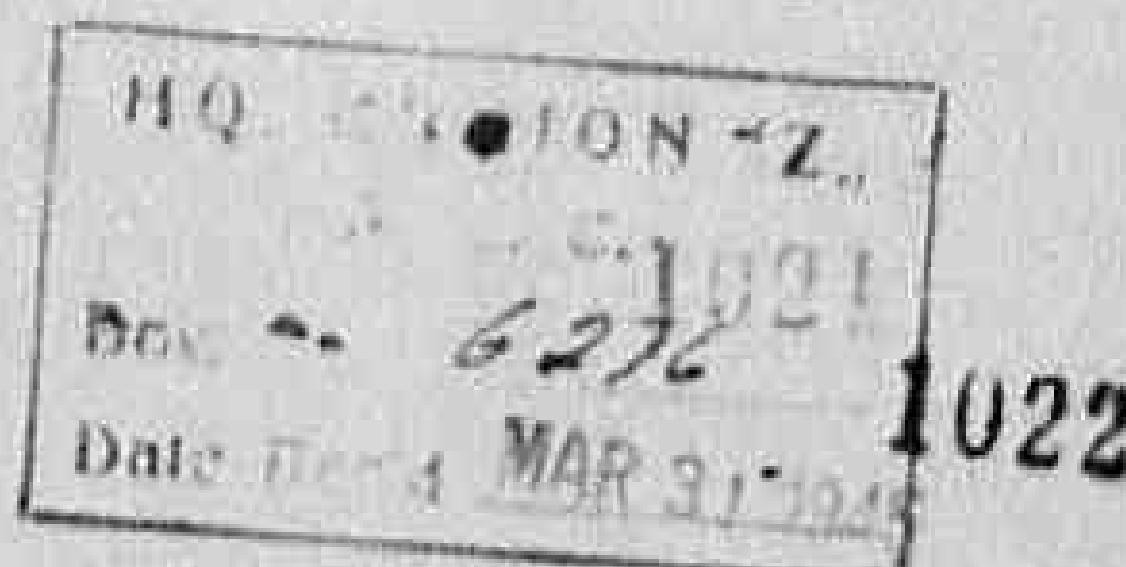

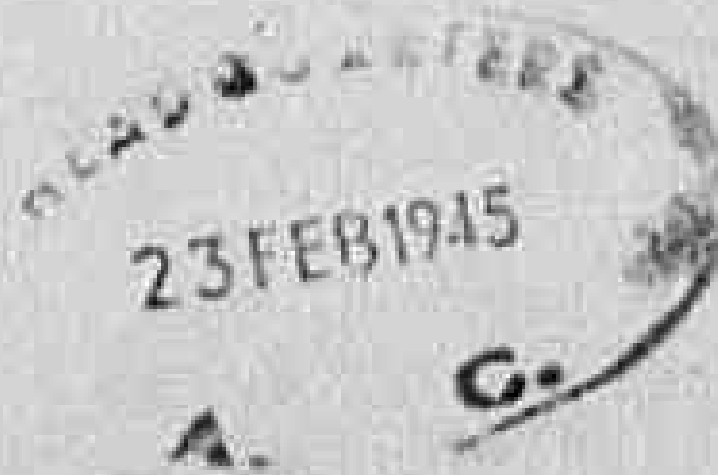

1. Your mimeographed letter 23/38/EST, 24 January 1945, Subject: "Visits of Regional Commissioners to Headquarters Allied Commission" has been received.

2. I have invariably, upon arrival at Headquarters Allied Commission, made contact promptly with the offices listed in sub-paragraph 1 a of the letter, and shall continue to do so.

3. The requirements of sub-paragraph 1 b are more difficult to observe, as I usually visit HQ A.C. in the course of a tour covering the 5th Army area, headquarters of the five provincial teams co-operating with 5th Army, and other places. This trip must necessarily be elastic and I cannot usually determine when I will arrive at main headquarters of the Commission, until the day before my arrival.

4. I customarily thereupon call my Rear Headquarters and ask them to make hotel reservations for me. In the future, it will also be S.O.P. for them to notify the sections enumerated on your list.

5. I again call your attention to the fact that I do maintain a full-time rear headquarters in room 39 on the first floor of the Ministero delle Corporazioni annex building, telephone 418. There is always one officer and one clerk located at that place and information as to my movements, and the probable date and time of my next contemplated arrival, can usually be most readily determined through that office. Other items of business with the Region can also often be handled most expeditiously and conveniently through this channel.
