The following extract from the minutes of the Executive Commissioner's meeting of 21 September is passed to you for your information:

X X X X

"6. Handover of Territory. Mr CA said that the normal time for the handover procedure was twenty-one days. He said, however, that it could be done in ten to fourteen days. It was agreed by all that to push the handover was a mistake and that it might be necessary to make the date say 10 October. Polans said that at least we should get out an announcement of the handover in September. EX C agreed that this was sensible. EX C would go ahead with the preparations and EX C would discuss with CA.

"With regard to Udine, a press release should be drafted, and EX C asked PMO to coordinate with CA Dec on this. This, and the handover announcement, should be studied by Polans, and would then be passed to CC for approval."

"6. Handover of Territory. Mr CA Sec said that the normal time for the handover procedure was twenty-one days. He said, however, that it could be done in ten to fourteen days. Polada said that at least we should get out an announcement of the handover in September. Ex C agreed that this was preferable. CA Sec would go ahead with the preparations and Ex C would discuss with CO.

With regard to Udine, a press release should be drafted, and Ex C asked PBC to coordinate with CA Sec on this. This, and the handover announcement, should be studied by Polada, and would then be passed to CO for approval."




