MEMORANDUM

TO : SO to Chief Commissioner (Major Quayle)

1. In response to your personal request, the matter of disquisitioning Dr. Marcello Perez' car has been thoroughly investigated by the Establishment Section and this office. From a technical standpoint, the vehicle was requisitioned in a strictly orthodox manner, and it is now being used by the Headquarters Commandant of the Lazio-Umbria Region. The question of Dr. Perez' professional need for the car, I believe, has been adequately answered. The attached file contains certificates from leading members of the medical profession in Rome and vicinity as to the high level and extent of Dr. Perez' professional activity. It is recommended that the car be returned to the owner.

2. This investigation has disclosed one disquieting fact. It appears that the Director of the Public Health Division of the Region, Lt Col O. J. Bizzozero, in the course of his activities has certified extensive lists of local doctors who are permitted to obtain vehicle circulation permits. On one such list Dr. Marcello Perez' name appeared (see inclosure 1). Such certification in effect indicates that the doctors whose names appear on these lists require personal transportation in the performance of their professional activities. However, in a statement which Colonel Bizzozero made (inclosure 2), he stated that his certification to such circulation permit lists in no way indicated that the doctors thereon needed transport in order to perform their duties. In fact, he further stated that, in his opinion, it was not essential for Dr. Perez to have a vehicle. Such a statement and attitude appear quite inconsistent with straightforward dealing.

3. The question may be raised as to just how many doctors whose names have appeared on lists countersigned by Colonel Bizzozero and who have obtained vehicle circulation permits and are operating cars on such basis actually need such use of transportation. It would have been more consistent with straightforward dealing to have scrutinized the lists and eliminated therefrom those doctors to whom, in the opinion of the Director of the Public Health Division, the possession of a vehicle was not essential. The indiscriminate certification and countersigning of lists which permit the individuals thereon to obtain circulation permits and accordingly retain and

operate vehicles should be stopped. It is therefore recommended that this fact be brought to the attention of the Public Health Subcommission from the top level. Such action on the part of AG officers tends to lower materially the prestige of the Commission in the eyes of the Italian people.

Acting on your instructions I have investigated this subject in conjunction with the letter from H.Q. Allied Commission, reference 93/47/XST dated 21 December 1944, and the various enclosures.

The investigation falls into two parts. Normally any decision that is necessary could be made on the two statements (Appendix A and Appendix B) which show that the vehicle is properly requisitioned, and that the Director of the Public Health Division was properly approached for a decision as to whether or not the vehicle was essential to its owner.

On this I am able to say that I can find no grounds to support any accusation of improper behaviour by any Allied Officer.

However, the matter cannot be left there because the whole affair has been turned into a personal matter so far as Lieut. Randolph Corvini is concerned. Moreover it would seem that, somewhat surprisingly, the statements against this Officer have been accepted at their face value without any question. It is therefore necessary to pursue it further and investigate the statements made in the Memorandum enclosed with the A.C. letter.

This part of my investigation is attached as Appendix C.

The conclusion from this is that Lieut. Corvini is in no sense guilty of improper behaviour. He was at all times acting properly on behalf of this HQ and there are absolutely no grounds for turning an official matter into a personal one.

Finally I would submit that, if for any diplomatic reasons, the Chief Commissioner decides to issue a directive that this car - contrary to normal procedure - is to be de-requisitioned, no such action should be taken immediately. To do so would be to support an Italian who has not been entirely straight forward (Reference original memorandum with USAMF), against an Allied Officer who has been perfectly correct in his conduct.

APPENDIX B.

I am Director of the Public Health Division Lazio-Umbria Region. In this capacity I was consulted regarding the proposed requisition of the car belonging to Professor PEREZ. I did not consider that it was essential for him to have his car.

I confirmed this opinion when, quite recently, Lt. CORVINI approached me again on the same subject. The Professor's name is on the list of bona-fide medical men who are authorised to apply for circulation permits. That list was countersigned by me. The fact that a name is included in the list does not signify that it is essential for that person to have a vehicle.

I do not consider it essential for Prof. PEREZ to have a vehicle and have never expressed such an opinion verbally or in writing.

1. Memorandum para 3. The vehicle was "picked up" for circulating without a permit. In fact it had a temporary permit, but also carried illegal documents which purported to show that it was in service for a Unit of USAAF. It was clearly not being used by this Unit, and subsequently the owner admitted it.

This is important as the owner's failure to act in a straightforward manner over this unquestionably affected later decisions.

2. Memorandum para 4. The Director of Public Health has at no time stated that the possession of a car is essential to Prof. PEREZ.

3. Memorandum para 5. 6. When HQ Lazio-Umbria Region received the letter from G.4 MAAC, the Director of Public Health was again consulted as to whether this vehicle should be released.

It should here be stated that while the spirit of the Memorandum n°2, to which reference is made in the G.4 letter, has always been observed, it is regarded as a directive and in individual cases the Director of the appropriate division in Lazio Umbria Region has been, and is, regarded as the final authority on the question of civilian cars.

4. Memorandum para 10.11. It is probably as a result of this part of the memorandum that the affair first became personal against Lt.CORVINI. It is, no doubt, true to say that the conversation was probably not extremely amicable, but the import of the whole paragraph changes if "HQ. Lazio-Umbria" is substituted for Lt. CORVINI. It has already been shown that Lt.CORVINI took all the correct steps and was speaking on behalf of this HQ regarding the decisions.

5. The remainder of the Memorandum is immaterial except as a guide to the Chief Commissioner in deciding whether it is desirable for him to issue an order cutting across the normal procedure. It reads very much like the majority of "appeals" and may, <sup>b3

1. A.M.G. Region IV vehicle No 131 was requisitioned on 21 August 1944. This vehicle is Lancia-Aprilia license No 83021 belonging to Dr. Marcello Perez.

2. This vehicle was picked up on the above mentioned date because it was travelling without a circulation permit. At the time it was picked up the owner had in his possession 3 documents signed by U.S. Army Officers, copies of which are attached. According to these documents this vehicle had been hired and was being used by the 18th Squadron of the 64th Troop Carrier Group.

3. The morning after the vehicle was requisitioned Lt. Col. William Tesch commanding 18th Squadron came in to see the undersigned officer to protest the requisitioning claiming that the vehicle was being used exclusively by his unit. The undersigned officer pointed out that vehicles used by the military in the Rome Area were being requisitioned and not rented and that the Colonel should have requested permission to requisition of the Rome Area Command. He was then referred to Capt. Tolliver, G-4 of the Rome Area Command, who explained the requisitioning process in detail.

4. Several days later the owner of the vehicle came in to explain that the documents which he carried were in fact a misrepresentation to prevent the vehicle being requisitioned. He explained that the vehicle was not being used by the 18th Squadron.

5. If the owner could afford to put his vehicle at the disposal of the 18th Squadron it would not be unreasonable to conclude that he does not need his vehicle. If his vehicle was not in fact put at the disposal of this unit then he is guilty of gross misrepresentation.

History of Requisitioning

1. Read Letter HC/117, dated 7 November 1944, this HQ containing full report on requisitioning of vehicle.

Lt.Col. Bizzozzero Consulted before Requisitioning

2. Before Requisition papers were put through the chief of the Public Health Division was consulted. He authorized the requisition in spite of the fact that the Perez was a doctor because the vehicle in question had been hired out to the 18th Troop Carrier Squadron, 64th Troop Carrier Group since 3 July 1944 and on 21 August 1944 the driver of the vehicle at the time of requisition (whom it now turns out is Dott. Franco Pizzarelli, according to his own statement attorney of Prof. Marcello Perez) maintained that the vehicle was still in service for the above mentioned unit.

Lt. Col. William Tesch, A.C., U.S.Army, Commanding 18th Squadron on 22 August 1944 the day after the requisitioning applied to Major Tolliver - G-4 R.A.A.C. for the return of the vehicle on the grounds that it was temporarily the property of the 18th Squadron. Major Tolliver pointed out that the 18th Squadron had no right to the vehicle since it had W.D. transportation and that Lt.Col. Tesch had acted against published orders of the Commanding General, R.A.A.C.

Misstatement on Part of Perez regarding Lt.Col. Bizzozzero

Perez claims that Lt.Col. Bizzozzero gave him a certificate to obtain the derequisition of his car and implies throughout his report that Col. Bizzozzero has approved the derequisitioning. In point No 8 on page 1 of Perez's Memorandum the following statement appears "following the O.K. already expressed by Col. Bizzozzero", Lt. Col. Bizzozzero has never in writing or orally assented to the car being derequisitioned. In fact the Colonel feels even now that the car should not be derequisitioned. The only paper issued over Col. Bizzozzero's signature was a statement that Perez's name appeared on the approved list of physicians.

Letter from Lt.Col. Bizzozzero affirming above - suggest 68el6 be written.

Letter of R.A.A.C. dated 4 Nov. 1944 requests derequisition.

Letter of Lt.Corbin including letter of Lt. Corvini HC/117 dated 7 Nov. 1944 in reply to above.

R.A.A.C. then forwards all documents to this HQ for decision.

This HQ turns over papers to Lt. Col. Bizzozzero who reaffirmed original decision to retain car.

Perez and Pizzarelli meet Corvini in the street in front of HQ. and continue the hounding of this officer which has been going on since the day the car was requisitioned 21 August 1944. Being an Army officer Lt. Corvini could never have made the statement alleged that no office or Allied Command in Rome was competent to order him to derequisition the car. Corvini did say that the R.A.A.C. had referred the matter to this HQ and that this HQ had decided to keep the car.

#### Libel and Slander by Implication

Perez and/or Pizzarelli say "they declared" and anyone who reads their letter will conclude that Lt. Corvini is the person or persons referred to in an alleged report that vehicle in question had been stolen and recovered without its tires. Lt. Corvini has never reported this vehicle stolen nor has he authorized anyone to make any such statement.

Perez and/or Pizzarelli imply that whoever engineered the theft would probably stand to make 1500 dollars profit. -----!!!! implying by the wording and the punctuation that this person was Lt. Corvini.

In ordering the car derequisitioned without hearing this HQ on the subject Colonel Parkin is tacitly accepting the slanderous charge against an officer merely performing his duty for this HQ.

#### Interchanging Parts on Requisitioned Vehicles







MEMORANDUM

After over two months of enquiries, investigations and tours of offices I succeeded in obtaining the official acknowledgement of the absolute necessity I have to use my automobile, Rome 83021, in the exercise of my profession as a surgeon. This acknowledgement is inequivocably implied in the declaration issued to me under date and instant by Col. Bizzozero, Head of the Public Health Division, Lazio Umbria Region Milizia. Subsequently I called on the G4 RAAC Officer in order to obtain the requisition of my motocar, requisitioned from me by the Region IV Command on 21 August 1944.

However, after having been assured of a prompt and favorable acceptance of my legitimate request, I learned on the 11<sup>th</sup> inst. from said G4 officer that, although RAAC had no objection for the requisition in question, the definitive decision rests on the competent office of the Lazio Umbria Region Command.

The reasons for this were not disclosed to me; I think I know some of the arguments which were raised in the past and therefore I wish to give hereunder some explanations:

1o) - At the moment of the car requisition I was just carrying out the necessary proceedings for the transference of said automobile from the public automobile register of Viterbo - where the car was registered under n°4722 7T - to that of Rome. This transfer was completed on 21 August 1944 and a new number (Rome 83021) had already been assigned to me although I had to get some additional documents in order to obtain the definitive circulation permit.

I was not able to complete this act before, because:

- a) prior to the liberation of Rome I was in hiding, being hunted by the Gestapo as I had been sentenced to death on account of the anti-German and anti-fascist activity which I was carrying out as a liaison member with the V Army O.S.S. At that time also my wife was in the hands of the Germans, in the well known Via Tasso jail.

Some times I was lending the car to some of these officers out of friendship. I declare on my honour that my automobile has never been rented to the Squadron.

As to the question whether the Squadron has the authority to issue the above permit; whether its form was regular and the wording exact, it is clear that all this matter concerns the Allied Armed Forces and not myself.
