I -- ASSUMPTION OF ADMINISTRATIVE CONTROL, PERUGIA AND TERNI PROVINCES

In compliance with Paragraph I, Executive Order No. 25, Headquarters, Allied Commission, dated 23 March 1945, this Region assumed, at 0100 hours on 16 March 1945, administrative control of the military government of the Umbrian compartment of Italy, comprising the provinces of Perugia and Terni. All proclamations, orders and directives issued by former headquarters of Allied Military Government in either or both of the provinces and not thereafter revoked, remain in full force and effect.
