



Marshal told me that he knew of no troops quartered in this particular house. I gave this information to Col. Hale.


SUBJECT Report on actions of Colonel Henry A. Hale, U-166213, Inc. AUS.

Chief Commissioner, Allied Commission,

(Attention - Deputy Chief of Staff for Establishment).

- 1. Ref. attached two copies of a letter from the Commanding General 92nd Infantry Division, file 371 x 600.91 dated 6 Dec. 44 and enclosures thereto; also letter from Colonel Henry A. Hale, file LU/C/3 dated 29 Dec. 44.
- 2. I have carefully considered the communications mentioned in par.1 preceding which have been officially referred to me. I have also interviewed Colonel Hale at length and considered statements submitted by him, some of which were made under cath, but have since been withdrawn at Colonel Hale's request.
 - 3. From the foregoing I conclude that:
- a. When the incident reported upon by a tactical division commander involving Colonel Henry A. Hale, Inf. D-166213, AUS, took place, Colonel Hale was some distance beyond and outside that part of Lucca Province which had been turned over to him for AMG administration and control by AMG Fifth Army. He had no jurisdiction or responsibility in the tactical division zone of action.
- b. The necessity, or justification, for Colonel Hale to take a woman resident of Lucca to the vicinity of the battle line to show him the way, or to assist him to obtain guides to the place of his mission is, at least, questionable.
- g. Colonel Hale did have official business in the tactical division zone of action; but not at the scene of the incidents reported by C.G. of the Division. He did not, immediately upon arrival in the tactical division zone, make his presence and his business known to either the Division Commander or the Infantry Sector Commander concerned, as he should have done.
- d. Without any semblance of authority to do so, and contrary to all accepted military practice, to say nothing of routine courtesy, Colonel Hale ordered soldiers, not under his command, out of a house within 300 yards of our front line where they were posted by their own officers for duty. At least some of the men were part of the crew of a nearby cannon.
- g. Colonel Hale either ordered, demanded, or insistently requested the members of a gun crew to move their gun which was in position for combat missions near the house from which he ordered the soldiers. He later asked a certain field officer concerned to have the gun moved all this being purely interference with matters which were in no way his responsibility. 29.7 This action was in no way connected with the mission which justified his presence in that area.

4. A. I find that Colonel Hale's actions, in this instance, showed lack of judgement, discretion and self control. He appears to have committed irresponsible acts in the heat of anger. Such actions are unworthy of an officer of his age and grade.

b. I have, therefore, relieved him from duty as Provincial Commissioner, Lucca Province, and request confirmation of this action.

5. The action taken has the oral concurrence of the SCAO, AMG Fifth Army.



SUBJECT: Interference With Tactical Operations.

TO : Commanding General, Fifth Army, APO 464, U. S. Army.

- 1. On 26 November 1944 a Golonel HALE, AMD Officer at LUCCA, accompanied by an Italian woman, arrived at BARGA (L 185044, Map ITALY, OSGS 4228, scale 1/25,000) in one of the regimental sectors of this Division without having made his presence known to the sector commander. He propeded to upbraid soldiers of this command, then in the performance of their combet duty, in an unmilitary manner (see Inclosure #1 for details). He ordered moved one weapon emplaced within 300 yards of our front line apparently because the house belonged to the woman who accompanied him. He later reported to the sector commander, stating that the soldiers were abusing civilian premises. The sector commander, at this time thinking that Colonel HALE had some status as an AMG officer, began to investigate the incident in question. However, Colonel HALE returned to the scene of his former interference before the commanding officer of 370 Combat Team could complete the investigation.
- 2. Upon learning that Colonel HALE was the AMS officer of the LUCCA area only and had no authority in HARGA, Colonel SHERMAN, the sector commander, promptly and properly ordered Colonel HALE out of his sector.
- 3. Colonel HALE's conduct was unwarranted, unethical, and contrary to sound military procedure. It is therefore requested that necessary action be taken to prevent further interference on Colonel HALE's part with the combat dispositions and activities of troops of this command.



SUBJECT: Actions of Col. Hale (Initials Unknown) of AMO, Lucea.

TO : Commanding General 92d Infantry Div. APO 92, US Army

- 1. On 26 November 1944, a Colonel Hale, the AMS officer of Lucea drove in a jeep, occupied by a civilian woman, to a point in Barga, within 300 yards of my front line, without authority. There he evicted a gun crew from a house, directed the gun be moved, and acted generally in a manner unbecoming to an officer and a gentleman. (See attached statements of officers and enlisted men of the 3d Battalion, 370th Infantry)
- 2. My first knowledge of this incident came when Colonel Hale came to my headquarters in Fornaci di Barga and stated a house had been badly misused by soldiers in Barga, that they were having a high old party with a bunch of women, and that the place looked like a mig pen. He further stated there was a gun in the yard that would have to be moved. He stated he had ordered the men out of the house and the gun moved.
- 3. Believing him in his efficial capacity as an AMG officer I told him I would investigate the situation at the house, as I wanted nothing of that sort going on, however as far as the gun was concerned it would stay where it was, as no one was going to order my guns around while I was sector commander. He then asked me to come to the jeep and listen to what the owner of the house had to say. I went to the jeep and was introduced to a lady in the back seat of the jeep. Colonel Hale then stated she wanted to move back into her house. I advised her not to move back as I considered any house north of Harga unsafe. She then asked if she could go to the house and get a small package of valuables before leaving it. I gave her that permission. Colonel Hale then drove off with the lady in his jeep.
- 4. After they left I checked up and found that Colonel Hale had no authority as AMS in Barge and was therefore there unofficially, without authority.
- 3d Battalion, who stated Colonel Hale was back again, was cursing the gun crew, ordered them and the gun off the property. I immediately went to Barga and to the house in question which is north of the city and within 300 yards of my front line. I saw Colonel Hale in the corner of the yard with some civilian workmen who were digging up, under his direction, a large glass bottle of what appeared to be wine. I first examined the house for damage. The only damage seemed to be a broken hinge on the lid of a piano. Windows downstairs on the north side were broken from enemy shellfire which had struck outside the house near a basement window. The house was clean.

> The soldiers occupied one room downstairs and heated their rations in a room in the basement. There were the only rooms occupied by them. I them closely questioned all the men. Their statements are as enclosed and the evidence on the spot seemed to bear out their statements as substantially correct. I then talked to Colonel Hale. I asked him if he had anything to do with the AMG in Barga. He admitted be did not. I then asked him by what authority he was there. He stated he had gone to see Colonel Ross of the 598th Field Artillery Battalion, but not find him in, had gone to my S-2 office and had received permission. (A check of this last statement disclosed no much permission given, nor had Colonel Hale been near my office on his way to Bargs). I then told Colonel Hale he was completely in the wrong, that he was there with no authority, that I felt he had used his Luces AMG status to get into my area with the lady in question, and that I would not tolerate for an instant anyone ordering my men or guns around while I was the tactical commander. I further told him to leave my area and advised him to stay in Lucea. To prevent any more civilians entering the house, I, in Colonel Hale's presence, put the house "Off Limits" to officers, soldiers, and civilians. The gun crow I placed in a building nearby so they could quickly serve the gun. The gum remained where it was.

- 7. From my inventigation I conclude that:
 - (a) Colonel Hale was completely in the grong.
 - (b) The men were well-behaved and the house was not torn up, nor did it look like a "hog-pen".
 - (c) That nothing in fact occurred to justify Colonel Hale's "whorehouse" statement.
 - (d) That the slight dumage to the piano was not the fault of the soldiers present.

STATEMENT OF IT COL CLARENCE W. DAWRITTE, JR. 370th THE


On the 26 November 1944, a Colonel Hale called me on the phone stating that he was with the AMG and that he manted me to meet him immediately at a certain house in Barga, he stated that some of my so-called soldiers had an AT Cam behind this house and that in wanted the soldiers put out of the bouse and the gan moved ismediately. He accused the men of running the place as a whore house. I told him that I would come down to the house and mee what was the trouble. Upon reaching the house I found that the four men that operated the gun and who had been staying in the house had been ordered out of the house by Gol Hale and all of their equipment was out on the street. He had ordered the sen to move the gun, but they told him they eculd not move it until they had orders from me to do so. I found that the men had not fired a fire mission, to fire at a house which contained 5 or 6 Germans, due to the appearance of Col. Hale and the issuing of orders by him to nove out of the house. In talking to Gol. Hale, he stated that the house had been damaged by coldiers and the lady that owned the house was there with him. He stated that be wanted the gun moved from that property. In making a short investigation, it appeared that the damage he referred to had not been done by this gun sound as they had only occupied the house for three days, but had been done about 7 days before this time. Upon investigation, there appeared to be no foundations for the accusation that the mon sure using the house as a whore house. He asked who had been in the house other than this gun squad. I told him none of the soldiers of this En had been in this house up until 3 days ago, but possibly Af Company of the Regiment had occupied it with one of their gun crews before we moved into this position. He wanted to know who was in charge of AT Company, and I told him Col Sherman. he said that he was going to see him ismediately. He wanted to know if I would have the gun moved immediately, and I told him I allowed the men of this En in cortain instances to occupy houses if the situ-W ation permitted, provided the property was not damaged. I also told him the gun was in position to engage targets that we needed to have govered. I s wouldn't be able to move the gon unless I could find another position that would be just as good as this position. After a recommaisuance, if it was possible to secure another position, I might have it moved, otherwise, the gun would have to stay in that position as we could not stop a war just to get a gun off the property that the owner objected having there.

Col Hale then left to see Col. Sherman. I told the Platoon Sergeant to leave his gun in his present position until ordered to move it by me, and to make a recommaissance to see if it was possible to cover the same target from a different position and to report to se later. The feelings of these soldiers were very much hurt by the way Col. Hale talked to them. He unlied them wandals, so-called soldiers and cursed them out. The Fistoon Sgt. one of the hest Sgts in the record of this En, has been above reprouch and has performed his duty in a highly natisfactory manner, but was insulted and had his feelings hart to such an extent that he was forced to cry over the incident that had just happened. After Col hale left I reported the incident to Regiment and asked them what authority Gol Hale had to interfere with the operations and the troops in this sector. I was informed that he had no right at all to order guns to be noved or to interfere with the troops operating the guns. A few hours later Gol Bale returned again to the gun position and house, ordering the men a second time to howe. Gol. Sherman was notified of this and he came up and talked to Col. Hale and made a personal investigation and instructed the men to leave the gun in its present position.


On or about 26 November 1944, I received a telephone call from Bet Sousley. By told my that they had been kicked out of the house they were occupying and had been told to stay out and to get their 57mm AT Gun away from the rear of the house. I saked him whose orders they were and he said a Colonel Hale. Col Hala then came to the phone and told me that he had entered the house and found the men running a first class whore house, so I told him that I would be down immediately. When I arrived I met Sgt Blake and told me that the Colonel had called them varials and so-called soldiers, and had kicked some of their equipment out of the door. Colonel Hale maid to me, "Yes, I put them out; these so-called soldiers of yours." He also stated that hespelving stayed here for 3 months and the house was kept smaculate. Then a woman who the Colorel naid was the owner of the house said, "Yes, the Garmann were very emaculate." Sgt Blake asked her if she would rather have the Germann back and she replied, "No. no." Col Hale said he was going to see Col Sherman and I returned to the Bn CF. Some time later I received another call from Sgt Buasley saying that Col. Bale had returned and but them out of the house quain and told them that he did not went to see ther again. I called Col. Sherman and asked him if he had ordered that house vacated and the gun moved. On or about 26 November 1944, I was sitting in our Platoon ngs reading a maner to the Boys when a Colonel walked into the room and said, West the Hell out of here." When he said that the rest of the Boys and I went on upstairs. I turned around, came back downstairs and asked his mame and what right he had to drive us away from our gun position, which set right by the house in the back yard. He replied, "You are a bunch of Der Vandala," I told him I would call the Bn and contact one of the officers. He replied, "Call Gol Ross." I told him I didn't know Gol Hoss, but I would get a No officer, so I called my En Meadquarters and got Lt Marrington. I told him we wern being but out by some Colonel. He told me to give him the phone and he talked to bt Harrington. Protty soon bt Harrington and Capt Brown case and shortly after Col Daugette arrived. Col Daugette talked with this Colonel and shortly after the Colonel left. After he left Col Daugatte told us to stay there until we heard from bim. Shortly after the Colonel returned. I was mitting downstairs when he and the owner of the house walked in. He said, "Get the Dam Hell out of here, and don't let me catch you here again. Don't even let me see your face again." So I took the phone, went outside and called Lt Harrington again. Lt Harrington told me to hold the phone and he would call me right back. He called me and told me that he and Gol Sharman were coming over. They came and Gol Sherman talked with me and asked me about the women the other Colonel had said were in the house. I told him women, son and boys were in and out of the house every day, getting mood which is in the house downstairs in the hall mext to our kitchen, however, I don't know them nor do my men, because we had only been in the house three days. Cur Platoon leader has been with us practically all the time we have been there. Col Sherman told us to move tack in the house and stay if we could not find a place to engage the targets which we were assigned. I tried to explain to the Colonel in question, that we had been there only three days and had not destroyed anything, but he would not let me talk to him.



As we were not quite through getting everything out of the bouse, he kicked boxes containing toilet articles and small arm ammunition out of the house into the yard, at the same time he was still using profamity.

Then he ordered me personally to get that dam junk out into the street. I took as much equipment as I could out into the street and stayed with the equipment.

About 1045, upon returning from the of to our plateon headquarters I saw a Colonel kicking the equipment of the man of the squad outside the door. I went over to the Colonel to find out why he was kicking the equipment out. Upon saluting the Colonel he refused to return the selute and said, "I don't mant to talk to you, I want to talk to an officer". Then he told me to get Colonel Ross on the telephone, I tried to explain that Golonel Ross had nothing to do with us that Golonel Daugette was Commanding Officer of our unit. He stated that Colonel Ross knew him and he wanted to talk to him. I couldn't get Colonel Ross on the phone so I called Colonel Daugette. I heard him say to Colonel Daugette over the phone "You got a goddan bunch of vandals over here, so called troops, that don't know how to not".

In the mountime he begin cursing us an ordered us out of the house, he again started kicking the equipment out of the house, stating "This woman happens to be an American Citizen" referring to a lady that came in with him and the owner of the house. I replied "So are we and se are trying to fight a war".

He ordered us to move our gun position and I refused. I said not until I get orders from my Battalion Headquarters, would I move the gun. Then be falsely accused us of breaking in the house and destroying the property. However this statement was proven false by the caretaker who, in the presence of the Colonel and Colonel Daugette admitted that the damage had been done seven days ago and we had only been there three or four days.

He also accused us of running a whore house because he saw two women in the house when he came in.

In the meantime, while all this was going on, two measungers from Go E came down and gave us a fire mission to fire on, however during the confusion, we didn't get to fire because the Colonel had given us a direct order to move out and we were in the process of doing so.

Later Lt Harrington, En S.2, Capt Brown and Colonel Daugette came down. Col Daugette told us to move back in and carry on. However the Colonel (Later identified as Colonel Hale) returned and made us move out again, using profanity.

The Colonel stated "Kesselring had his headquarters here and left the place emaculate, you live like dogs" I asked Colonel Hale if he preferred the Cormans here to us, but got no reply.



SUBJECT

Chief Commissioner, Allied Commission, (Attention - Deputy Chief of Staff for Establishment).

- Ref. attached two copies of a letter from the Commanding General 92nd Infantry Division, file 371 x 600.91 dated 6 Dec. 44 and enclosures therato; also letter from Celonel Henry A. Hale, file LU/C/3 dated 29 Dec. like .
- 2. I have carefully considered the communications mentioned in par.1 preceding which have been officially referred to me. I have also interviewed Colonel Hale at length and considered statements submitted by him, some of which were made under oath but have since been withdrawn at Colonel hule's request.
 - 3. From the foregoing I conclude that:
- a. When the incident reported upon by a tactical division commander involving Colonel Henry A. Hale, Inf. 0-166213, ADS, took place, Colonel Hale was some distance beyond and outside that part of Lucca Province which had been turned over to him for AMG administration and control by AMG Fifth Army. He had no jurisdiction or responsibility in the tactical division zone of action.
- b. The necessity, or Justification, for Colonel Hale to take a woman resident of Lucca to the vicinity of the battle line to show him the way, or to assist him to obtain guides to the place of his mission is, at least, questionable.
- g. Colonel Hale did have official business in the tactical division some of action; but not at the scene of the incidents reported by C.G. of the Division. He did not, immediately upon arrival in the tactical division zone, make his presence and his business known to either the Division Commander or the Infantry Sector Commander concerned, as he should have done.
- d. Without any semblance of authority to do so, and contrary to all accepted military practice, to say nothing of routine courtesy, Colonel Hale ordered soldiers, not under his command, out of a house within 300 yards of our front line where they were posted by their own officers for duty. At least some of the men were part of the crew of a nearby cannon.
- g. Colonel Hale either ordered, demanded, or insistently requested the members of a gun crew to move their gun which was in position for combat missions near the house from which he ordered the soldiers. He later asked a certain field officer concerned to have the gun moved - all this being purely interference with matters which were in no way his responsibility. This action was in no way connected with the mission which justified his presence in that area.

4. A. I find that Colonel Hale's actions, in this instance, showed lack of judgement, discretion and self control. He appears to have committed irresponsible acts in the heat of anger. Such actions are unsorthy of an officer of his age and grade.

h. I have, therefore, relieved him from duty as Provincial Commissioner, Lucce Province, and request confirmation of this action.

5. The action taken has the oral concurrence of the SCAO, AMG Fifth Army.





SUBJECT Interference With Tactical Operations.

TO : Commanding General, Fifth Army APO 464, U. S. Army.

- 1. On 26 November 1944 a Colonel HALE, AMG Officer at LUCCA, accompanied by an Italian woman, arrived at BARGA (L - 185044, Map ITALY, CEGS 1,228, scale 1/25,000) in one of the regimental sectors of this Division without having made his presence known to the sector commander. He proceeded to upbraid soldiers of this command, then in the performance of their combat duty, in an unmilitary manner (see Inclosure #1 for details). He ordered moved one weapon emplaced within 300 yards of our front line apparently because the house belonged to the woman who accompanied him. He later reported to the sector commander, stating that the soldiers were abusing civilian premases. The sector commander, at this time thinking that Colonel HALE had some status as an AMC officer, began to investigate the incident in question. However, Colonel HALE returned to the scene of his former interference before the commanding officer of 370 Combat Team could complete the investigation.
- 2. Upon learning that Colonel HALE was the AMD officer of the LUCCA area only and had no authority in BARGA, Colonel SHERMAN, the sector commander, promptly and properly ordered Colonel HALE out of his sector.
- 3. Colonel HALE's conduct was unwarranted, unethical, and contrary to sound military procedure. It is therefore requested that necessary action be taken to prevent further interference on Colonel HAIZ's part with the combat dispositions and activities of troops of this command.

SUBJECT: Actions of Col. Hale (Initials Unknown) of AMG, Lucca.

TO

Commanding Seneral 92d Infantry Div. APO 92, US Army

- 1. On 26 November 1944, a Colonel Hale, the AMG officer of Lucca drove in a jeep, occupied by a civilian woman, to a point in Bargs, within 300 yards of my front line, without authority. There he evicted a gun crew from a house, directed the gun be moved, and acted generally in a marmer unbecoming to an officer and a gentleman. (See attached statements of officers and enlisted men of the 3d Battalion, 370th Infantry).
- 2. My first knowledge of this incident came when Colonel Hale came to my headquarters in Fornaci di Barga and stated a house had been badly misused by soldiers in Barga, that they were having a high old party with a bunch of women, and that the place looked like a pig pen. He further stated there was a gun in the yard that would have to be moved. He stated he had ordered the men out of the house and the gun moved.
- 3. Believing him in his official capacity as an AMG officer I told him I would investigate the situation at the house, as I wanted nothing of that sort going on, however as far as the gun was concerned it would stay where it was, as no one was going to order my guns around while I was sector commander. He then asked me to come to the jeep and listen to what the owner of the house had to pay. I went to the jeep and was introduced to a lady in the back seat of the jeep. Colonel Hale then stated she wanted to move back into her house. I advised her not to move back as I considered any house north of Barga unsafe. She then asked if she could go to the house and get a small package of valuables before leaving it. I gave her that permission. Colonel Hale then drove off with the lady in his jeep.
- 4. After they left I checked up and found that Colonel Hale had no authority as AMG in Harga and was therefore there unofficially, without authority.
- 3. A few minutes later I received a call from It. Harrington, 5-2
 3d Battalion, who stated Colonel Hale was back again, was cursing the gun
 crew, ordered them and the gun offthe property. I immediately went to
 Barga and to the house in question which is north of the city and within
 300 yards of my front line. I saw Colonel Hale in the corner of the yard
 with some civilian workmen who were digging up, under his direction, a large
 glass bottle of what appeared to be wine. I first examined the house for
 damage. The only damage seemed to be a broken hinge on the lid of a piano.
 Nindows downstairs on the north side were broken from enemy shellfire which
 had struck outside the house near a basement window. The house was clean.



The soldiers occupied one room downstairs and heated their rations in a room in the basement. These were the only rooms occupied by them. I then closely questioned all the men. Their statements are as enclosed and the evidence on the spot seemed to bear out their statements as substantially correct. I then talked to Colonel Hale. I asked him if he had anything to do with the AMG in Barga. He admitted he did not. I then asked him by what authority he was there. He stated he had gone to see Colonel Ross of the 598th Field Artillery Eattalion, but not find him in, had gone to my S-2 office and had received permission. (A check of this last statement disclosed no such permission given, nor had Colonel Hale been near my office on his way to Barga). I then told Colonel Hale he was completely in the wrong, that he was there with no authority, that I felt he had used his Lucca AMG status to get into my area with the lady in question, and that I would not tolerate for an instant anyone ordering my men or guns around while I was the tactical commander. I further told him to leave my area and advised him to stay in Lucca. To prevent any more civilians entering the house, I, in Colonel Hale's presence, put the house "Off Limits" to officers, soldiers, and civilians. The gun crew I placed in a building nearby so they could quickly serve the gun. The gun remained where it was.


- 7. From my investigation I conclude that:
 - (a) Colonel Hale was completely in the wrong.
 - (b) The men were well-behaved and the house was not torn up, nor did it look like a "hog-pen".
 - (c) That nothing in fact occurred to justify Colonel Hale's "whorehouse" statement.
 - (d) That the slight damage to the plane was not the fault of the soldiers present.

STATEMENT OF LT COL CLARENCE T. DAUGETTE, JR. 370th INF

On the 26 November 1974, a Colonel Hale culled me on the phone stating that he was with the AMO and that he wanted me to meet him immediately at a certain house in Barga. He stated that some of my so-called soldiers had an AT Gun behind this house and that he wanted the soldiers put out of the house and the gun moved immediately. He accused the men of running the place as a whore house. I told him I would come down to the house and see what was the trouble. Upon reaching the house I found that the four men that operated the gun and who had been staying in the house had been ordered out of the house by Col Hale and all of their equipment was out on the street. He had ordered the men to move the gun, but they told him they could not move it until they had orders from me to do so. I found that the men had not fired a fire mission, to fire at a house which contained 5 or 6 Germans, due to the appearance of Col. Hale and the issuing of orders by him to move out of the house. In talking to Col. Hale, he stated that the house had been damaged by soldiers and the lady that owned the house was there with him. He stated that he wanted the gun moved from that property. In making a short investigation it appeared that the damage he referred to had not been done by this gun squad as they had only occupied the house for three days, but had been done about 7 days before this time. Upon investigation, there appeared to be no foundations for the accusation that the men were using the house as a whore house. He asked who had been in the house other than this gun squad. I told him none of the soldiers of this En had been in this house up until 3 days ago, but possibly AT Company of the Regiment had occupied it with one of their gun crews before we moved into this position. He wanted to know who was in charge of AT Company, and A told him Col. Sherman. He said that he was going to see him immediately. He wanted to know if I would have the gun moved immediately, and I told him the gun was in position to engage targets that we needed to have covered. I wouldn't be able to move the gun unless I could find another position that would be just as good as this position. After a reconnaissance, if it was possible to secure another position, I might have it moved, otherwise, the gun would have to stay in that position as we could not stop a war just to get a gun off the property that the owner objected having there.

his gun in his present position until ordered to move it by me, and to make a a reconnaissance toses if it was possible to cover the same target from a different position and to report to me later. The feelings of these soldiers were very much hurt by the way Col. Hale talked to them. He called them vandals, so-called soldiers and cursed them out. The Flatoon Sgt, one of the best Sgts in the record of this Hn, has been above repreach and has performed his duty in a highly satisfactory manner, but was insulted and had his feelings hurt to such an extent that he was forced to cry over the incident that had just happebed. After Col. Hale left I reported the incident to Regiment and asked them what authority Col Hale had to interfere with the operations and the troops in this sector. I was informed that he had no right at all to order guns to be moved or to interfere with the troops operating the guns. A few hours later Col Hale returned again to the gun position and house, ordering the men a second time to move. Col. Sherman was notified of this and he came up and talked to Col. Hale and made a personal investigation and instructed the men to leave the gun in its present



STATEMENT OF 1ST RALPH B. HARRINGTON, 370TH INF.

On or about 26 November 1944, I received a telephone call from Sgt. Beasley. He told me that they had been kicked out of the house they were occupying and had been told to stay out and to get their 57mm AT GUN away from the rear of the house. I asked himwhose orders they were and he said a Colonel Hale. Col Hale then came to the phone and told me that he had entered the house and found the men running a first class whore house, so I told him I would be down immediately. When I arrived I met Sgt. Blake who told me that the Colonel had called them vandals and so-called soldlers, and had kicked some of their equipment out of the door. Colonel Hale said to me, "Yes, I put them out; these so-called soldiers of yours". He also stated that Kesselring stayed here for 3 months and the house was kept emaculate. Then a woman who the Colonel said was the owner of the house said, "Yes, the Germans were very emaculate". Sgt. Blake asked her if she would rather have the Germans back and she replied, "No, no". Then Colonel Hale took me around the first floor to show me the damage which he said American soldiers had done to the house. Upon questioning the cartaker we found that the dumage had been done 7 or 8 days before and the soldiers of the AT Platoon had been there only 3days. Col. Hale stated further, "This woman is an American citizen", and Sgt. Blake said "We are all American citizens". Then Colonel Daugette came in and talked to Col. Hale. Col. Hale said he was going to see Col. Sherman and I returned to the Bn CP. Some time later I received another call from 5gt. Beasley saying that Col. Hale had returned and put them out of the house again and told them he did not want to see them again. I called Col. Sherman and auked him if he had ordered the house vacated and the gun moved. He asked me what is the trouble. I explained what had kappened. He said that he would be up right away. When Col. Sherman arrived I went with him to the house in question. He talked with everyone concerned.

I told him women, men and boys were in and out of the house every day, getting wood which is in the house downstairs in the hall next to our kitchen, however, I don't know them nor do my men, because we had only been in the house three days. Our Platoon leader has been with us practically all the time we have been there. Col. Sherman told us to move back in the house and stay if we could not find a place th engage the targets which we were assigned. I tried to explain to the Colonel in question, that we had been there only three days and had not destroyed anything, but he would not let me talk to him.



I went over to the Colonel to find out why he was kicking the equipment out. Upon saluting the Colonel he refused to return the salute and said, "I don't want to talk to you, I want to talk to an

officer". Then he told me to get Colonel Hoss on the telephone. I tried to explain that Colonel Ross had nothing to do with us that Colonel Daugette was Commanding Officer of our unit. He stated that Colonel Ross knew him and he wanted to talk to him. I couldn't get Colonel Ross on the phone so I called Colonel Daugette. I heard him may to Colonel Daugette over the phone "You got a goddam bunch of vandals over here, so-called troops, that don't know how to act".

In the meantime he begin cursing us an ordered us out of the house. He again started kicking the equipment cut of the house, stating "This woman happens to be an American Citizen" referring to a lady that came in with him and the owner of the house. I replied "So are we and we are trying to fight a war".

He ordered us to move our gun positions and I refused. I said not until I get orders from my Battalion Headquarters, would I move the gun. Then he falsely accused us of breaking in the house and destroying the property. However this statement was proven false by the caretaker who, in the presence of the Colonel and Colonel Daugette admitted that the damage had been done seven days ago and we had only been there three or four days.

He also accused us of running a whore house because he saw two women in the house when he came in.

In the meantime, while all this was going on, two messengers from Co K came down and gave as a fire mission to fire on, however during the confusion, we didn't get to fire because the Colonel had given us a direct order to move out and we were in the process of doing so.

Later Lt. Harrington, Bn 3-2, Capt. Brown and Colonel Daugette came down. Col. Daugette told us to move back in and carry on. However the Colonel (Later identified as Colonel Hale) returned and made us move out again, using profanity.


The Colonel stated "Kesselring had his headquarters here and left the place emaculate, you live like dogs" I asked Colonel Hale is he preferred the Germans here to us, but got no reply.

STATEMENT OF CPL ELIHUE HENDERSON, HQ CO 3D BN. 370TH INF.

On or about 26 November 1944, while at our Flatoon Hqs., I was sitting at a table when a Colonel walked in and said "Get the goddam hell out of here". I went upstairs to roll up my equipment and he came up there and said, "These goddam Niggers". I begin to take the equipment outside and the Colonel came up and said "Get that dam stuff all the way into the street". He then begin kicking the equipment with his foot. I then started carrying the equipment to a new place.
