1. Paragraph 2, Ltr. Commanding General, MTCUSA, dated 4 December 1945, is quoted for your instruction:

" 2. Only those vehicles in use by United-States elements of Allied Commission should be carried as a United States responsibility and vehicles used by British elements should be called in and de-requisitioned and then re-issued by the Italian Government to the British elements should they desire it".

1. This Headquarters has no objection in your continuing with your present procedure in handling PIO vehicles now in use by the Commission. However, you are required to advise PBS of the vehicles for which you have no further use prior to taking de-requisition action to enable PBS to determine if vehicles are still required by the Army, and, to further advise PBS and the Deputy Claims Officer of the United States Claims Service your procedure now in effect and the location of the records pertaining to the vehicles presently in use and of those heretofore disposed of.

2. Only those vehicles in use by the United States element of Allied Commission should be carried as a United States responsibility and vehicles used by British elements should be called in and de-requisitioned and then re-issued by the Italian Government to the British elements should they desire it. Vehicles in use by the United States may be carried on the records of the 2675th Regiment.

3. De-requisitioned vehicles will be returned to the Ispettorati Compartimentali della Motorizzazione and in no case to the original owner.

My dear Minister:

I would like to refer to you for appropriate action, a matter, which for the past six months has been one of considerable discussion and correspondence between Allied officers and officials of the Italian Government. As you are probably aware, all allied papers relative to the requisitioning of civilian motor vehicles and vehicle accessories have been transferred by the Allied Commission to the Ispettorato Generale della Motorizzazione. This transfer has been accomplished to the entire satisfaction of all concerned, however, the second step towards completion of our program has been very difficult to accomplish; namely the actual turnover of vehicles which A. C. has no longer any need for and wish to return to the Ispettorato Compartimentale in Rome. We have had in our possession available for transfer to the Ispettorato Compartimentale della Motorizzazione Civile di Roma (in accordance with Legislative Decree No. 46 of Lt. General of the Realm) some two hundred (200) civilian vehicles to be returned to their owners. We have tried on many occasions to assist the Ispettorato Compartimentale of Rome to locate a suitable garage to receive and process these vehicles without success and the Ispettorato officials also have tried to locate suitable space without result. As soon as a garage is obtained, transfer of these two hundred (200) vehicles will be expedited.

It is therefore suggested that the Prefect of Rome be requested to requisition a garage suitable to the need and place it at the disposal of the Ispettorato Compartimentale della Motorizzazione for this specific purpose.

I will be very grateful if this matter which has been unfortunately delayed be given your immediate consideration.

SUBJECT: Requisitioned Civilian Vehicles on Charge to D. P. & R.

TO : Director, Displaced Persons and Repatriation Sub Commission,
Headquarters, Allied Commission.

1. This headquarters has been directed by higher authority to expedite program of reduction of requisitioned civilian vehicles under A. C. requisition.
2. Appropriate instructions have been issued to all Regions in the field and to the Headquarters Transportation Officer; which will reduce the number of Allied Commission's requisitioned vehicles by 50% by 29 September and by 100% on date of restoration of all territory to Italian Government Control.
3. It is therefore requested that the below listed civilian vehicles on charge be turned in not later than 5 October 1945 to the Transportation Officer in charge of A. C. Super Garage, Piazza Verdi, Rome:

According to the recent instructions concerning the derequisitioning of vehicles, requisitioned by the Allies I call the attention of the Inspectorate on what follows. On July the 12th of last year the AMG of Fermo (Ascoli Piceno) has requisitioned for the American Government my car Lancia-Aprilia, license plate Rome 61560, frame N°38-3216, motor N° 3052.

Therefore on the 28th September 1944 I received a requisitioning folio N° 134 from the HQ. AMG of Ascoli Piceno.

The undersigned professor of the R. University of Rome and lawyer, is since few months serious leucocytosis. Recently he had to submit himself in a short period of time to four blood transfusions, which were done by the Prof. Corelli of the Frugoni clinical surgery. His car is really indispensable to him to accomplish his professional duties which require his presence to the Justice palace and frequent displacements which do not permit him to use collective means of transports.

As the undersigned has no incomes besides those which he collects from his profession and he cannot support the expenses which are required by the continuous hire of motor vehicles, thus he request the Compartmental Inspectorate to ask the Allied Authorities to derequisition his car.

My doctor and lawyer Nicola Mattina, living in Rome Paa Buenos Ayres N° 14 can certify what has been reported.

2. Request is made that the a/m vehicle be derequisitioned. Dr. Zara is at present engaged in work directly connected with the rehabilitation of the Italian pharmaceutical industries. Medicines, vaccines and serums are urgently needed by Italy to prevent spread of disease and incidence thereof. In Italy there are approximately 800 pharmaceutical plants and the coordination of the allocation of raw materials (in very short supply) requires constant liaison with these plants. Also Dr. Zara has had considerable experience in both the American and Italian pharmaceutical industries and is therefore called upon by the Italian pharmaceutical industries for advise relative to production methods, products, etc. as can readily be seen a real need exists that Dr. Zara's vehicle be released to him at the earliest possible moment. Attention is invited to the fact that little is achieved by derequisitioning vehicles that belong to private doctors, if these doctors do not have medicines with which to treat the sick.

Requisitioning and Derequisitioning of Civilian Motor Transport.....II

I -- CAPTURED ENEMY EQUIPMENT AND OTHER ITEMS CONFISCATED BY BASE CENSORS

1. a. Captured enemy material, allied clothing, equipment and stores are constantly being confiscated by Base Censors, Transit Camps, Training Depots, Port Battalions and other Port Installations.

b. In the past, difficulty has been experienced by Base Censors and others in having such items accepted by depots and installations, and obtaining receipts. The consequent delay has meant that the items have not been utilized and has created storage problems for the recovering units, especially in the case of valuable technical stores.

2. a. Services will, in future, insure that their officers, installations and depots accept such stores from Base Censors and others immediately when offered, and give receipts for them.

b. Captured enemy material will be reported through proper channels to (M(CENS) AFHQ who will issue disposal instructions. Items of Allied equipment will be disposed of according to normal procedure.

II -- REQUISITIONING AND DEREQUISITIONING OF CIVILIAN MOTOR TRANSPORT

1. All requisitioning of civilian vehicles for both United States and British Forces will be under the control of Allied Force Headquarters through normal channels. Authority to requisition lies with the 15th Army Group in the forward areas, and AFHQ for British Army and MTOUSA for United States Army in the rear areas, giving regard to their respective areas of responsibility, but may be delegated by these headquarters to certain specified subordinate headquarters.

2. All requisitioned vehicles will be held against deficiencies in TE/WE of Allied military units, including Allied Commission. No requisitioned vehicles will be held surplus to TE/WE unless written authority of 15th Army Group or AFHQ/MTOUSA is obtained.

3. In an emergency, vehicles may be requisitioned in excess of TE/WE without prior written authority of 15th Army Group or AFHQ/MTOUSA, but such authority must be obtained promptly thereafter.

4. All requisitioned vehicles held surplus to TE/WE for which authority is not granted by 15th Army Group or AFHQ/MTOUSA will be disposed of by one of the following methods:

- a. To the respective Ordnances
- b. Derequisitioning and handing over to the original owner, or if not practicable, to the Italian Government
- c. Using in work shops for dismantling and removal of essential spares for repair of other requisitioned vehicles.

5. In territories under the jurisdiction of the Italian Government, vehicles requisitioned by the Allied Forces will not be used by Italian Government officials or Italian civilians not employed by Allied Forces. Any such vehicles which are now being used in this manner will be disposed of as in paragraph 4 above.

6. All requisitioned vehicles will be registered with a military registration number by Ordnance British for British vehicles and by the subordinate commands delegated responsibility of requisitioning for United States Army vehicles.

7. Load carrying vehicles will not be requisitioned for military use except in cases of emergency.

8. Requisitioned vehicles will not be moved from the country in which they were requisitioned except with the approval of AFHQ/MTOUSA.
