Subject: Autostrada Passes for Members of the Italian Government.

To: Commanding Officer, 57 Area  
(THRU) Commanding General, PBS.

1. The procedure outlined in your 16/80/PRO dated 27 April 1944 does not appear either satisfactory or workable.
2. It is extremely important, as explained in our 2nd indorsement DSG 200.2 of 17 April 1944 to your letter 16/56/PRO dated 10 April 1944 that permission be granted to officials of the Italian Government for travel on the Autostrada in connection with their official duties.
3. Attention is invited to letter from the Provost Marshal, 57 Area, 26/273 dated 16 March 1944, copy attached, in which it is stated that passes will not be necessary for members of the Italian Government.
4. It is believed that in view of the importance attached by H. M. and U. S. governments to an efficient Italian Government Administration in the furtherance of our common war effort, and the relatively insignificant inconvenience caused to military traffic on the Autostrada by the presence of a few Italian government vehicles, every effort should be made to have this highway available for their use.
5. It is therefore strongly recommended that the Possep-Naples Autostrada be opened to Italian Government Officials bearing the proper credentials and engaged in the execution of their delegated functions, and if passes are considered necessary, that this headquarters be given

DSG 200.2 of 17 April 1944 to your letter 16/56/PRO dated 10 April 1944 that permission be granted to officials of the Italian Government for travel on the Autostrada in connection with their official duties.

3. Attention is invited to letter from the Provost Marshal, 57 Area, 26/273 dated 16 March 1944, copy attached, in which it is stated that passes will not be necessary for members of the Italian Government.

4. It is believed that in view of the importance attached by H. M. and U. S. governments to an efficient Italian Government Administration in the furtherance of our common war effort, and the relatively insignificant inconvenience caused to military traffic on the Autostrada by the presence of a few Italian government vehicles, every effort should be made to have this highway available for their use.

5. It is therefore strongly recommended that the Pompei-Naples Autostrada be opened to Italian Government Officials bearing the proper credentials and engaged in the execution of their delegated functions, and if passes are considered necessary, that this headquarters be given authority to issue them as outlined in the 2nd indorsement referred to in 1451 .. paragraph 2 above.

6. It is requested that early action be taken and this headquarters advised with the least practicable delay.

MEMORANDUM FOR: Captain Stone.

The procedure outlined in the attached letter is impracticable due to the fact that each time a member of the Italian Government wishes to proceed via the Autostrada it will be necessary for him to apply to this headquarters for one of the three passes, provided they have not already been issued and a covering letter stating that the holder has permission to use the pass.

It is suggested that one of the following lines of action be taken:

a. The matter be forwarded to the Executive Commissioner for transmittal to AAI as the road in question is an Army controlled road.

b. The Italian Government be advised that permission cannot be granted for use of the Autostrada based on the information contained in the attached letter.

1. The action taken as outlined in basic communication is not understood in view of the fact that the undersigned personally made a trip from Salerno to Naples on or about 17 March 1944 and discussed the use of the Autostrada by officials of the Italian government with the Provost Marshal's office.
2. At that time I left a copy of the passes being issued by this headquarters with the Provost Marshal; he assured me that the pass was in order, and at that time no mention was made of a special pass from that office being required.
3. The only time a pass is issued by this headquarters is for official travel by a member of the Italian government and I was assured that such passes would be honored by the Military Police for travel on the Autostrada from Pompei to Naples.
4. The passes issued by your headquarters are presumed to be of a permanent nature and entitle the holder to use the Autostrada at any time regardless of the nature of his business, whereas those issued by this headquarters are for one specific trip and the user is required to secure a new pass for each trip.
5. If a special pass is required as outlined in basic communication, it is requested that this headquarters be authorized to issue such passes to the officials of the Italian government, as these officials are located in Salerno.

1. Attached are two letters from A.C.C. purporting to be passes for the military highway Autostrada, forwarded for your perusal.
2. Autostrada passes have in the past been issued from this office, and such is the necessity for keeping this vital road free for military traffic that only 29 have been issued to date.
3. It will be appreciated that if units, services etc give independent passes the amount of traffic would enormously increase and nullify the object of a military road.
4. Should you consider it essential that these civilians have autostrada passes, this office will of course be pleased to furnish them. If it is not considered essential that these passes are issued, perhaps you would take the necessary action.

RULES AND REGULATIONS  
FOR  
ALLIED OFFICERS CLUB

1. This club is for the use of officers of the Armed Forces and Merchant Marine of the Allied Nations, Warrant Officers of the U. S. Army, and men and women of the American Red Cross.
2. No one is to be admitted to the Club premises who is not a member, except by express direction of the Commanding General.
3. An initiation fee of one dollar shall be paid with application for membership and thereafter each member shall be charged one dollar per month.
4. Cash is to be paid for all purchases made at the Club. No credit is to be allowed.
5. The Club will be open from 1100 hours to 2200 hours daily. Hours for meals will be announced from time to time. Extension rights for special functions will be given only upon authorization of the Commanding General.
6. Civilians will not be accepted to membership, nor will they be permitted on the Club premises.
7. The Club is not responsible for loss of kit or personal belongings of members.
8. Members will be compelled to pay for damage or breakage caused by them in the Club. Members are also reminded that the articles they break will probably be irreplaceable.
9. Tipping is not permitted.
10. The constructive criticism and suggestions of members for the improvement of the Club facilities are invited.
11. Members are asked to make any complaints they may have directly to the Club Manager or his assistant.

The Regional Civil Affairs Officer, Region III, has asked to be allowed to discontinue the issue of circulation passes in the province of NAPLES south of the rear Corps boundary of Fifth Army.

Owing to the typhus situation, it is considered desirable to retain this form of control into and out of NAPLES City, but with this exception there are no objections on the part of this headquarters to the proposal.
