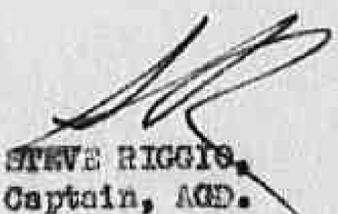

SUBJECT: Funds for Payment of Administrative Personnel

TO : All Delegations, through: The Secretariat,
Advisory Council for Italy

1. Your attention is invited to Ltr., No. 0 Finance sub-Commission, File 13005/P, 3 November 1945, subject: "Advances of Lire to Advisory Council for Italy", which stated in part that there would be no more advances of Lire to the Advisory Council for Italy as of 1 November 1945.

2. Information was given to the Secretariat to the effect that for the month of November 1945 there was required the approximate sum of 22,500 Lire from each of the six delegations for Administrative expenses.

3. Since the undersigned did not receive such advances it was necessary to operate with an amount of money which was turned over for refund from the American Delegation to be credited to sub-accounts.

4. The expenses of November to include the 30th have been met from the amount of money quoted in 3 above. There remains approximately 12,000 Lire.

5. The 12,000 Lire now on hand is barely sufficient for the payment of the drivers of the MCI vehicles for three (3) days. (This sum does not include pro-rata for Miss Pasa, Secretary to the Secretariat).

6. All Delegations are informed and advised that effective midnight 30 Nov '45 there will be NO repeat NO FUNDS to enable the continuation of the operation of a Motor Pool.

7. In order that the Motor Pool can continue in operation and that this section can continue to render its customary services and have operating funds, it will be necessary that the Secretariat furnish the undersigned with the sum of 1,25,000 Lire (22,500 from each delegation) for the administrative expenses of November and also the advance of 240,000 Lire (40,000 each Delegation) for the month of December.

8. The undersigned as Financial Agent will then account to each Delegation for their share of the advances.

9. IF NO FUNDS ARE AVAILABLE BY NOON JANUARY 1946, THE MOTOR POOL WILL HAVE TO BE CLOSED AND ALL DRIVERS RELEASED.

Subject: Liquidation of the ACI Liaison Section.

To : Chief of Secretariat, Advisory Council for Italy.

1. Assuming that the plan for Discontinuance of the ACI Motor Pool is put in effect, there remains only the following for this Section:-

- a. Travel of Foreigners.
- b. Funds. (1) Issues in Bulk Sums.
(2) Payment of Salary to Miss Pass.
(3) Payment of bills passed to the undersigned by some of the delegations.
- c. SUPPLY & EQUIPMENT, records and receipts.

2. In as much as the duties listed in 1, a,b,c, above are in some cases a duplication and others just records, it is suggested that the following recommendation be brought forward and the Liaison & Adm. Section and duties of the Financial Agent be liquidated:-

a. For Travel: The Liaison Section, ACI, is now operating and taking care of many Legations, and Missions. An additional request or two weekly from Delegations of the ACI would not hinder their activities.

b. For Funds:

For issues in Bulk Sums the Delegations now drawing such funds could arrange directly with the Representative of the AFA, as the undersigned just acts as a clearing house for them.

For payment of salary to Miss Pass, the Chief of Secretariat can apply monthly to the AFA for the necessary funds explaining the reason and charges to be made to the six delegations.

For the payment of delegation bills, since they can draw lump sums direct from the AFA they can also pay such ~~pay~~ bills and keep an account as is now required (but not done) by the various delegations.

c. For Supply & Equipment: The issues of the supply & equipment from British Sources have been completed by the payment of all articles and now such articles are the property of the delegations which have them.

The issues from American Sources remain open and such records and receipts need only to be transferred to the office which might be designated by the PBS.

3. As is self explanatory above, there is actually very little for this Office to do, I should appreciate to liquidate the above and be available for other duties with the 2675th Regt., also, I can apply for a leave of absence to the UNITED STATES. IF I AM NOT TIED DOWN WITH I&A ACI.

(NOTE) A recent appeal by the Advisory Council to AFHQ for new vehicles brought the following results:-

FROM BRITISH SOURCES:

3 Humber Pullman were issued.
2 Humber Pullman were ordered evacuated for reconditioning.
Inquiry results that vehicles are laying idle in 408 RVP awaiting removal to Base Workshops, Naples.

FROM AMERICAN SOURCES:

An Ordnance Inspector checked the 4 Chevrolets and found that they would be returned to Maintenance Shop for reconditioning; and that 5 sedans would be temporary assigned until completion of reconditioning.

Repeated contact with Ordnance Section, FBS South, results that no sedans are available for the temporary replacement. Consequently, vehicles are becoming more and more unserviceable as time passes.

b. It costs the Advisory Council approximately 120,000 lire monthly for payment of civilian drivers; this causes a charge to each delegation of approximately 20,900 lire monthly.

c. Each delegation is furnished daily, two (2) vehicles; one (1) sedan and one (1) 15cwt or 5 cwt. When possible a 15cwt and/or a 5cwt are used by the military personnel of the ACI Liaison for odd duties.

d. A recent survey shows that there are on record several or more vehicles privately listed as belonging to the various Embassies and Delegations:-

U. S. DELEGATION: 25 vehicles carrying ACI plates.
5 or 6 Military Vehicles.

BRITISH DELEGATION: 40 vehicles, military and civilian carrying tags of British Embassy.

RUSSIAN DELEGATION: 4 Vehicles, registered with G-4 AC.
Several others registered as Embassy and Mission through both G-4, AC and RAAC.

FRENCH DELEGATION: 15 vehicles, military and civilian.
(These are serviced by the French Base).

GREEK DELEGATION: 6 Vehicles, registered with G-4 AC.

JUGOSLAV DELEGATION: 5 Vehicles, registered with G-4 AC.

2. In view of the foregoing data it is requested that the undersigned be ordered to return subject vehicles to the respective Ordnance Units, (American and British) and that the ACI Motor Pool be officially discontinued.

MEMORANDUM

To: Office of the Executive Commissioner, Allied Commission.

Reference the attached cable, action was taken by the undersigned in the capacity of Liaison & Adm. Officer, ACI. The cable system of the Allied Commission has for the past 22 months transmitted all cables for the Advisory Council for Italy.

In order to ascertain the necessity and reasons for such a communication having been sent, it is necessary to bring your attention to previous instructions insofar as supply of rations is concerned. The following is furnished to clarify action taken in basic cable in question:

- a. Cable UINC, 5 Mar. 1944, Ref. No. 60560, (Secret) to FLAMBO & CG SOS NATOUSA & CG FES, states in part: "Moscow Conference established the ACI. That all demands will be supplied by British and American sources on an equitable basis". (paraphrased).
- b. On 11 July 1945, MFOUSA published Circular Number 97, which states in part "That all issued of rations to diplomatic agencies of foreign governments would be on a sales basis, and that IN NO CASE SHOULD LIRE BE ACCEPTED IN PAYMENT FOR RATIONS ISSUED TO DIPLOMATIC AGENCIES OF FOREIGN GOVERNMENTS. THE RECEIVING GOVERNMENT IS OBLIGATED TO REIMBURSE THE US IN DOLLARS.
- c. DURING THE MONTH OF SEPTEMBER, the undersigned was informed by the Secretaries of the FRENCH and GREEK Delegations that their Delegation could not comply with instructions as listed in b above, after 1 October 1945, due to difficulties within their own systems.
- d. In order to maintain the equitable basis and to avoid complications in the record keeping and accounting of rations issued to the two mentioned delegations, the basic cable was drafted and transmitted.
- e. By cable No. F47890, dated 8 October 1945, MFOUSA replied the following: "TO OVERCOME DIFFICULTY OF GREEK AND FRENCH DELEGATIONS TO ADVISORY COUNCIL FOR ITALY IN PAYING FOR UNITED STATES RATIONS IN U S DOLLARS AND TO MAINTAIN ORIGINAL AGREEMENT OF BRITISH AND UNITED STATES ASSUMING EQUAL RESPONSIBILITY FOR FURNISHING RATIONS FOR FOREIGN DELEGATIONS OF THE ADVISORY COUNCIL FOR ITALY FOLLOWING RATIONS ISSUES BASED ON STRENGTH FIGURES IN CABLE 6599 OF OCTOBER 5 ARE AUTHORIZED:
FROM U S ARMY: 40 Russian Delegates and 45 Yugoslav Delegates.
FROM BRITISH ARMY: 15 Yugoslav delegates, 35 Greek Delegates and 40 French Delegates."

The above is a complete history on authority for rations for Foreign Delegations of the Advisory Council for Italy.

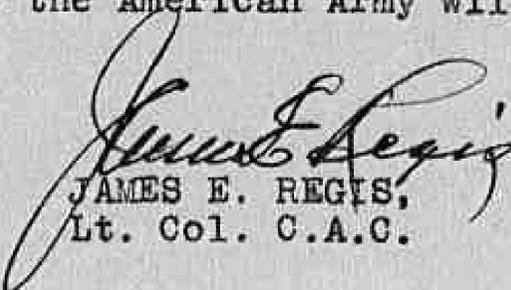

SUBJECT: Admin. Memo. For Delegations of the A.C.I.

TO : All Delegations. High Secretariat

In order to coordinate the activities of the Liaison and Administrative Section of the A.C.I. with various delegations, the following memorandum is issued for the information and guidance of all concerned.

1. Arrival of New Members.

(a) The Administrative Officer should be advised, through the Secretariat, at the earliest possible, of the contemplated arrival of new members so that arrangements may be made for, housing, rationing P.X. privileges, passes etc.

2. Transportation

(a) In compliance with Army and ANIK and PBS regulations, all cars assigned to the A.C.I. are pooled at the administrative & Liaison Headquarters at Villa Regietta, phone 11584, as it is necessary that a check be kept on all vehicles for maintenance and repairs.

As the Pool is centrally located it is possible for any Delegation to receive a car 10 or 15 minutes after request, though longer notice is advantageous to the smooth running of the system. Under order from the War Department transport Headquarters it is necessary periodically to garage vehicles for inspections or overhaul-at such times due to our limited resources a delegation may not receive a car it particularly desires but a system of rotation is in operation in fairness to all.

Should a car on service to a Delegation sustain an accident or break down necessitating garage repairs, a second best car will be provided to that Delegation until the repairs to the damaged car are effected.

(b) Long Distance Journey

Prior to any car setting out on a journey of more than a days duration it should be completely checked and serviced, therefore it is deemed necessary that any Delegation requiring a car to undertake such a journey should give one day notice or more in writing to the Administrative and Liaison Officer. Also upon return, time must be allowed for a general clean up etc.

(c) P.B.S. Pool

Due to the fact that the number of cars requested by the

Administrative and Liaison Officer, for service to the A.C.I. were not granted in full and that since, the personnel of the A.C.I. have increased in numbers, an arrangement was made with the P.B.S. Pool to supply further transportation on demand. The agreement was however for an emergency and that only at such time as all the A.C.I. cars were in use would demand be made on P.B.S.

3. Security

In accordance with existing Army and P.B.S. regulations covering all journeys forward or to any point outside the Metropolitan Area, information distance-duration, should be given to this office along with request for transportation and permission for intended journey.

4. Air Travel

To avoid duplication and wastage of time it will be appreciated if Delegations desiring air transportation will submit their requests in writing to the Administration and Liaison Officer.

The earliest possible notice should be given, also information on

1. Alternative times of departure.
2. Duration
3. Personnel weight
4. Baggage weight (limited)

5. Finance

(a) Advance in lire for a financial advance in lire it will be appreciated if an early request in writing (one day in advance) be made to Lt. Col. J.E. Regis C A C, Financial agent to A.C.I. through proper channels.

Accounting of Expenditure In order to comply with instructions issued by the combined chiefs of Finance, a member of each Delegation should be appointed as finance agent for the delegation. The financial member of the Delegations will render to Lt. Col. J.E. Regis CAC, Financial Agent to A.C.I. monthly statement of financial expenditure.

6. Supplies

The obtaining of essential supplies is becoming exceedingly difficult and long sighted estimation of supplies required by Delegation is recommended.

The procedure of supply is as follows.

(a) A Delegation makes a demand on Administration Headquarters ⁵³⁶ writing.

(b) Indents and requisitions are submitted to British and American supply departments.

(c) Goods in supply departments stocks are supplied.

(d) Goods not in stocks are purchased locally when available.

It will be seen that following the many demands made upon local purchased certain items are now very scarce, and an early request will facilitate the procurement.

7. A previously quoted, rations as supplies are drawn from British and American stocks on 50/50 basis. Indents have to be submitted to member of rations drawn, a monthly charge is made to this Headquarters, this in turn is broken down and each Delegation is charged according to the number of rations drawn by them per month. In view of the fact that frequently members of a Delegation are out of the Area for a few days, rations in excess of strength are being drawn by the Delegation and are included in the monthly charge. To obviate this will Delegation please notify this office of any changes. It is requested that a list of members of each delegation be submitted at once.

8. Domestic Labor

In accordance with AMG directive for employment of civilian labor, records have to be kept and returns made by this office to the Civil Labor Dept. It is essential therefore that any engaging and disengaging of civilian employees must be effected by the Administration and Liaison office. If any time a Delegation wish to hire or dispense with the services of a civilian employee, such a matter can be expeditiously dealt with by this office if full particulars are submitted and records will then be kept in order.

9. Telegrams

It is not the function of the Administrative and Liaison Section of ACI to dispatch telegrams. Should the necessity arise for the dispatching of a telegram, transportation will be furnished, as usual, so that a member of the delegation concerned can dispatch same.

General

It will be appreciated that only by adopting those methods of procedure and the full cooperation of all concerned can the functions of the Administrative and Liaison Section be carried out in an efficient manner. To ensure satisfactory results, where possible, please submit all requests in writing giving the fullest particulars at the earliest possible moment.

2. Information was given to the Secretariat to the effect that for the month of November 1945 there was required the approximate sum of 22,300 Lire from each of the six delegations for administrative expenses.

3. Since the undersigned did not receive such advances it was necessary to operate with an amount of money which was turned over for refund from the American Delegation to be credited to sub-accounts.

4. The expenses of November to include the 30th have been met from the amount of money quoted in 3 above. There remains approximately 12,000 Lire.

5. The 12,000 Lire now on hand is barely sufficient for the payment of the drivers of the ACI vehicles for three (3) days. (This sum does not include pro-rata for Liaison Officer, Secretary to the Secretariat).

6. All Delegations are informed and advised that effective midnight 3:00 '45 there will be NO repeat NO FUNDS to enable the continuation of the operation of a Motor Pool.

7. In order that the Motor Pool can continue in operation and that this section can continue to render its customary services and have operating funds, it will be necessary that the Secretariat furnish the undersigned with the sum of 125,000 Lire (22,500 from each delegation) for the administrative expenses of November and also the advance of 240,000 Lire (40,000 each Delegation) for the month of December.

8. The undersigned as Financial Agent will then account to each Delegation for their share of the advances.

9. IF NO FUNDS ARE AVAILABLE BY NOON 30 NOVEMBER 1945, THE MOTOR POOL WILL HAVE TO BE CLOSED AND ALL DRIVERS RELEASED.

1. Assuming that the plan for Discontinuance of the ACI Motor Pool is put in effect, there remains only the following for this Section:-

- a. Travel of Foreigners.
- b. Funds. (1) Issues in Bulk Sums.
(2) Payment of Salary to Miss Pass.
(3) Payment of bills passed to the undersigned by some of the delegations.
- c. SUPPLY & EQUIPMENT, records and receipts.

2. In so much as the duties listed in 1, a,b,c, above are in some cases a duplication and others just records, it is suggested that the following recommendation be brought forward and the Liaison & Adm. Section and duties of the Financial Agent be liquidated:-

a. For Travel: The Liaison Section, AC, is now operating and taking care of many Legations, and Missions. An additional request or two weekly from Delegations of the ACI would not hinder their activities.

For the payment of delegation bills, since they can draw lump sums direct from the AFA they can also pay such ~~pay~~ bills and keep an account as is now required (but not done) by the various delegations.

c. For Supply & Equipment: The issues of the supply & equipment from British Sources have been completed by the payment of all articles and now such articles are the property of the delegations which have them.

The issues from American Sources remain open and such records and receipts need only to be transferred to the office which might be designated by the FBS.

MEMORANDUM

To: Office of the Executive Commissioner, Allied Commission.

Reference the attached cable, action was taken by the undersigned in the capacity of Liaison & Adm. Officer, AGI. The cable system of the Allied Commission has for the past 22 months transmitted all cables for the Advisory Council for Italy.

In order to ascertain the necessity and reasons for such a communication having been sent, it is necessary to bring your attention to previous instructions insofar as supply of rations is concerned. The following is furnished to clarify action taken in basic cable in question:

- a. Cable CINO, 5 Mar. 1944, Ref. No. 60580, (Secret) to FLAMCO & CG SOS NATOUSA & CG PES, States in part: "Moscow Conference established the AGI. That all demands will be supplied by British and American Sources on an Equitable Basis". (paraphrased).
- b. On 11 July 1945, NATOUSA published Circular Number 97, which states in part "That all issues of rations to diplomatic agencies of foreign governments would be on a sales basis, and that IN NO CASE SHOULD LINE BE ACCEPTED IN PAYMENT FOR RATIONS ISSUED TO DIPLOMATIC AGENCIES OF FOREIGN GOVERNMENTS. THE RECEIVING GOVERNMENT IS OBLIGATED TO REIMBURSE THE US IN DOLLARS.
- c. DURING THE MONTH OF SEPTEMBER, the undersigned was informed by the Secretaries of the FRENCH and GREEK Delegations that their Delegation could not comply with instructions as listed in b above, after 1 October 1945, due to difficulties within their own systems.
- d. In order to maintain the equitable basis and to avoid complications in the record keeping and accounting of rations issued to the two mentioned delegations, the basic cable was drafted and transmitted.
- e. By cable No. F47890, dated 8 October 1945, NATOUSA replied the following: "TO OVERCOME DIFFICULTY OF GREEK AND FRENCH DELEGATIONS TO ADVISORY COUNCIL FOR ITALY IN PAYING FOR UNITED STATES RATIONS IN U S DOLLARS AND TO MAINTAIN ORIGINAL AGREEMENT OF BRITISH AND UNITED STATES ASSUMING EQUAL RESPONSIBILITY FOR FURNISHING RATIONS FOR FOREIGN DELEGATIONS OF THE ADVISORY COUNCIL FOR ITALY FOLLOWING RATIONS ISSUES BASED ON STRENGTH FIGURES IN CABLE 6599 OF OCTOBER 5 ARE AUTHORIZED:
FROM U S ARMY: 40 Russian Delegates and 45 Yugoslav Delegates.
FROM BRITISH ARMY: 15 Yugoslav delegates, 35 Greek Delegates and 40 French Delegates."

The above is a complete history on authority for rations for Foreign Delegations of the Advisory Council for Italy.

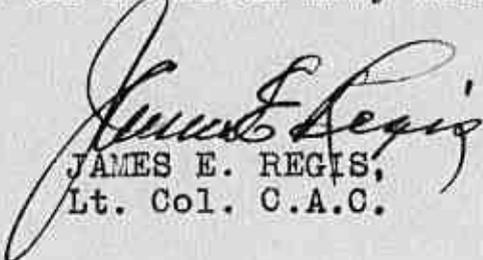

SUBJECT: Admin. Memo. For Delegations of the A.C.I.

TO : All Delegations. High Secretariat

In order to coordinate the activities of the Liaison and Administrative Section of the A.C.I. with various delegations, the following memorandum is issued for the information and guidance of all concerned.

1. Arrival of New Members.

(a) The Administrative Officer should be advised, through the Secretariat, at the earliest possible, of the contemplated arrival of new members so that arrangements may be made for, housing, rationing P.R. privileges, passes etc.

2. Transportation

(a) In compliance with Army and AFHQ and PBS regulations, all cars assigned to the A.C.I. are pooled at the administrative & Liaison Headquarters at Villa Reginetta, phone 11584, as it is necessary that a check be kept on all vehicles for maintenance and repairs.

As the Pool is centrally located it is possible for any Delegation to receive a car 10 or 15 minutes after request, though longer notice is advantageous to the smooth running of the system. Under order from the War Department transport Headquarters it is necessary periodically to garage vehicles for inspections or overhaul-at such times due to our limited resources a delegation may not receive a car it particularly desires but a system of rotation is in operation in fairness to all.

Should a car on service to a Delegation sustain an accident or break down necessitating garage repairs, a second best car will be provided to that Delegation until the repairs to the damaged car are effected.

(b) Long Distance Journey

Prior to any car setting out on a journey of more than a days duration it should be completely checked and serviced, therefore it is deemed necessary that any Delegation requiring a car to undertake such a journey should give one day notice or more in writing to the Administrative and Liaison Officer. Also upon return, time must be allowed for a general clean up etc.

(c) P.B.S. Pool

Due to the fact that the number of cars requested by the

Administrative and Liaison Officer, for service to the A.C.I. were not granted in full and that since, the personnel of the A.C.I. have increased in numbers, an arrangement was made with the P.B.S. Pool to supply further transportation on demand. The agreement was however for an emergency and that only at such time as all the A.C.I. cars were in use would demand be made on P.B.S.

3. Security

In accordance with existing Army and P.B.S. regulations covering all journeys forward or to any point outside the Metropolitan Area, information distance-duration, should be given to this office along with request for transportation and permission for intended journey.

4. Air Travel

To avoid duplication and wastage of time it will be appreciated if Delegations desiring air transportation will ~~submit~~ their requests in writing to the Administration and Liaison Officer.

The earliest possible notice should be given, also information on

1. Alternative times of departure.
2. Duration
3. Personnel weight
4. Baggage weight (limited)

5. Finance

(a) Advance in lire for a financial advance in lire it will be appreciated if an early request in writing (one day in advance) be made to Lt. Col. J.E. Regis C A C. Financial agent to A.C.I. through proper channels.

Accounting of Expenditure In order to comply with instructions issued by the combined chiefs of Finances, a member of each delegation should be appointed as finance agent for the delegation. The financial member of the Delegations will render to Lt. Col. J.E. Regis CAC. Financial Agent to A.C.I. monthly statement of financial expenditure.

6. Supplies

The obtaining of essential supplies is becoming exceedingly difficult and long sighted estimation of supplies required by Delegation is recommended.

The procedure of supply is as follows.

(a) A Delegation makes a demand on Administration Headquarters ⁵³⁶ in writing.

(b) Indents and requisitions are submitted to British and American supply departments.

(c) Goods in supply departments stocks are supplied.

(d) Goods not in stocks are purchased locally when available.

It will be seen that following the many demands made upon local purchased certain items are now very scarce, and an early request will facilitate the procurement.

7. A previously quoted, rations as supplies are drawn from British and American stocks on 50/50 basis. Indents have to be submitted to member of rations drawn, a monthly charge is made to this Headquarters, this in turn is broken down and each Delegation is charged according to the number of rations drawn by them per month. In view of the fact that frequently members of a Delegation are out of the Area for a few days, rations in excess of strength are being drawn by the Delegation and are included in the monthly charge. To obviate this will Delegation please notify this office of any changes. It is requested that a list of members of each delegation be submitted at once.

8. Domestic Labors

In accordance with AMG directive for employment of civilian labor, records have to be kept and returns made by this office to the Civil Labor Dept. It is essential therefore that any engaging and disengaging of civilian employees must be effected by the Administration and Liaison office. If any time a Delegation wish to hire or dispense with the services of a civilian employee, such a matter can be expeditiously dealt with by this office if full particulars are submitted and records will then be kept in order.

9. Telegrams

It is not the function of the Administrative and Liaison Section of AGI to dispatch telegrams. Should the necessity arise for the dispatching of a telegram, transportation will be furnished, as usual, so that a member of the delegation concerned can dispatch same.

General

It will be appreciated that only by adopting those methods of procedure and the full cooperation of all concerned can the functions of the Administrative and Liaison Section be carried out in an efficient manner. To ensure satisfactory results, where possible, please submit all requests in writing giving the fullest particulars at the earliest possible moment.

If some of these rations are issued to civilian employees on repayment at a price of 30 Lire the difference of 73/4d per ration which is not recovered should be borne by the Council. The WD bears that loss on issues to cooks and waiters employed in Army messes but cannot accept any liability for civilians employed by the Council.
