SUBJECT: Protest of Italian Ministry Foreign Affairs.

- 38
1. In reference to your letter 110/38/L of December 13th an investigation was immediately made in regards to the facts brought to the attention of this Office by note of Ministry Foreign Affairs.
 2. It is correct that on December 9th Lucien ROSSI was arrested by members of the French Provost Marshal Coy Rome French Military Command.
 3. ROSSI who belongs to the French Army, had escaped from the French Military Barracks in Bagnoli and was considered as a deserter. Therefore a regular warrant for his arrest was issued and it was the duty of French Military Police of Rome to search for him and put him under arrest.
 4. Numerous Allied Military garments were found in the apartment and consequently confiscated. The three military shirts belonging to the Italian soldier were given back to him after it was established that this man belonged to an Italian unit fighting with the 8th Army.
 5. The French Military Police N.C.O. in charge denies having made any threats against the persons involved.

1. Reference your 110/15/L dated 25 October 1944 General de Sevin's letter was passed to HQ. and thence to Fifth Army.
 2. Fifth Army reply the procedure for procurement of local resources is the same irrespective of ownership or nationality. Further, reports of lloiting or illegal requisitioning are investigated and disposed of by Fifth Army.
 3. The Saint Gobain Glass plants at Pisa have been assigned to the Fifth Army Engineers for exploitation since 30 October 44.
 4. It is suggested that you approach Industry Sub Commission as to the future of the factory when it ceases to be in Army Area.

MEMORANDUM FOR THE POLITICAL SECTION - A.C.

The Ministry of Foreign Affairs wish to acquaint the A.C. with the following fact:

On the 9th inst. in Rome at about 2,30 p.m.. 5 French military policemen stationed in the barracks of the 81st Infantry Regiment, entered armed the house of Pietro Rossi, living in Borgata Tufelli, No. 18, apartment No. 339, pronouncing under arrest his son Lucio, born in 1924, as deserter from the French Army.

On this occasion they also struck the paratrooper corporal Pistelli Liberator of the Nembo Division now in furlough owing to wounds sustained in the 8th Army front and who happened to be in the house, and searched his rucksack, carrying away three military shirts.

Corporal Pistelli complained to the French Command, who called him up to the barracks where his shirts were returned to him; the French Policemen again threatened him and stated that they could arrest and kill whom they would.

On the evening of the 12th, two policemen came back to the Borgata Tufello, to look for Corporal Pestelli. Not having found him, they warned Pietro Rossi that they would return and pay Pistelli out for his complaint.

These events have raised in Borgata Tuffello and Monte Sacro, where their news have quickly spread, the most unfavorable comments and great excitement.

In recalling their memorandum No. 6/998/418 of the 9th inst. on the same subject, the Ministry for Foreign Affairs would appreciate if the A.C. would consider the possibility of recalling the competent French Authorities to a stricter observance of the limits of their competence.

4. All documents may be made available to him with the following exceptions:-
 - a) Unparaphrased copies of communications which have been coded.
 - b) Any documents that might prejudice relations between the Allied Governments.
5. He reports on the work of the Allied Commission direct to his Government.
6. I think this is all I can tell you about him. Let me know if there are any other points you would like classified, and I will attempt to do so.
7. The Russian Representative, Maj Gen I.A. Susloparov, is attached here in the same capacity, except that he maintains a larger staff of Officers who are assigned directly to the Sub-Commissions and Branches to observe their work.

 Subject: Requisitioning of French Materiel

1. Since the recent allied advances in Italy, a certain number of French factories and properties are being included in liberated Italian territory and a greater number still are to be found in Northern regions not yet liberated.
2. Among the former, the SAINT GOBAIN GLASS FACTORY, a French concern of world fame, has two important plants in Pisa. Since the liberation of town, allied units have greatly increased the damage already existing by requisitioning, and not always with good reasons, or even looting some parts essential to the functioning of the plant.

This is not only contrary to French interests but contrary to war effort as well, and in opposition with the rehabilitation plan for Italy. In a country where glass and its industry have been practically annihilated, the part that SAINT GOBAIN would be able to play is considerable.

The social side of the question must also not be overlooked as these factories employ the greater part of the industrial workers of the town, some of which have not been paid in the last three months.

It is only through the constant effort of the French Officer in charge of the Florence Office, Capitaine VAN LAETHEM, as well as of those of Captain SIRROTA and Lieutenant BLAYR, A.M.G. PISA, that a tragic situation does not exist to-day in Saint-Gobain. However, if requisitioning continues on this scale, the factory will be unable to operate in the future.

3. In earlier days when Major DE PANAFLEU was assistant to the French Representative, a policy was laid down by which:
 - a) no requisition would be made in Allied or French property or factory if same requisition could be made on Italian property;
 - b) only essential military requisition would be made when it had proved impossible to do otherwise;
 - c) all goods requisitioned would be paid for in cash by Allied Author-

....rities (as it is now being done in Naples in Societe OSSIGENO branch of French Air Liquide);

This would help considerably in the task of rehabilitating the plant and carry out the necessary financial responsibilities towards workers and their families.

- 4. In view of the situation now existing in PISA and in view of what we may expect in further Northern Regions this office feels that it may be advisable to make an effort so that the above policy be made known to proper authorities in the field.

It is only through the constant effort of the French Office in charge of the Florence Office, together with VAN LATHUY, as well as of the SAITE D'ALBA and the French Office in Rome, that a certain number of plants have not yet been destroyed. However, it is regrettable that the fact that the factory will be made to operate in the future.

- a) no requisition would be made in Allied or French property on the ground that it was requisitioned for use as Italian property;
- b) requisitioning military property would be made when it had proved impossible to do otherwise;
