According to information received in the U.S. Embassy in Rome, the United States Government established diplomatic relations with the Polish Provisional Government of National Unity on July 5, 1945.

Unless Major Z. Wierski has credentials from the Polish Provisional Government of National Unity it will not be possible, in the view of the United States Government, to recognize him as Polish Consular Representative in Milan.

MEMORANDUM

SUBJECT : Proposed opening of Polish Consulate at Milan.

TO : Liaison Division, A.C.

1. The attached request has been received from the Polish Consul General, Rome in order that we may submit same to your section with the following comments :-

- (i) In view of the fact that North Italy is still under the jurisdiction of A.M.G., there is no necessity to re-open any of these Consulates, until this territory is officially handed over to the Italian Government.
- (ii) Under the present circumstances all Consulates should be accredited to the Italian Government and not to A.C.
- (iii) The appropriate authorities are establishing static Camps where Polish Citizens will be accommodated, and our Forward Groups will send all Polish Citizens to these Centres, where the Poles will have their Representatives.
- (IV) If this authority is granted, it will create a precedent for other Allied Nations who have been endeavouring to re-open their respective Consulates for the last two months.
- (V) The Swiss Consulates in North Italy are protecting the interests of all Allied Nations, and since this is good enough for U.S.A. and Great Britain, it ought to be satisfactory for other Allied Nationals.

The Polish Consul General therefore wants to intrust the mission as his authorised representative in Milano with Major Z. Wierski from the Polish Army, who will act in all consular questions.

The Polish Consul General will be very grateful to the Allied Commission if they could inform the Allied Military Government in Milano of the mission which has been trusted with Major Wierski.

The scheme has been already presented unformally by Major Wierski to Colonel HANCOCK.

If the Allied Commission would not find any objection in this occurrence the Polish Consul General will be thankfull

reopening the polish consular office in Milano, to deal with
the needs of the Polish citizens in the north of Italy.

The Polish Consul General therefore wants to intrust
the mission as his authorised representative in Milano with

The Polish Consul General will be very grateful to the

If the Allied Commission would not find any objection
in this occurrence the Polish Consul General will be thankful
for a telegraphic decision to be transmitted to AMG in Milano
confirming to Colonel HANCOCK the mission of Major WIERSKI.

The Major WIERSKI has been detached by the 58th
Corps specially for this mission.
