The present regulations show the assignment of 2 Camp Blanket or 1 Comforter to each soldier.

Considering that all units are accommodated under tents and the present weather conditions, it is thought necessary and urgent to increase the number of blankets assigned to each soldier bringing it up to 4 blankets or issuing one Comforter over and above the two blanket already in possession.

Practically my suggestion is being carried out in units US-14. Each soldier has 4 blanket or 2 blanket and 1 comforter or 2 comforters.

However considering the difference in treatment existing between units depending from American authorities US-171 and those depending from British authorities British and Italian 14th, I beg this office to take the matter up with either the Allied authorities or Gen. Suez di Compto M of W. so that 2 extra blankets or 1 comforter be assigned to each soldier of the Italian units British and 14th.

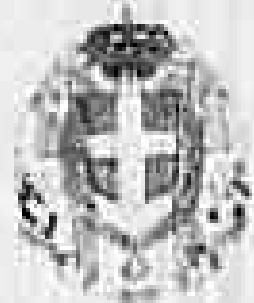

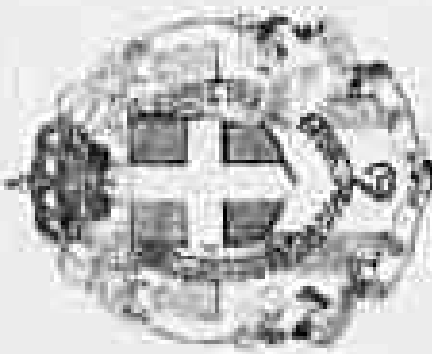

1. Para. 32 of Weekly Liaison Log, WMIA LO Sicily, for week ending 2 December, Report No. 21, states that the above subject Bn. has about 40 men sleeping without beds, and also about 40 men using tin cans for mess kits.

2. It is our firm opinion, that both of these items can be readily made available from existing salvage in Sicily. We feel that an effort should be made to supply the necessary mess kits in this manner. In connection with the bed problem, we wonder just how many good U.S. and British Soldiers in this Theatre are sleeping without beds. It is our opinion, that a considerable percentage of them have never enjoyed the comforts of a bed since their arrival here, and maybe a few Italian Soldiers should be expected to put up with the same sort of inconvenience. This is merely an observation, but it might be well to pass the thought on to the G.O. of the 2nd Bn. 45 I.S. Regt.

During the forthcoming winter season and in agreement with the American Red Cross, I have taken into consideration the problem of accommodating troops.

It has been so concluded that in case no employment is foreseen this and next will be stationed. In all other cases tent accommodation is necessary (mostly American troops).

To improve as far as possible tented accommodation I have arranged to have the tents fixed with wooden floors obtained from nearby allied units and get the units concerned to make wooden bases for camp use.

However, if we could get Phillips Case, Troops would have a satisfactory winter accommodation.

This idea has actually a rough strength of 40,000 men and, taking into account that a few thousands of them are already in possession of Phillips Case, the number required would be roughly 20,000.

Reference is made to your request for the issue of eight (8) each, outfit, cooking, 20 man, for use in the preparation of meals for the United States Army personnel attached to the Quartermaster Truck Battalion of the 2675th Regiment, AG, (Gvhd). This issue is approved on temporary shipping ticket for a period not to exceed 120 days.

2. The request for the issue of eight (8) each single unit range, field #1937 (Quartermaster nomenclature: 5 each, Pack "A" 1/range field, #1937; 3 each Pack "B" 1/range, field #1937) is not favorably considered. The operation and first and second echelon maintenance of the first unit is considered too complicated for the novice, and experience has proven that excessive maintenance and replacements are necessary where such issues are made.

3. The stock position will not warrant the equipping of other Italian Military Units with this equipment, hence a precedent cannot be established in this instance.

4. Fuel for the Army Field Range number 1 should be furnished by the Allied Commission to the maximum extent possible in conformity with the policy of the Italian Government rendering maximum assistance in the War Effort. Subject Furnishing of Furniture for the Allies.

In October of last year, the Military Commissariat of BARI was ordered to co-operate with some English officers in the purchase of furniture for the furnishing of the lodgings of a high English personality, and on the basis of orders given by S.M.F.E. it remitted the relative bills to the Italian Liaison Office with HQ No. 2 District, for successive dispatch to the English HQ concerned, which was to effect the payment of a total of 61,625 Lire.

Said Liaison Office returned the bills, however, reporting that the D.A.D.O.S. office of HQ No. 2 District had reported that it could not effect the liquidation, in-so-much as the furniture were to be considered requisitioned, as by the appropriate procedure already consigned to the supplying firms.

Following pressure by the firms concerned, the Commissariat Directorate of BARI turned to the Italian Liaison Office for the decision on the question, but said office confirmed what was stated above.

In regard to this, please note that the regulations in force in unoccupied territory prescribe that for requisitions in general must be carried out by Italian authorities and that for requisitions of furniture for good, the payment of an indemnity is due, while the requisition of furniture for use, besides payment as compensation, the furniture must be returned within six months of the requisitioning date.

As the work of the Commissariat Directorate, as shown above, has been limited only to co-operate with the English officers, who have effected the purchase, we believe that the relative payment must belong to the Allied HQ.

Please consider the question with the aim of approaching the above mentioned HQ. We have enclosed the furniture bills. We await information in regard to the question.

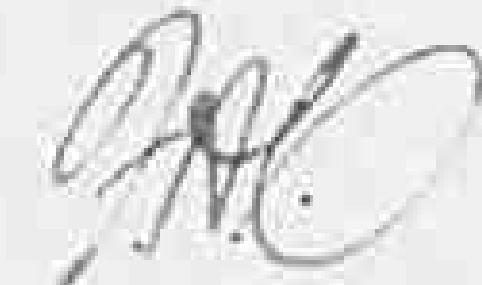

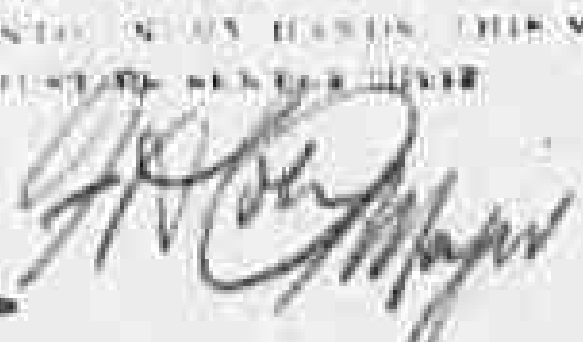

The Army Sub-Commission of Allied Control Commission, dealing with the matter of releasing bedding needed for the Royal Military Academy in process of being formed, has given its approval for all furnishings, except for bedsheets.

In regard to the latter, it mentioned the instructions issued by the Chief Commissioner of Allied Control Commission, according to which bedsheets should only be used for sanitary units.

However, the distribution of bedsheets to the candidates of the Academy has always been a custom of the Royal Italian Army; it does not have the meaning of comfort, but rather it tends to keep up (ITALIAN: Not to let down too much) the tone of the institution.

At any rate, the bedsheets needed for the purpose are available in stores.

May I, dear Captain, beg you, who certainly realise perfectly this need, to intervene in this matter and to obtain for us the authorisation to draw the necessary bedsheets for the candidates of the Royal Military Academy?
