Your Mission with letter N. BR-ITI/78 dated 24 April 1945 requested 43 typewriters and 18 duplicators. Furthermore, your HQ authorized the allotment of 13 typewriters to the 205th Div.

It must be considered that supplies of typewriters, duplicators, and calculators at this Ministry's disposal in V.E. Depot in Rome have been reduced to minimum. None of this material is available at Naples Depot and according to information received from Bari on the 18th of April 1945, only 12 typewriters, 5 of which in repair, 6 duplicators, 1 adding machine.

On the other hand, this HQ received requests from its subordinate units for about 200 typewriters and for a total of 25 between calculators and duplicators. Said requests have been forwarded to your HQ for approval, but it will not be possible to meet same even if approved by your HQ.

It is almost impossible to buy said material from the trade in central and southern Italy.

Fabulous prices are demanded for stocks still on hand which are now new.

It is, therefore, suggested to send an official of this Ministry to Northern Italy where, at Ivrea and Milan Factories, an adequate number of typewriters could be obtained at prices much lower than those charged in Rome and in Southern Italy. Moreover, the material would be new and would therefore last much longer. On that occasion, said official could be instructed to recover urgently typewriters, calculators, duplicators, previously used by the War Ministry in Northern Italy. There is certainly involved an important number of machines, part of which were carried north by units transferred by order of the pseudo Social Republic. With material partly bought and partly recovered, this Ministry would have ample and inexpensive

4. It is understood that bids must be accepted within seven days for the contract to become operative in order to meet the rapidly fluctuating costs.

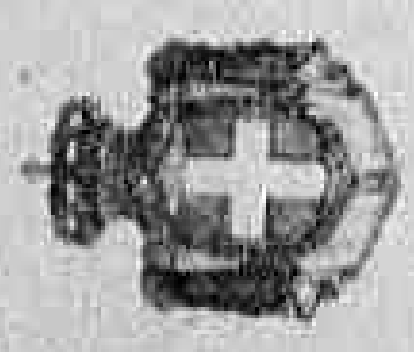
