Your DO/RAC/129 dated 17 July to Lt. Col. RUDZIANCO has reached me. It came up at a recent tour of SANDHIA but my General has told me to write and explain matters.

We will of course get you the best men possible as soon as authorization is given by AAI. Various American and British org. want out of the troops in SANDHIA, but for a variety of reasons which I need not go into, we have had to fix a policy that this cannot be allowed. Units come over to the Mainland on bloc and sorting out and selection of personnel is made this end. This we have found pays best for all concerned in the long run.

Moreover, we have moved so many troops from SANDHIA that the surplus remaining over and above the fixed Garrison is on the whole rather poor stuff. So it would be best to leave things as they are and when you get your authorization from AAI we will see to it that you get what you want. As I say we are not jibbing. We are merely continuing our existing policy and you actually will score thereby.

By the way the General said that RUDZIANCO was somewhat disturbed at his position in the matter but he (the General) said that he was sure that it would be alright if I wrote you a private letter like this.
