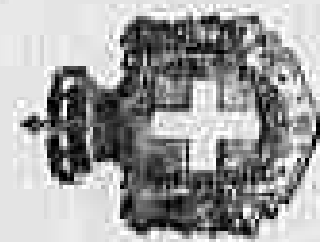

I/ This office, in agreement with MMIA, fixed W/E as per attached appendix in respect of 209, 228, 230 and 231 Div. HQs.

II/ HQ 228 Div. should, on 8th Army HQ request, administer Stores, Arm Depot, Clothing & Boots repair workshops etc, over and above discipline & administrative duties carried out on depending units located in a waste area and employed by the 8th Army.

Therefore, the apn HQ pointed out difficulties in functioning with the W/E established and requests an increase of:-

- 2 officers and 3 ORs for the formation of a Div. Vice-Comdt. Office which is above all necessary to supervise supplies.

- 1 Officer and 3 ORs for the formation of an Assistance Office.

- 30 ORs in lieu of civilian personnel shown on W/E as there cannot be taken on strength since the Div. follows an operational Allied unit.

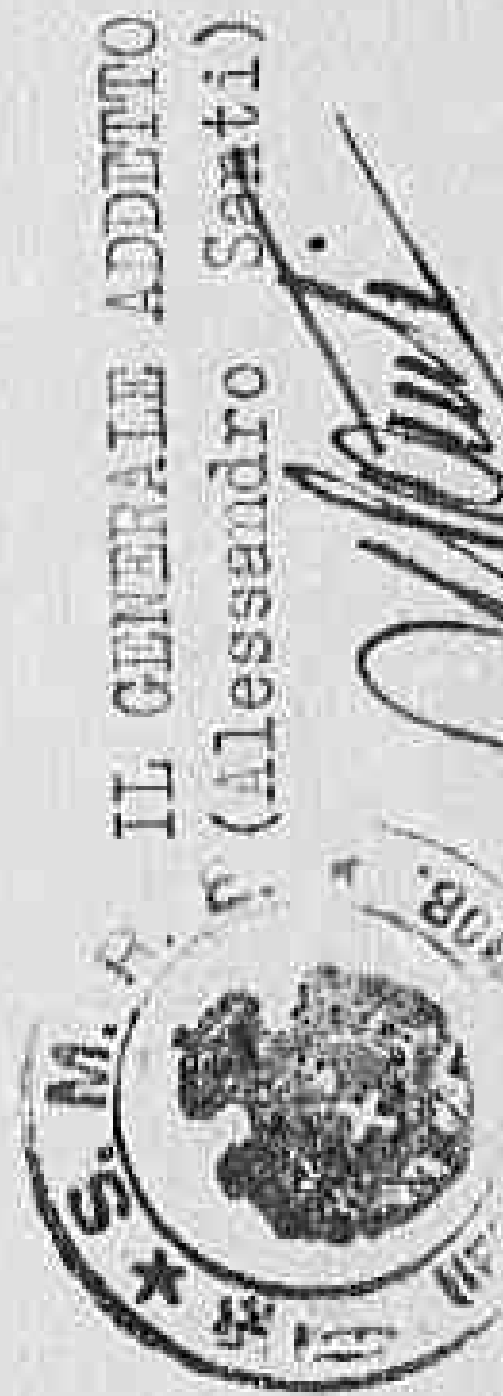

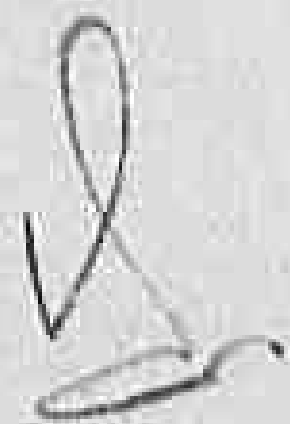
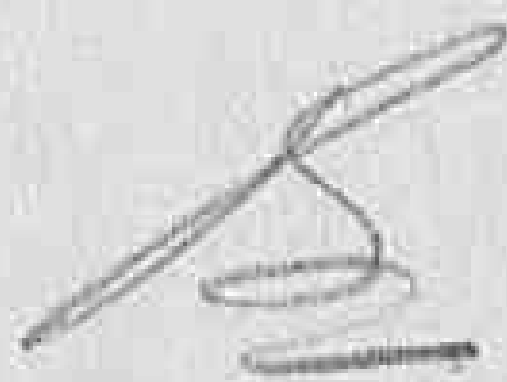

As per above, will you kindly examine the possibility of following one of the following solutions.

a) to keep Delegation "T" in service with its present W/E of 60 military.

b) change Delegation "T" into VII Territorial Hq. Det. with their present W/E.

4) The same completion of W/E as for the Territorial Hq.s to be sent North (para. 4, sec. 6 $\frac{1}{2}$ of above letter TS/G/12 of the 16 inst.) is to be preserved also for the Detachments of the other Territorial Hq.s if they are to perform the functions as per para. 4, sec. b) of letter TS/G/12 of the 30 Oct., i.e. functions of command in the disciplinary + administrative field for all units located in the territory under their jurisdiction.

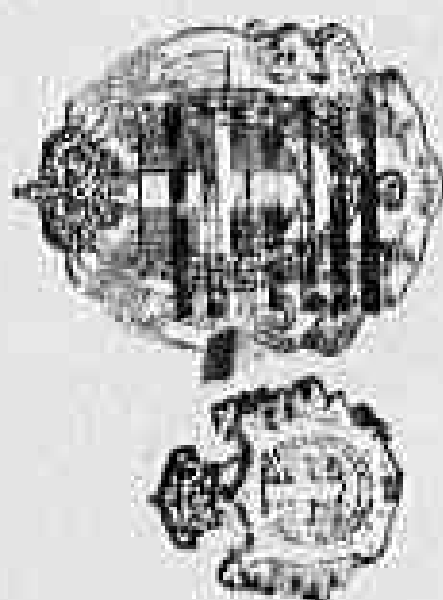
It would also be necessary, in order to attain a quick settlement of economic and disciplinary matters of the personnel that is gradually being recovered, to carry the re-organization of the Districts as far North as possible. This would allow the disbanding of the mobile units employed thus far. If the Districts are not re-formed immediately in the wake of the Allied advance, the above mobile commissions will, instead, always be necessary.

5) I also want to take this occasion to propose the suitability of moving the Detachment of the ex-Delegation "A" (VI Territ. Hq. Det.) from its present location at CHIETI, to ANCONA, or another, more Northern, location.

Thus the above Detachment will already, in its future territory of jurisdiction and can begin its work of reorganization.

Dear Colonel Simmons:

Your letter of 23 September just arrived, and I can fully appreciate why you do not understand the changes regarding the Italian Army.

Under the new set-up, the 205th Division becomes a US-ITI commitment; and is part of the US Italian Troops; and as such, is a US commitment for supply and operations. From our stocks in Italian depots, we will not issue any more clothing or equipment to this unit as this is a US commitment now. For the time being, the rations will continue to be issued on the present basis. Therefore, if NATOUA desires to move the 205th Division from Sardinia, it is simply an operational move of US Troops and has nothing to do with the program of furnishing units to the various Allies.

There have been many telegrams floating around about this division, and the latest this morning is from AFHQ to AAI, which asks AAI to arrange for movement of the 205th Division along with the plans of the other troops in Sardinia. AAI has not given any decision on the matter; and if they do, they will probably allot cruiser space under some priority to be determined by them.

Under the new arrangements, there are certain troops assigned to the British and to the US and once assigned to those categories become in effect British or US troops for all purposes.

I know the situation is confusing to you, as it is *3644* us here, but I hope this throws some light on the matter. It simply means that the 205th Division can be moved around just like the US Air Forces personnel if NATOUA approves and if AAI grants shipping space.

NOTES ON PROPOSED ORGANIZATION OF
ITALIAN ADMINISTRATIVE HQ FOR A DISTRICT.

1. Appendix "A" sets out a possible basis for the reorganization of an Italian Adm Hq for a British District capable of dealing with approximately 10,000 tps.

2. The main differences in the organization as proposed and in the present Hq 209 Div organization are that :-

- (i) The "Ops" and "I" side is reduced to one officer.
- (ii) An officer interpreter is included on the establishment.
- (iii) Two officers are included to deal with "Garrison affairs", i.e. the running of such civilian personnel the Italian War Ministry choose to employ in former garrison towns such as FLORENCE, ANCONA, PERUGIA, SIENA, BOLOGNA, SAVANNA, etc.
- (iv) A "Comando Genio" similar but on a smaller scale to that included in a Corps Hq, is included as Italian Engineer problems and personnel are always likely to exist in a large district.
- (v) The Services generally are strengthened.
- (vi) A "Comando Recupero" or Salvage Office is established.

3. The total personnel as set out in Appendix "A" is approximately 50 less than that of the present Hq 209 Div.

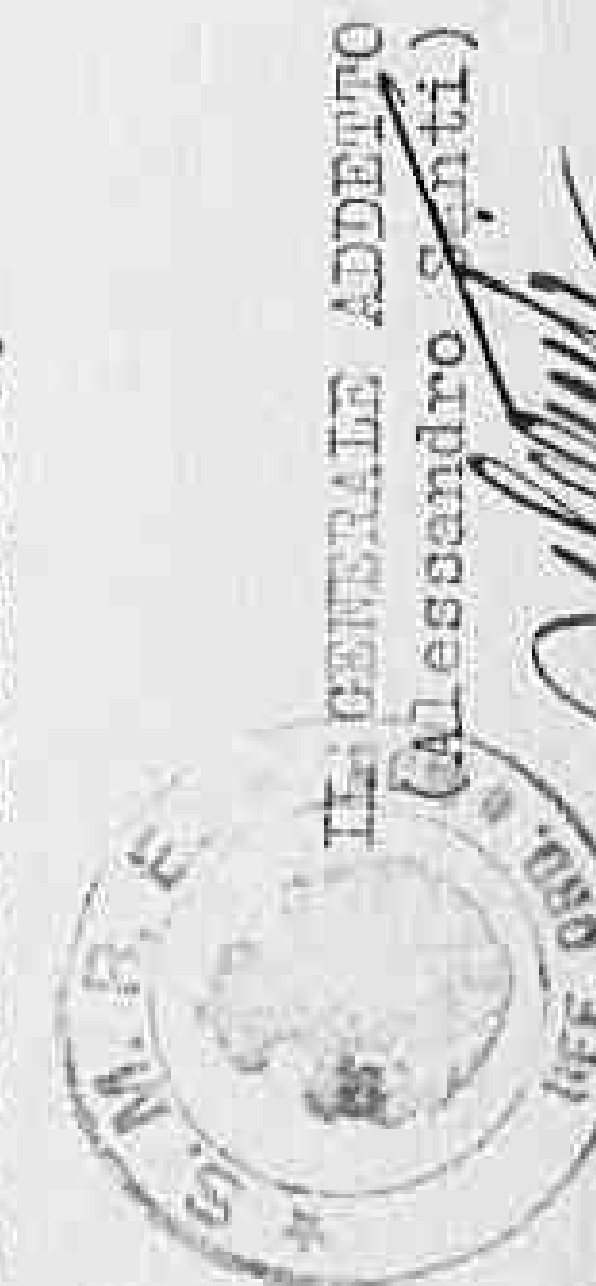

6. INEFFICIENCY HQ 209 DIV

I understand from various sources that HQ 209 Div has not been functioning efficiently for some time past. From my own observation I was not very impressed with the set up I discovered at OSIMO.

The reasons for this inefficiency are, I believe, as follows :-

- (i) HQ 209 Div is still organized as, and still tries to believe itself a semi operational Division following behind Eighth Army. It has not adapted itself to the loss of almost all its regiments and RE coys, etc, who have passed u/c other formations or to the task of administering other Italian units which have passed to it u/c.
- (ii) Its communications with Eighth Army, Polcorps, Del A, Rome and with its own rear HQ at CHIETI have been very poor. Its MT position is bad.

- (iii) Its own HQ is strung out between OSIMO and CHIETI and the units it administers cover a vast area which includes parts of both 1 and 2 Districts.
- (iv) General PROPERZI does not strike me as an energetic man and I feel that his attitude towards most of the admittedly difficult problems facing him is defeatist.
- His staff as a whole do not improve either.

7. RECOMMENDATIONS

I recommend that the following action be taken :-

- (i) Rear HQ 209 Div (CHIETI) ceases to function w.e.f. 15 Oct 44 and passes its functions as admin HQ for 67 Garrison to HQ 541 Regt (CHIETI) or to any other HQ of about the same strength which the Italian Ministry of War can designate if the above formation moves away. APPENDIX "A"

NOTES ON PROPOSED ORGANIZATION OF
ITALIAN ADMINISTRATIVE HQ FOR A DISTRICT.

I have set out in Appendix "A" a possible basis for the reorganization of an Italian Adm Hq, for a British District capable of dealing with approximately 15,000 tps.

2. The main differences in the organization as proposed and in the present Hq 209 Div organization are that :-

- (i) The Ops and I side is reduced to one officer.
- (ii) An officer interpreter is included on the establishment.
- (iii) Two officers are included to deal with "garrison affairs", i.e. the running of such civilian personnel the Italian War Ministry choose to employ in former garrison towns such as FLORENCE, ANCONA, PERUGIA, SIENA, BOLOGNA, RAVENNA, etc.
- (iv) A "Comando Genio" similar but on a smaller scale to that included in a Corps Hq is included as Italian Engineer problems and personnel are always likely to exist in a large district.
- (v) The Services generally are strengthened.
- (vi) A "Comando Recupero" or Salvage Officer is established.
3. This establishment is meant only as a sketch and no doubt the Italians will want to pull it about and alter it (and no doubt create a Vice Commandant with the rank of General).
4. The total personnel as set out in Appendix "A" is approximately 50 less than that of the present Hq 209 Div.
5. Once an establishment is agreed between DIA and the Ministero della Guerra, it should serve as a model for other Italian Adm Hqs to be formed for British Districts later on.

1. This HQ has been informed by 227 Italian Div, which is under my operational command, that they have received orders from SITE to disband the following HQ units:-

(a) 516 Regt HQ

(b) 10 Smoke Bn HQ

516 Regt HQ

2. Previous to this HQ passing to your direct cmd I had already advised MMIA direct that it was necessary for the efficiency of my District to retain the services of 516 Regt HQ.

3. 516 Regt HQ is commanded by Colonel HERTOLA, an Italian Officer of capacity and energy, and is actively employed at AFRAGOLA in running the Italian Army Labour Reorganization Centre. This centre was approved by AAI. It is essential to the efficiency of the District in that it deals with the intake from SARDINIA and elsewhere of Italian tps, sorts them out, equips them, and organizes them into labour regts for employment under British cmd. It is at present dealing with 407 Regt (for this District) and 417 Regt (for employment forward), and will probably have to organize a further regt shortly.

4. Further, when I take over cmd of the present territory of 2 District, I shall require all the more the services of this HQ in view of the added Italian military labour commitments.

5. Not only, therefore, do I consider the retention of such a regt HQ essential, but also I particularly wish to retain the services of Colonel HERTOLA and 516 Regt HQ which has now had much experience of this specialised work and carried out its duties efficiently.

6. 10 Smoke Bn HQ was specially formed to administer the Italian Smoke Coys 3823 employed under 22 AA Bde in the defence of NAPLES and vicinity. Although the original five companies are being reduced to three in number I consider it essential for both operational and adm efficiency that the Smoke Bn HQ is retained in its present form. This view is strongly endorsed by Commander, 22 AA Bde who states that your CWS branch concur.

7. In view of the above stated facts I have ordered 227 Italian Div not to proceed with the disbandment of these units until I have referred the matter to you, and received your decision.

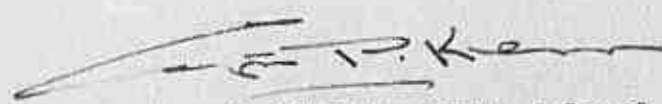

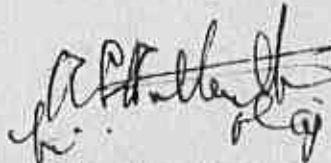

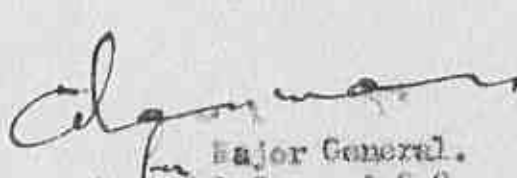
